Minutes for Council Meeting 19<sup>th</sup> November 2012

---

**WELCOME:** Isabel Hewitt welcomed all. Jan Harrison introduced Elizabeth McEwen as new Anglican Representative to NSW Council of Australian Church Women Inc.

**DEVOTIONS:** Isabel Hewitt spoke of a fund raising dinner for Churches Together held at the Friends' Meeting House in Devonshire Street. The room where the Quakers in Sydney gather to pray, to read God's word, to hear the words of others and to keep silence, listening for God's word to them was visited. At a Taizé retreat there are chants, prayers, readings and silence, [which some find to be beyond their capacity]. In the familiar reading from Ecclesiastes there is the reminder that there is a time for silence. As we approach Advent we look forward to this celebration. Let us take time to be silent, to reflect, to keep silence, to hear what God wants to say to us in the coming year. Isabel prayed.

**CONFIRMATION of MINUTES:** The minutes of the Council Meeting held on Monday 20<sup>th</sup> August were confirmed on the motion of Carmel Keys and seconded by Jan Jeffrey – Passed

### **BUSINESS ARISING:**

1. **National Executive AGM Friday 9<sup>th</sup> November 2012** at Westmead. Met with representatives from other states. Topics included the draft National constitution; voting pattern for National Conference and AGM in alternate year; position of Winifred Kiek trust within ACW. [This is a legal matter] - Public Liability Insurance for National. It was moved that a vote of thanks be given to Pamela for her invaluable help. Moved Jennifer Peffer, seconded Helen Hill. Passed

2. **National Executive from NSW 2013-2015:** Lyn has met with selection committee. The way forward had been presented to executive and now to council. Representatives from each denomination : Jan Harrison [Anglican] Lyn Middleton [The Salvation Army] Judith Cayzer [Churches of Christ] Carmel Keys [Roman Catholic]; Jennifer Peffer [Baptist] Nola Dickson [Presbyterian]; Isabel Hewitt [Uniting]. Committee to consider all nominations received. After prayerful consideration contact to be made with each person nominated to see if there is a willingness to consider acceptance of the role. If willing to consider, then that person to be sent the guidelines for the role offered. Once all the places have been filled it will be announced to council. "Expression of interest form" to be returned after this council meeting or by Friday 4<sup>th</sup> January 2013. The positions to be on the national executive were listed. Consent of person not necessary at this stage. 1<sup>st</sup> meeting for nominating committee at 10 am Monday 14<sup>th</sup> January -The Salvation Army 140 Elizabeth Street. [10<sup>th</sup> floor]. Lyn offered prayer for the selecting process and selection of National Executive from NSW.

3. **NSW State Conference Day 17th September:** Personal commitment prompts regarding Social Justice are available. Day was well received. Speakers challenging. Can connect through websites to become better aware. Social Justice 'find a word' displayed as well as list of contacts for social justice programs mentioned.

4. **75<sup>th</sup> Anniversary of State Unit for 2013:** Invited country branches to contact President regarding speakers for the occasion. Phone enquiry from Armidale branch to be further investigated.

5. **Multicultural Concert for ACWC:** Feedback told of a great occasion; entertainment was fantastic; food was consumed quickly; Manly Catholic church hosted the afternoon graciously; Kyounghee Cho, W K S Scholar [2012] was present. Thanks to all who supported especially Carmel Keys and the team from the church! \$1068.90 raised . Many thanks to Lyn and her team.

6. **ACWC convener for NSW:** Ladies were asked to prayerfully consider the possibility of taking on this role or even part of it.

7. **NSW Unit Banner:** Possibly develop ideas already presented and bring to February meeting.

### **REPORTS:**

**TREASURER:** as per attached for 3 months report. Helen Richardson had over \$7000 receipts. Balance \$18,014.51. Payments for outstanding claims and monies to be sent to National Executive moved Helen Richardson; seconded Tricia Graham. Passed

**PASTORAL CARE** Helen Hill - Thanks for support of Helen during David's recuperation . Prayer was given for all those in the group affected by various challenges of life.

**SPECIAL DAYS** as per report in Newsette Various ladies gave report of the World Community Day locally attended. Fellowship Day 2013 Theme: *Love Never Fails* [ Job 15: 9 – 17]

**FELLOWSHIP of the LEAST COIN:[F.L.C.]** Lillian read part of letter from Pat Allison, [Honorary Treasurer ICFLC] 'These coins can go to provide shelter, food, medical care, basic education. Your least coins also send emergency aid to countries dealing with natural disasters. Countries such as Egypt, Jordan, Lebanon, the Holy Land, Syria and Iraq join in praying with us. Shanti's message of peace justice and reconciliation continues to spread to all corners of the globe' F L C is in its 55<sup>th</sup> year. The logo for F L C has become a frig magnet. Lillian prayed.

**WINIFRED KIEK SCHOLARS:** Judith Cayzer showed Photo from ACWC concert of herself and Kyounghee Cho, whose report has been sent in about her use of the scholarship given. In South Australia Denise Champion was heard on radio interview about the suicide death of her nephew. [Should be finished her second block of study]. Leinamau [2007] sends Christmas greetings to all. 2013 Scholarships. 4 have been offered. At this time only Berebere Katauea [Kiribati] has officially accepted. Christmas cards being sent out to some past and present scholars.

**SOCIAL ISSUES;** Rae Goth raised the issue of Insurance for those with disability. It was suggested that questions be asked of the members of parliament including the Prime Minister, about the level of cooperation that can be expected from the state governments and in what context the boundaries of the definition of disability will be formulated. At the International level, West Papua is in the limelight for horrendous abuse of citizens peacefully lobbying against the authorities for recognition of their autonomy. Rae encouraged letters to be written to Bob Carr, [Foreign Affairs Minister] raising this concern. It is noted that there is generally a lack of respect for leaders. We are instructed in the Scriptures to pray for all leaders

National Council of Women: [NCW] presented by Tricia Graham. In September 90 people attended the Marie Bashir Peace awards Ceremony where the Governor presented awards [ \$250] to 7 female school students for their work to promote peace and harmony in their communities. 4 others received 'Highly Commended' Certificates. Tricia was elected as NCW President for another year. Triennial conference of NCW was held in Canberra in September. Female speakers on - Women in Science, Women with Disabilities; Communication and other topics. Attended the Australian Human Rights Commission – Launch of 'Working without Fear' – which came from the results of National telephone Survey 2012 .  
The delegates registered disappointment about the behaviour of parliamentarians. Sex discrimination officer has noted that in 2012 sexual harassment continues and male on male harassment is on the increase though rates of reporting are low. 51% of witnesses are likely to report the harassment.        Attended the United Nations Week Lunch at Parliament House.

Pan Pacific and South East Asian Women's Association [PPSEAWA] Edith Ridge reported: *August* speaker from 'Pyjama Foundation' – working towards a brighter future for children in foster care by interaction encouraging the increase of their numeracy and literacy skills; *September* - Work to eradicate polio since 1985 Rotary International 'End Polio Now' program in partnership with contributors. India almost free of polio- Polio still exists in Afghanistan, Pakistan, Nigeria; *October* - Robyn Gaspari spoke on the formation of this diverse group which works together to achieve a creative approach to the balance of work, life and family for women. AWC developed and presented the SHOUT program for young women [18-25]; and HELLO, specifically dealing with osteoporosis. PPSEAWA conference to be held in Fiji 2013
