Minutes of a meeting held Monday 17 March 2003 at 76 Abernethy Rd Belmont

The meeting commenced at 10 a.m.

Australian Women's Coalition (AWC)

- Brochures distributed
- Incoming National Executive (NE): involvement with AWC. The next face-to-face meeting is in Canberra 10 - 11 June. Representative from incoming NE needs to be present. Leeola will follow up with NSW Unit. Government pays expenses for delegate but not for successor. Lee has organised for successor to travel from Sydney to Canberra with Barbara Hollingsworth. If no billet with family/friends possible, it was agreed that National Executive would pay for accommodation.
