**PROVENANCE NOTE**

*The Broughton papers described in this guide are an artificial collection also containing the papers of Rev. Edward Coleridge which relate to Broughton's life as Bishop in Australia. Some of the material had been sent to St. Andrews, Sydney from St. Augustine's College, Eton in 1927. Among this material was the Bishop's M.S. account of "Four Days at Bahia". Other material such as the collection of personal family letters and the diary of Broughton's trip out to Australia in 1829 were in the possession of R.B. Boydell at Gresford, the son of Phoebe and William Boydell. It appears these papers were collected by the Bishop of Newcastle, Robert Atkins and F.T. Whittington in the 1890's to aid literary research. It is probable that Coleridge's papers were obtained at St. Augustine's College when Whittington was researching his biography of Broughton during the period 1899 to 1928. How the papers came into the possession of Moore Theological College is unknown.*

### BIOGRAPHICAL NOTE

William Grant Broughton was born at Westminster on the 22nd May 1788, the eldest son of Grant Broughton and Phoebe Ann Broughton (nee Rumball).<sup>1</sup> He was to become the first Bishop of Australia and later Bishop of Sydney and Metropolitan of Australia.

He was educated at Barnet Grammar School and Kings School Canterbury and in 1804 won an exhibition to Pembroke College, Cambridge but due to the death of his father and financial difficulties, he was unable to accept. Consequently, he spent two years in obscure employment until he gained a position with the East India Company. In 1814 a legacy enabled him to go to Pembroke College where he gained his Bachelor of Arts in 1818 and his Master of Arts in 1823.<sup>2</sup> In 1818 Broughton was ordained deacon by Bishop Burgess of Salisbury for the Bishop of Winchester and was licensed in Hartley Westpall where he served Reverend Alfred Harris and Dr. Keate of Eton College.<sup>3</sup> In the same year, on the 13th July, he married Sarah, daughter of Rev. John Francis, rector of St. Mildred's, Canterbury.<sup>4</sup> He remained at Hartley Westpall until 1827 when Bishop Tomline of Winchester licensed him as an assistant at Farnham. In March 1827 Broughton was granted a further licence as Master of the Farnham Free Grammar School and in January, 1828 he became chaplain to the Tower of London.<sup>5</sup>

In September, 1828 the Colonial Office received the resignation of Thomas Hobbes Scott as Archdeacon of New South Wales. The Duke of Wellington wrote to the Secretary of State for Colonies and recommended Broughton as T.H. Scott's successor.<sup>6</sup> Broughton was offered the position and after some deliberation, during which he received favourable reports of the colony from his brother at the Admiralty and Henry Dumaresq, the governor's brother-in-law who was on leave in London, he accepted the position.<sup>7</sup> However, Broughton hesitated when he learned that the appointment was for an indefinite period and did not provide a pension or compensation in the event of death or retirement. Broughton purchased some assurance policies as security, accepted the position and spent the next three months in and out of London dining with prelates, consulting at the Colonial Office and arranging passage and outfit.<sup>8</sup>

In mid-April Broughton and his family prepared to board the "Sovereign" but due to the illness of one of his children they were unable to do so but found an alternative passage on the "John" which sailed on 26th May, 1829, arriving in Australia on 13th September, 1829.<sup>9</sup> Archdeacon Scott handed over his authority to Broughton on 16th September and Broughton delivered his Primary Visitation at St. James Church on the 3rd December, in which he outlined his policy as Archdeacon of the colony.<sup>10</sup> In it Broughton charged the clergy regarding their public, private and pastoral functions and reminded them of the needs of the residents in the outlying districts where Christian piety was wavering for want of a minister. He further charged the clergy to support and encourage the parochial schools of the colony and to have a special concern for the convicts and aboriginals.<sup>11</sup> The Primary Visitation revealed Broughton's concerns for the colony and reflected the areas where he would be most active

for most of his life.

Broughton hoped to maintain and strengthen the school system which Scott had established through the Church and School Corporation which had been established by Royal Charter in 1825.<sup>12</sup> The Corporation was to possess one-seventh of the land in each county and to use the income derived from it for the maintenance of the schools and clergy of the Church of England. However, the Charter of the N.S.W. Church and School Corporation was suspended in 1829 and was finally revoked in 1833.<sup>13</sup> In 1830 Broughton developed a plan for higher education of The Kings Schools Parramatta and Sydney. The object was to provide a classical education for the sons of the middle and upper classes. Although the Colonial Office approved the proposal Governor Bourke tried to limit its official support and in September 1833 proposed a scheme for the introduction of Stanley's Irish National System of popular education.<sup>14</sup>

Bourke also proposed that the churches of England, Scotland and Rome should receive funding for the supply of clergy and building of churches. The distribution of money for the former was to be made according to the proportion of population in each denomination and for the latter, according to private contributions. Broughton protested as he believed that the Church of England should be the only church to receive recognition and support from the government and returned to England in 1834 to consult with the Colonial Office.<sup>15</sup> He wanted to enlist the services of the Society for the Propagation of the Gospel and the British Government for the provision of clergy and money. The Society promised aid which resulted in its continued support. Broughton also wished to secure the erection of a Bishopric in Australia which Lord Glenelg agreed to in November 1835. Broughton was appointed to the new See and after returning to Australia on 14th February, 1836 was installed at St. James Church by Samuel Marsden.<sup>16</sup>

It was during his visit to England that Joshua Watson, Treasurer for the Society for the Promotion of Christian Knowledge, introduced Broughton to Rev. Edward Coleridge, a Master at Eton College, Windsor. This introduction started a correspondence between Coleridge and Broughton which continued throughout the rest of Broughton's life.<sup>17</sup> Coleridge helped Broughton provide his Diocese with clergy and money and offered continued support and approval.

The supply of clergy and money was one of Broughton's major concerns. During his visit to England in 1834 he was able to solicit the help of the Society for the Propagation of the Gospel to provide money and clergy. The Church Act of 1836 also helped to provide for prospective ministers and priests.<sup>18</sup> However, Broughton realised that clergy needed to be trained in his own Diocese. On 24th December, 1840 Thomas Moore died and left his house and grounds at Liverpool for the purpose of training young men for the clergy and in 1845 St. James' College, the forerunner of Moore Theological College, was established.<sup>19</sup> However, in 1849 the College was forced to close. During this year Broughton became seriously ill and in September his wife died suddenly.<sup>20</sup> Broughton was shattered.

Broughton attempted to superintend his Diocese in the outer

districts. During 1840 to 1845 he made an extensive programme of visits to the country districts.<sup>21</sup> He also made several trips to Van Diemen's Land and Port Phillip. By 1840 Broughton felt it was essential that his Diocese be subdivided and aided the promotion of the Colonial Bishopric's Fund in England. The Sees of New Zealand, Tasmania, Port Phillip, Melbourne and Newcastle were established with Broughton's assistance.<sup>22</sup>

Broughton understood "Church of England" to be synonymous with "Christianity" and objected to other denominations gaining a foothold in the colony. He particularly directed his protests towards the Roman Catholic Church. When the Roman Catholic Archdiocese of Sydney was created in 1843 Broughton saw it as a breach of civil and ecclesiastical order and made a formal and public protest in St. James Church.<sup>23</sup>

In 1850 Broughton summoned the five Bishops to a conference to discuss the future of the Church of England.<sup>24</sup> Broughton resolved on another visit to England to clarify the whole question of the Colonial Church Constitution. He arrived there in 1852 after a difficult journey by way of South America, and after some months of illness died in London on 20th February, 1853 and was buried at Canterbury Cathedral.<sup>25</sup>

**GENERAL DESCRIPTION:**

The majority of the letters are from W.G. Broughton in which he reports on church and political affairs in Australia and seeks Coleridge's advice and assistance in ecclesiastical matters. A few letters are from various correspondents who report on church affairs in Australia.

**BROUGHTON (SYDNEY) TO COLERIDGE (WINDSOR)**

**26 JUL., 1836.**

**12pp**

Requests assistance in the erection of two churches in Sydney. Desires to obtain an order from the Home Government to secure the Church of England's possession of the King's School at Parramatta. Expresses a wish to maintain the parochial schools according to the English National System and is opposed to the proposed introduction of the Irish System. Wishes to obtain the services of more clergymen in the colony and also asks for donations for the payment of clergy. James Macarthur is travelling to England to present a petition to the Houses of Parliament requesting that measures be taken for the good government of the colony.

**BROUGHTON (SYDNEY) TO COLERIDGE (WINDSOR)**

**8 SEP., 1837.**

**12pp**

Thanks Coleridge for securing subscribers in England to support the Church of England in Australia. Outlines the income of Bishops in the colony and the uncertainty of its source other than from government stipend. Purpose of letter is to inform Coleridge of a proposal to use the funds obtained from subscriptions to alleviate the conditions of the clergy. The proposal involves using an amount of the subscriptions to purchase property to raise sheep and cattle, the income from which will be used to pay the wages of the clergy and to purchase other estates to be similarly occupied. Expresses wish to use funds to make provision for parochial school masters and for the maintenance of widows and orphans of the clergy.

19 OCT., 1837.  
14pp

Expresses delight that the number of English subscribers has grown and discusses intention to invest the bulk of the money gained from subscriptions into property and stock. Outlines proposal for expenditure of funds and reports on the erection of the church in Sydney. Discusses the provision of residences for the clergy and his own problem of accommodation. Outlines objective of acquiring more books for the theological library for use by the clergy. The lack of clergymen in the colony is outlined and the need for an institution for the training of clergymen for work in the colonies is expressed. No encouragement for such an institution was received from the Bishop of London. Expresses dismay that other Christian denominations find means of engaging capable clergymen and states the necessary qualifications of clergymen to be brought out from England. Expresses strong missionary need of the Church of England throughout the Empire.

Reports on financial matters such as the feasibility of investing subscriptions into real property, funding for the erection of churches and the financial provision for the settlement of clergy. The Presbyterians and Papists are described as "adversaries" and a need is expressed to firmly establish the Church of England in Australia so as to ensure the continuation of "true" Christianity.

Outlines reasons for abandoning scheme of investing subscription funds into real estate. Describes meeting with Mr. Moore who wishes the income from his freehold estate to be used to build and maintain the Cathedral of St. Andrew. Reports on the church and school estates. Protests about the Governor being directed by the Secretary of State to offer the church lands for sale. Highlights the importance of the Church of England's evangelistic cause.

Reports on receiving donations from Coleridge. Sending

newspaper clippings to Coleridge which contain a report on a meeting held in the Roman Catholic Chapel in which the resolution was passed requesting the Marquess of Normandy to remove the Protestant Bishop from his seat on the Executive and Legislative Councils. Expresses the opinion that the Roman Catholic's oath of supremacy should be abolished. Considering retiring from the Legislative Council.

14 OCT., 1839.  
12 pp Incomplete.

Reports on the arrival of new clergymen and donations from Coleridge, the expenditure of funds, the speech he gave to the Legislative Council regarding the Governor's Education Project and the management of the Diocesan Committee. Discusses Mr. Gladstone's book on the relations between church and state and the Church of England in the colony. Thanks Coleridge for the books he has sent for the Theological Library.

Seeking legal advice regarding the will of Mr. Moore and expresses intention of forwarding copies to Coleridge. Anticipates steps to be taken if the will is contested.

15 FEB., 1841.  
6 pp

Gives an account of the conditions regarding religion and the church in Australia and reports on the unsuitability of some clergy for employment in Australia. Reports on Public Education in Australia and refers to Sir John Russell's despatch as being favourable to the Church of England. Reports on the death of Mr. Moore and the receipt of a "valuable bequest" to the church.

4 DEC., 1841.  
13 pp.

Reports on proposed acceptance of a candidate for ordination, on the arrival of money for the Church Fund and on the purchase of land around the Grammar School with funds received from the S.P.C.K. Again, expresses need for more clergymen. Reports on his relationship with the Roman Catholics.

7.5 pp

Reports on clerical matters including the ordination of Mr. Sconce as a Deacon. Gives an account of the opinions of Australians on Lord Russell's suspension of transportation. Includes an outline of the opinions of Mr. James Macarthur.

14 FEB., 1842.  
19.5 pp.

Mentions forwarding copies of his Charge to the Clergy and one of his sermons to Coleridge via Rev. W. Cowper who is returning to England. Writes concerning Cowper's son who was the first Australian born admitted to Holy orders. Proposed visit by the Bishop of New Zealand on his way to his Diocese. Condemns ideas presented in Tract 90 regarding the existence of purgatory.

Announces Rev. Cowper's departure for England and declares the need for a suitable successor to fill Cowper's position at St. Philip's Church. States that he is enclosing a report of a speech delivered on the 26 Jan. 1842 at a dinner to commemorate the founding of the colony. Also enclosing a newspaper article about representative government. Contemplates whether a Bishop should be a member of the

government councils.

Discusses Dr. Pusey's letter to Dr. Jelf on the 90th Tract and the existence of purgatory and the sacrament of the Mass. Outlines the financial position of the church in Australia and reports on the Roman Catholics in the colony.

Expresses his views about having a Bishopric of Jerusalem and attempts to dissuade Coleridge from undertaking a colonial Bishopric in South Australia. Writes that he is sending Coleridge a copy of *The Australian Chronical* and examines some of the articles.

Expresses his opinion of Tract 90.

Reports that there are two Bishops in the one Diocese and one, being a Catholic does not have the legal recognition of title. Accounts for a need for the introduction of a plan to recruit clergymen suitable for positions in colonial churches. Expresses wish to implement plan himself. The more immediate concerns of the church are highlighted including the preparation for the arrival of Dr. Polding and the Roman Catholic Priests and the completion of the building of churches.

11 DEC., 1843

9 pp.

Desires meeting with Sir John and Lady Franklin and mentions Sir John's polar expeditions. Expresses a wish to visit the new settlement of Hong Kong.

BROUGHTON (SYDNEY) TO COLERIDGE (WINDSOR)

22 DEC., 1843.

9.5 pp.

Writes of his movements throughout the Diocese. Reports on discussion with Archbishop Marriott. Expresses concern over sickness of his wife.

BROUGHTON (SYDNEY) TO COLERIDGE (WINDSOR)

3 JAN., 1844.

13.5 pp.

Reports on financial matters including government funding for the maintenance of religious establishments and its division among the different denominations. Describes letter he received from the Archbishop regarding matters relating to Anglicanism in Australia such as the Protest, Tractarian Theory and the establishment of an additional Bishopric in Australia. Gives his views on the establishment of the Bishopric in Jerusalem and expresses opinion that there should be a Bishop in Rome. Appraisal of Dr. Pusey's sermon.

CONTENT DESCRIPTION:

Boarded the John Transport on Tuesday, 26 May, 1829 with his wife, two children and two servants. On board the ship there were 185 males, 30 soldiers, and a crew of 32 men and boys and 1 surgeon. Details the ship's position, speed and progress. On 28 May, the ship passed North Foreland and he records that the islands of Madeira and Palma were sighted in June. By 14 June, it was expected that the N.E. tradewinds would be reached and on 16 June the Tropic of Cancer was crossed. On 2 July the Gulf of New Guinea was entered and the Tropic of Capricorn was crossed on 16 July. On 2 September Bass Strait was reached and the South Cape of Van Deimen's Land was sighted on 6 September. Jervis Bay was sighted on 12 September and later the same day, Port Jackson was sighted. On 13 September, 1829 the ship entered the Heads of Port Jackson.

Whilst on board he records his reflections, thoughts and reminiscences. Remarks on the inexperience of the crew and the idleness of the soldiers. Reports on his intervention when a convict, John Hunt, is sentenced to be kept in handcuffs and receive 3 dozen lashes for striking an officer. Expresses his wish to show the prisoners that he has an interest in their welfare. Each Sunday he performs Divine Service on the quarterdeck with the prisoners and guards assembled. Gives a detailed analysis of Harris' History of Charles I and often quotes passages and analyses various books he is reading. In doing so, he examines such issues as a minister's duty towards "heathens" and the "personal deportment of a Bishop". Writes of the death of one of the crew and describes the mode of internment and the funeral service. Reports on a school on board the ship established by Rev. Peter Fenn (Broughton questions whether he is a clergyman as he was convicted of forgery) for the convict boys. Reflects on the pain of seeing a respectable man such as Fenn reduced to the status of a convict. Describes in detail the sounds and sights on board a convict ship.

**CONTENT DESCRIPTION:**

In 1834 Broughton and his family made a trip to England. During the voyage they stopped at Bahia, Brazil about which Broughton wrote a detailed account. In it he describes in great depth his impressions of the town and its people. Broughton dedicated the account to his mother.

On 14 June, 1834 it is recorded that the ship is near the island of Trinidadain. On the thirteenth week after leaving Port Jackson the coast of Brazil is sighted. It is noted that during those thirteen weeks the only land sighted was the desolate islands of the Antipodes. Records the sighting of buildings and plantations as they sail past islands. Sights a vessel rigged off what he believes to be Cape Antonio ("which forms the western enclosure of the Port of Bahia and on which the city of Saint Salvadore is built"). As they sail into the harbour Brazilian Men-of-war and English, Dutch, French and American vessels are sighted. On their left the island of [Toporica] which forms the western side of the bay and on the right the city of Bahia. Describes the harbour and procedure for landing at Bahia, including the examination by the commanding officer of a Brazilian man-of-war. Describes the view of the city as seen from the ship. Records visit by health boat and comments on the inefficiency of regulations and precautions taken against smuggling and "contagion". Gives an account of the Divine Service which he performed on deck. Describes a trip made in the late afternoon to the public gardens. The next morning he and his family set off in the ship's boat towards the "public landing place" and he gives a detailed description of the activity in the harbour and town. He particularly notes one busy street which he found interesting and describes the sedan chairs called "caderas" which are the only means of transport in the town. He and his family travel in caderas to see the upper part of the city which is residential and he describes the Festival of Saint Antonio and the interior of a church he visited. Gives of an account of journey to the outskirts of town and describes a convent which he visits. On the way back from the convent he and his family stop to view a public library and opera house. Describes the village and church of Bom Fim which was reached by boat.

On Thursday, 12 June, 1834 they weighed anchor and made their way to England.

In 1846 George James Armytage stated that he saw Rev. J. Duffus drinking and smoking in the tap room of a public bar. Broughton appointed a commission to investigate whether the charges made were legitimate and worth further investigation. After hearing from numerous witnesses who testified to Rev. Duffus' good character, the commission concluded that there was insufficient evidence to carry the investigation any further.

In 1847 charges relating to Duffus' moral character were brought against him by the church wardens as a result of documents they had received from Mrs. Forbes and her daughter Mrs. C.A. Bull. Broughton again appointed a commission to investigate the validity of the charges. The commission concluded that the charges were legitimate and should be investigated further. Broughton therefore held an ecclesiastical court hearing in which he heard the witnesses, and passed sentence.
