

MINUTES OF AUSTRALIAN CHURCH WOMEN NATIONAL EXECUTIVE MEETING HELD AT
ST. AUGUSTINE'S CHURCH HALL, COMO ON MONDAY, FEBRUARY 27, 1989 AT 10.00 A.M.

6. Mrs. Grealy advised in her letters that \$5000 U.S. has been allocated by ECFLC. Our application had asked for \$2000 US. The Committee doubled the amount of the application so that a white person could accompany her. There was some discussion whether this would be patronising to the aboriginal women however another view put forward was that it would be advantageous if the President of the National Executive could travel with her, introducing her to meetings and having the opportunity to share with her during time spent in travel. It was also felt that it would be good for the President to have the opportunity to meet members of State units informally in this way. (It was mentioned that Mrs. Haensel had visited most units during her term of office and this was considered beneficial by those involved.) It was moved Mrs. Major Dell, seconded Mrs. Wilson that the President accompany the fellowship awardee. Revd. Edwards advised that she would have to discuss the time she would need off with her parish but would like to be in a position to accept. It was anticipated that the duration of the visit would be approximately three weeks, possibly in July. Moved Mrs. Major Dell, seconded Mrs. Box, that in the event of Rev. Edwards not being able to travel, the Vice President, Mrs. Vera Wilson, accompany the awardee. The overall financial situation for the fellowship was discussed in conjunction with the above and it was agreed that there would be some funds available to assist with parish expenses for a replacement if Rev. Edwards was in a position to travel. It was agreed that units be requested to advise if they have any other nominations to make for the aboriginal fellowship, including her ability to address groups, age, work commitments and other general information in a Profile. Nominations to be in the hands of the Secretary no later than March 31. Sub-Committee of Rev. Edwards, Mrs. Watts, Mrs. Napier and Mrs. Stewart to meet early in April and make a recommendation to the April National Executive meeting.

Winifred Kiek Scholar Failautusi Teb'ati arrived on February 5 and has settled in well at the G.F.S. Hostel and the Secretarial College. Reports indicate that she is coping very well with office administration and typing but is having a little difficulty with accounting and word processing. She goes to the College early each day to practice on the various machines. Members of A.C.W. have taken her out each weekend and Mrs. Box asked the Committee to indicate when they would be able to offer hospitality. Enquiries have been made regarding student accreditation for reduced travel costs. Australian Airlines offer 25% discount with this but the traveller can't stop on the way. Coachlines do not offer discounts.

There was some discussion on costs of return travel including State units, accommodation and other expenses. Moved Mrs. Napier seconded Mrs. Green that Mrs. Box prepare two or three budget alternatives and bring to the next meeting for discussion.

The Committee accepted with grateful thanks the offer of financial assistance from an anonymous donor to cover the shortfall in Failautusi's course costs up to \$2,000.

It was suggested that country visits be arranged during the April Semester break. Mrs. Wilson offered to take her to Bunbury and Busselton during the first week. Mrs. Napier will try to arrange a visit to Wongan Hills during the second week.

Mrs. Box advised that she was in the process of sending out applications for 1990. Moved Mrs. Napier seconded Mrs. Green that China be added to this year's regions and that appropriate changes be made to the Constitution.

Mrs. Wilson advised that she had received one reply to the Christmas letters she had sent out to previous Winifred Kiek Scholars.

Mrs. Sushila Rao has written requesting financial assistance for her son who is studying in Bangkok, as they were having great difficulty in meeting his costs. Mrs. Wilson was asked to reply advising that although we were sympathetic to the case, this is outside A.C.W.'s role and that no financial assistance could be given.
