**HOLY COMMUNION SERVICE**

Jean Thomson led a Service of Holy Communion. The celebrants were Rev Lee Edwards, Rev Nita West and Rev Alistair Christie. The order of service was adapted from a service prepared by the Iona community.

**REMEMBRANCE SERVICE**

Jacqueline Hipwell led a Remembrance Service for all those members who have passed into eternal life since the last Conference, remembering their lives and work and especially their work for ACW over the years. As each name was read out a representative from the corresponding State or Territory Unit was invited to come forward and place a lighted candle into a bowl of water. The service concluded with a prayer of thanksgiving to God our Father.

**ADDRESS BY CORAZON TABING-REYES, ICFLC**

President Jean introduced Cora, the name by which she prefers to be known, and thanked her for coming. Cora began her address with greetings of joy and peace from the International Committee of the Fellowship of the Least Coin (ICFLC), of which she is Executive Secretary. She then gave a brief history of the FLC, which she described as a global ecumenical prayer movement for peace, justice and reconciliation, which was founded by Shanti Solomon in India in 1956 and has now grown into a worldwide prayer movement in 87 countries, the latest country to join being Mongolia. Every woman, no matter her economic position, can participate and each time a woman prays she is encouraged to set aside a "least coin" of her currency to demonstrate solidarity with suffering humanity and women of every nation.

Cora said that some 30 Project Grants have already been funded this year, in countries including Bangladesh, Sierra Leone, Tonga, and Kenya. Also, Emergency Grants supplied medicines for women and children in refugee camps in Sri Lanka and funded relief work in Taiwan after the Morakot typhoon. In addition to Project and Emergency Grants, there are Block Grants, which go to participating regional and global ecumenical organisations, e.g. World Council of Churches Women's Program and World Day of Prayer International Committee. Cora invited all to promote FLC, emphasising that it is a Prayer Movement charged with bringing peace, justice and reconciliation to the world.

Cora's address was acknowledged with acclamation and Jan Abrahamffy proposed a vote of thanks and presented Cora with a gift in appreciation.

**ACW INCORPORATION**

Jean introduced Mr Nicholas Tebbey, Solicitor from Sneddon, Hall and Gallop, who came to the meeting to answer questions re Incorporation legislation in the ACT.

Much discussion was entered into in relation to the incorporation of ACW and the concerns that certain member groups had in relation to the action taken by the National Executive in March 2009. Nicholas was able to advise the members that different regulations to Incorporation applied in different States. The following Motions were put to the Conference:

**2009/4 CENSURE MOTION**

That the National Executive 2007–09 be censured for acting as they did with regard to Incorporation without due consultation with State and Territory Units.

Jennifer Pepper, NSW, moved, seconded Cela Cooper, ACT. Carried.

**2009/5 APOLOGY FROM NATIONAL EXECUTIVE**

That an apology be accepted from the National Executive, that the incorporation of Australian Church Women Inc which occurred in March 2009 was contrary to section 16 of the *Associations Incorporation Act 1991 (ACT)* and clause 8 of the 2007 constitution of Australian Church Women.

That the apology be accepted –

**2009/6 RATIFICATION OF INCORPORATION**

ACW National Executive proposes that:

- ACW incorporation be ratified for the purposes of section 16 of the *Associations Incorporation Act 1991 (ACT)*; and
- the amendments made to the ACW 2007 constitution to ~~the~~ effect incorporation in March 2009 be ratified for the purposes of clause 9 of the 2007 Constitution; and
- all actions taken by the National Executive following March 2009, purported to have been taken under the ACW Inc 2009 Rules, be ratified as valid.

Nicholas Tebbey reminded members of Conference that, following the ratification of Incorporation, the creation of a Member Register should be seen to by the Incoming National Executive, and he wished everyone well.

Jean thanked Nicholas Tebbey for his attendance at the meeting.

**EVENING DEVOTIONS** South Australian Unit led the devotions following the theme *Faith in the Future*, with hymns and prayers asking that we never give up our faith in God, and never let go of the faith that God has placed in our hearts.

**NEWS** Jan Abrahamffy shared 'news of the day', anecdotes and notices. Greetings were received from Mrs Rathie Selvaratnam, a past President of ACWC.

**HONOURING AUSTRALIAN CHURCH WOMEN** Pages with profiles honouring 12 women were distributed to each Unit, together with longer bolts to accommodate the additional insertions in the covers. Cela Cooper ACT was thanked for preparing these.

**MORNING DEVOTIONS** Queensland Unit led devotions with the theme "*Faith Brings Blessings*", beginning with psalm 126 from *Psalms Now* by Brandt and a reading from Matthew 5:3-12. May the blessing of strength, gentleness, wonder, compassion, patience, peace, joy, love and friendship be on us and may the blessing of community arise from within us, radiate around us and remain.

**2009/08 WORLD DAY OF PRAYER AUSTRALIA REPORT p. 45**

National Liaison Officer of WDPA, Pauline Smit, presented the report. Pauline drew attention to the upcoming Quadrennial National Meeting which will be held from 13-15 November at the Holy Cross Centre at Templestowe in Melbourne. Pauline's term as National Liaison Officer will terminate at that meeting and Mrs Barbara Arnold from Adelaide will be elected to replace her. In the meantime if anyone has any concerns or comments they wish Pauline to take to the meeting, she will be happy to do so.

10.30am

**ECUMENICAL SERVICE** with the theme "*Faith in the Future*" was held at St Benedict's Church, Narrabundah, with the homily given by Rev Professor James Haire, AM, Executive Director of the Australian Centre for Christianity and Culture. Guests included Rev Father Ben Roberts, Parish Priest of St Benedict's, Monsignor John Woods, Rev Joy Bartholomew from St Andrew's Presbyterian Church, and Rev Gregor Henderson representing NCCA. The Service commenced with a procession of banners and President Jean gave a *Welcome to Country* and extended greetings to all in attendance. Pam Wright accompanied the singing on the piano. Readings were taken from Mark 1:21-28, Roman 12:1-5 and Psalm 46:1-7. Professor Haire said most eloquently and with conviction "that Jesus Christ is the Saviour of the world, and therefore that, individually, and communally, we must seek to live his way." He went on to say that "We are called to a life of praise, the praise of God, which embraces all of our personal and social life, in all its practical, ethical, religious, political and intellectual aspects. It is a praise which stands counter-culture, over against the idolatrous self-worship of individuals and even nations in our time. In our time especially we are called to stand against that self-worship, and to stand for the true praise of God, the praise of all our life, in public and in private. This is the heart of the Christian faith. God in Christ has created us to share in this new humanity. God has given us a new identity, a new harmony with God's very self, and thus a new human community one with another." Professor Haire left us with two challenging questions we should ask ourselves each night – "Am I at peace with God?" and, "What this day have I done to advance the peace, the harmony of this region, of the world?" He closed by asking God to richly bless each one of us. His address was truly inspiring.

Maureen was pleased to announce that the WK Scholars for 2010 will be Ruth Marsipal from Papua New Guinea and Tonu Fakraufon from Fiji. Both would undertake studies at the Alan Walker College of Evangelism next year. Maureen also said how delighted the WKS Trust was to be able to fund Cora's attendance at this Conference and even more delighted that she was able to accept the invitation to attend.

**2009/ 10 WINIFRED KIEK SCHOLARSHIP TRUST TREASURER'S REPORT 1.7.07 – 30.6.09**

Christine Barber, Treasurer, presented the following report:

Attached are the Financial Statements for the Trust for the years ended 30 June 2008 and 30 June 2009. The balances cover all funds for the Scholarship and Fellowship accounts and the Honouring Church Women account.

Investments continued to be placed in Term Deposits with guaranteed interest rates. For the year to June 2008 interest rates rose to over 8%, and encouraged longer investment periods which gave us a working sum of \$19,411.03 for Scholarship and \$917.11 for books and material from the HCW account. These funds are being used for the 2009 Scholars. The Fellowship account stood at \$17,548.98.

As you will be aware over the past two years there has been fluctuating earnings due to the "global financial crisis". Regretfully with the continued downturn in the economic market over 08/09 earning rates fell back to 4% but are now starting to rise. Although with the term deposit investments, there is no capital growth, we have not lost any capital, and you will see from the Financial statements that the Total Funds now accumulated stand at:–

Winifred Kiek Scholarship: \$345,030.71 (including the Fellowship account of \$19,228.89 and \$20,583 for the 2010 Scholarships), and  
Honouring Church Women: \$17, 206.76

Scholarships were paid in 2008 for Leinamu Manrogoana (balance of 2007) and Imelda Aquino totalling \$12,546.

In 2009 we have paid \$18,848 for Inise Foiakau and Christine Ferguson with a balance of \$2,245 in the current year 09/10. This leaves an estimated shortfall of \$1,600 which will be paid from the excess in 2008.

I again record my thanks to my fellow Trustees for their assistance and support in considering recommendations. Also I wish to acknowledge the assistance of our Auditor Mr Adrian Nicholls, and recommend a gift be made in appreciation of his service for the past term.

Moved Christine Barber, seconded Helen Raymond, ACT. Carried.

Constance Aronsen moved a vote of thanks to Christine for looking after the Finances so carefully for the last two years.

NSW Unit asks

**ITEM 1.** Whether Orders of Service for Special Days can be varied to suit the needs, age and culture of the community where they are being used.

Isabel Hewitt, NSW, and Lyn Middleton, SA(E) advised that while it was not necessary to be ‘slaves’ to the texts provided for Special Day Services, it was important to remain faithful to the order of service. There can be flexibility in the style of worship, but by and large texts should be followed. Changes can be made when it came to suitable hymns.

ITEM 2. Whether an ideas page should be submitted with each Order of Service for Special Days prepared, giving suggestions for alternative worship styles to which the service may lend itself.

Shirley Brooks, TAS, Donna Bryan, ACWC, Judith Brown, INE, Nancy McLaren, SA(E), Marie Majoor, WA, Jennifer Pepper, NSW, Helen Raymond, ACT, Pauline Smit, WDP, and Pat Walker, INE, all offered suggestions and generally felt an 'ideas page' would be useful. Alternative venues, such as a coffee shop meeting, a formal dinner, or an art and craft show interspersed with 'worship', were some of the ideas explored. Other considerations such as larger print order of services for those in nursing homes, *PowerPoint* presentations and the issue of copyright were canvassed. With regard to copyright it was noted that most, if not all, Churches, regardless of denomination, have a Copyright Licence Number and if reproducing hymns for a printed order of service, the number should be quoted.

#### **YOUNG AMBASSADORS FOR PEACE – REV RON and MRS MARGARET REESON**

Jean welcomed Rev Ron and Mrs Margaret Reeson to speak about "Young Ambassadors For Peace", otherwise known as YAP. Both expressed pleasure at being given the opportunity to address the Conference and began with quotes from Matthew 5:9 and James 3:18 – those who work for peace. YAP, an outreach of the Uniting Church, was founded in 2001 by Joy Balazo, a former nun, who grew up in the Philippines and moved to Australia to further her human rights work. YAP is a global network of young leaders representing the religious, racial, and ethnic diversity of the human family. Sharing the ethical principles of the world's spiritual traditions, they are committed to promoting reconciliation, overcoming barriers, encouraging equitable distribution of resources, and building peace through nonviolent engagement. The movement seeks to help young people who want to find peaceful solutions to conflict; to facilitate meeting of young people from opposite sides of conflict; to develop a culture of peace based on justice; to identify sources of conflict and to build trust between enemy communities. Since its inception in 2001 YAP has assisted many communities in need of conflict resolution to build a culture of peace.

Jean thanked Ron and Margaret for giving their time to present information about YAP.

QLD Unit p. 30 Fran Moss presented the QLD Unit report and advised that the recent highlight for members was Cora's visit and attendance at a special morning tea in her honour.

NSW Unit p. 29 Isabel Hewitt presented the NSW Unit report and was pleased to have met with WKS Inise Foiakau, saying it was encouraging to have that personal contact.

ACT Unit p. 28 Judith-Ann Sjostedt presented the ACT Unit report and brought greetings from NLMs Ruth Burmester OAM and Evonne Sullivan AM.

NT Unit Kaye Viney, who is based in Alice Springs, brought greetings from Northern Territory. Jean asked that it be noted here that an application for a grant to bring more members from the Northern Territory had unfortunately been unsuccessful.

Kaye Viney, NT, moved, seconded Barbara Mondon, VIC, that reports be received. Carried.

#### **2009/18 ASIAN CHURCH WOMEN'S CONFERENCE (ACWC) REPORT p. 25**

Donna Bryan, ACWC representative, presented her report. Since writing the report, Donna had been asked, at very short notice, to be the ACWC representative together with Christian Conference of Asia (CCA) as an evaluation team to look at the Church Women's Mission in East Timor. The CCA had previously asked the ACWC to work with it to develop the Church Women's Mission in East Timor (Sister Dominica's WEAVE program), but because of the chaos in East Timor in 2005 an evaluation at that time had been cancelled. However the issue of East Timor had been raised again when the CCA had a Round Table Meeting in July 2009. Donna advised that it had been a great privilege to have been invited to be part of a re-evaluation team and visited East Timor last month. She said that nothing had prepared her for the utter devastation of the region, with infrastructure in an awful state and rubbish everywhere. There is extreme poverty, but the people were lovely and very hospitable and the economy is growing fast. Donna requested prayers for all those who are trying so very hard to improve the quality of life in East Timor and the good news is that it has been relatively peaceful over the past 18 months and the crime rate is very low.

At present ACWC is seeking an Executive Secretary, with very high standards. Applications close in November and interviews are expected to be conducted in February next year. Meanwhile preparations are well under way for the 14<sup>th</sup> Quadrennial General Assembly to be held in Indonesia from 7-12 October 2010, with the theme *Asian Women Moving Forward: Non Violent World – New Earth – Life in its Fullness*.

Donna Bryan, ACWC, moved, seconded Judith-Ann Sjostedt, N/E, that report be received. Carried.

Jean congratulated Donna on her work and her report.

**2009/19 MOTION** Edith Ridge, NLM, spoke from the floor about the Millennium Goals and asked that a motion be put to the Conference.

“That the National Executive of ACW write to the Australian Government applauding its pledge to increase aid spending to 0.5% of gross national income by 2015, but requesting that consideration be given to raising the percentage to 0.7% by 2015, to bring it up to the recommended goal of the UN”.

**RATIONALE:** The Millennium Development Goals have received wide publicity and some attention by women’s organisations in Australia. While they have sometimes ‘studied’ these goals, I know of no positive action resulting from such ‘studies’ or discussion. Carolyn Hardy, Chief Executive of UNICEF in Australia, writing in the *Sydney Morning Herald* on 9 September 2009, focussed on the *Millennium Goal to Combat Poverty*, to which she linked the goal of reducing maternal deaths. She wrote that some half a million women die in childbirth each year around the world, almost entirely in poor nations. If we are going to achieve the Millennium Goal to halve poverty by 2015, we must include the goal of cutting the maternal mortality ratio by three quarters. While the Australian Government has boosted aid significantly in pledging to raise aid spending to 0.5% of gross national income by 2015, that target is still short of the UN goal of 0.7%. Therefore, I propose that ACW meeting in National Conference should write to the Australian Government, drawing attention to this situation and our commitment to the Millennium Goals, with the accompanying recommendation.

Anne Parnis, SA moved, seconded Kaye Viney, NT. Carried.

**EVENING DEVOTIONS** NSW Unit led the devotions adopting the Conference theme *Faith in the Future*, with readings from Matthew 4:10; Mark 6:36; Psalm 33; 2 Cor 9:8; Rev 4:1; Joshua 1:5; Ephesians 2:5; Ecclesiastes 3:1-8. A time for everything under heaven, with faith in the future.

**MORNING DEVOTIONS** were led by the VIC Unit, based on Luke 8:4-15, the parable of the sower–“Sowing the Seeds”. A rug was spread on the floor and each participant took a turn at scattering seeds ... the seed representing the word of God and having potential, power and persistence.

**BIBLE STUDY 1** Rev Vicky Cullen led the first of three *Bible Studies* and chose Luke's Gospel to ask "Who is Jesus?" and "What does he mean to us as women?" in particular. This first study began with the prologue and the announcement of the birth of Jesus in Lk 1:1-4, Lk 1:5—2:52, through to the preparation for the Ministry of Jesus in Luke 3:1—4:13.

Although there had been difficulties in recent months regarding lack of communication with the creators and administrators of the ACW website, the site had been updated and the word 'Incorporated' or 'Inc' had been added to the web page and to the logo. Just days before the Conference the website administrators advised that due to a change in family circumstances it was unsustainable for them to continue to maintain the ACW site. They made a recommendation regarding a replacement website administrator and the National Executive also made some inquiries regarding a replacement and, in particular, costs that would occur in relation to a change. However, it was decided that the decision would be the responsibility of the incoming National Executive and to this end a motion would be put from the floor to address this matter.

**2009/23 WINIFRED KIEK SCHOLARSHIP REPORT** p. 20

Constance Aronsen presented her report for 2007–09, having found the experience of being Convenor of the Winifred Kiek Scholarship over the past two years a most rewarding and enlightening time. Constance had diligently kept in touch with scholars past and present and was heartened to hear how their lives had been changed as a result of their scholarships – so much work for God. She wished the incoming Convenor well and hoped that "through faith in God ... she will receive guidance in her new role".

Edith Ridge was pleased to report “that nothing untoward has happened to the Archives in the last two years!” Everything seems to be in its place and there are no moths or silverfish having a free meal. However, the time had now come to consider longer term storage arrangements and Edith had already spoken to the former Archivist of the Uniting Church, who is interested in helping ACW and has offered space at the Eunice Hunter Library and Research Centre. She asked that we trust her with the task over the next two years.

Edith Ridge moved, seconded Donna Byran, ACWC, that the report be received. Carried.

As a result of this report the Reference Committee would examine a motion on how best to store the archives.

**GENERAL EVA BURROWS AO BA MEd “Miracles on Bourke Street”**

Jean expressed great pleasure in welcoming General Eva Burrows to address the Conference. General Burrows was born in Newcastle in NSW, the daughter of Salvation Army parents. She committed her life to God for service as a Salvation Army officer while studying at Queensland University and after completing a Bachelor of Arts degree she entered the William Booth Memorial Training College in London and became a commissioned Salvation Army officer in 1951. The General is warm and witty and passionate about people of all ages and from all backgrounds. Her life has been an extraordinary journey of faith, living and working in at least 50 countries over the years and even in retirement her energy and commitment to helping and communicating with those less fortunate has not abated. She is only the second Australian to be elected as General and is known to many as “the people’s General” – a title she did not seek, but one which she cherishes. At present she is serving with the Salvation Army Mission *Melbourne 614*, located in Bourke Street, Melbourne, hence the title of her address. General Burrows explained that *614* comes from Isaiah 61:4 “*They will rebuild the ancient ruins and restore the places long devastated; they will renew the ruined cities that have been devastated by generations*” and she spoke about the work there, the core values of human dignity, justice, hope, compassion and commitment to serving those living on the fringes of society and reaching out to many each day, from the very young to the very old. She gave various personal examples of those who have reached out and have been helped and how God works miracles every day and in the strangest of circumstances. Young people, in particular, are passionate about social justice and when asked “Do you want to be like Jesus Christ?” the answer is always a resounding “Yes”. General Burrows has been honoured in many ways and in many countries over the past fifty years and has received a number of honorary degrees. We, however, felt most honoured to have her spend time with us at our National Conference and were all enriched by the experience.

A vote of thanks was moved by Marie McCann, NSW, and the gathering showed appreciation by acclamation.

**2009/32 MOTION 7 p. 48**

SA Unit moves:

(A) That Australian Church Women meeting in Conference in Canberra requests the National Executive of ACW to approach the Minister for Indigenous Affairs for a detailed plan of how the Government intends to close the gap on Indigenous disadvantage within a generation.

(B) To ensure that funding is guaranteed for the stated targets, i.e.:

- to halve the literacy, numeracy and employment gaps within a decade
- to halve the gap in infant mortality within a decade
- to close the approximate 17 year gap in overall life expectancy within a generation.

## RATIONALE:

- It is a sad fact that the life expectancy of Indigenous Australians is around 17 years lower than that of the Australian population.
- In 2006 the unemployment rate for Indigenous people was 16% compared with only 5% for the non Indigenous population.
- In 2004-2005, 27% of Indigenous people were living in overcrowded conditions.
- Indigenous people are more likely to experience homelessness than other Australians.
- Indigenous people are more likely to experience domestic violence than non-Indigenous people.
- Finally Indigenous people have also suffered from limited recognition and protection of their cultures, languages and rights and ownership of land and resources.

Regarding health alone, although in November 2008 the Council of Australian Governments committed \$1.6 billion in new health funding – the largest increase ever for Indigenous health – the statistics are compelling: around twice as many Indigenous infants died before their first birthday compared with non-Indigenous infants

Cardiovascular disease is around 2.5 times higher for Indigenous Australians, respiratory disease is almost four times higher and pneumonia three times higher. (*NACCHO CEO Mr Mick Adams in Oxfam media release March 09.*)

**2009/33 MOTION 8 p. 49**

That Australian Church Women meeting in Conference in Canberra write to both the Federal and State Attorneys-General requesting them to consider adopting “safe surrender” legislation ensuring the protection of newborns.

RATIONALE: Ten infants are abandoned in Australia each year. The figures could be much higher as the numbers reflect only the babies that are discovered and reported in the media.

Safe surrender laws operate in Germany, Italy, Japan, Hungary, Austria and the US where a mother can leave her baby at a hospital or other safe place without legal penalty. Child abandonment is a deeply saddening response to what must be a very traumatic event for a mother who feels she is left with no other option but to relinquish her infant.

Presently in Australia abandoning a child is a criminal offence and therefore, a mother or a father who abandons a child can face criminal prosecution. As long as the mother is treated like a criminal we will continue to see many more babies left at rubbish tips, public toilet blocks etc to perish from exposure to the elements.

Last September, Senator Helen Polley proposed that Safe Haven laws be introduced in Australia to offer a mother/father a safe means of relinquishing a baby under tightly controlled guidelines.

**2009/34 MOTION 9 p. 49**

Members of National Executive of ACW meeting in Conference respectfully bring to the attention of the Minister for Health and Ageing, Nicola Roxon, our concern regarding the excessive alcoholic content of drinks such as *Bacardi Cruise*, *Lemon Ruski*, *Pineapple and Coconut Rum*, and *Vodka Raspberry*. They have the appearance of a harmless soft drink but, in reality, these drinks contain between 5–7% alcohol.

**RATIONALE:** Young girls are being particularly targeted by the liquor industry in its presentation of these drinks. The bottles appear to contain soft drink and the colouring suggests that they are soft drinks. The contents taste like soft drink. Most young women would be oblivious to the strong alcoholic content of these supposedly harmless drinks presented to them as an alternative to stronger alcoholic beverages. It has been established that females have a much lower tolerance to alcohol than males.

Alcohol is a very addictive drug. In the past few years calls to the Family Drug Support hotline by concerned parents worried about alcoholism have increased by 11%. Fifteen per cent of the 25,000 calls to the hotline last year were alcohol related with the overwhelming majority concerned about their teenagers binge drinking.

Consuming only two of these "lolly drinks" by young women could cause drunkenness, changes in consciousness, mood and emotions. These intoxicating and psychoactive effects lead to many accidents, injuries, diseases and disruptions to family life.

With one amendment, i.e. that Nicola Roxon's name be removed.

Judith-Ann Sjostedt, N/E, moved, seconded Leeola Loughnan, WA, with this amendment. Carried.

### **IRENE'S PLACE – A HOUSE OF DISCIPLESHIP, SERVICE AND PEACE**

Jean welcomed Rev Moriah Hurst, the Community Coordinator for young adults in the House. Moriah works with youth and young adults at Canberra Baptist Church and has recently completed studies in theology and youth ministry. The name "Irene" comes from the Greek word for "peace" and Irene's Place is a space for peace in ordinary lives. The House is located in Forrest, on part of the property of the Wesley Uniting Church, and houses up to five young Christians between the ages of 18–25, a mix of internationals and Australians.

Moriah introduced the latest arrivals at the House, who were all from the USA and, in this instance, all female. The young women had just recently arrived and have committed themselves to give 6 to 12 months to living in this community. With other young adults they will explore discipleship, practise faith together through prayer, and look at alternatives to violence in all forms. They hope to learn more about the complexities of peace, living simply without the pressure of a job or having to attend classes in service and discipleship.

Moriah was warmly thanked for giving her time to explain the mission of *Irene's Place* and all wished her well in her Mission. All showed appreciation by acclamation.

Incoming National President, Margaret Flint, made a statement reiterating the theme *Turning Darkness into Light* and urging all to move outside their comfort zones, cross boundaries, take risks, all for the good of Australian Church Women Inc nationwide.
