Welcome Lee Edwards

Devotions Olive Dell shared the story of Paolo, a Brazilian whose conversion, and enrolment as a Salvation Army soldier, led to his wearing the two 'S's' on his shirt ('Saved to Serve' or 'Saved to Save'). Threatened by a gang for his beliefs, Paolo fought back, and was branded by the gang leader with an 'S' on his forehead (cf. St. Paul "mark of the Lord Jesus"). Flora Larson poems: 'Awkward Saints' (difficult to love) and 'Too Small a Saint', a prayer that God will pardon our pettiness and make us more like the Lord Jesus. Prayer of thanks for work of ACW. Lee thanked Olive and noted that St. Paul addressed Corinthians as saints but then pointed out their shortcomings.

President (Lee Edwards)

- ◆ Visit to Sydney for AWC meeting. Hospitality of Jan and Graham Harrison much appreciated, as was opportunity to meet with NSW Unit members.
- ◆ Invitation to launch of NCWA book *From the Heart*
- ◆ Invitation to UCAF Fellowship Day, where Ann Connan (UCAF National President) will report on attendance at World Federation of Methodist and Uniting Church Women last year in England.

Treasurer (Sheila Mellar)

- Books not yet returned by auditor. Phillis presented account for payment.
- Payment to ACWC. Total \$US5885.26, expenses \$US1000, donations \$2936.93, endowment fund \$1658.12, partners \$276.37, signature fund \$13.84.

Publications and Publicity (Phillis Dolling)

Newsletter: 530 copies sent. Postage \$76.05, printing \$244 (extra page). Next issue will be Christmas one. Info needed re FLC.

Fellowship of the Least Coin (Olive Dell)

Circle of Prayer ready for despatch. Olive took copies to Victoria, Lee took copies to NSW. Letters to Units with 'Messages and Reports' mentioned other material. Still 120 copies of previous *Circle of Prayer*.

Social Justice Issues (Laurel Pearce)

- *Valuing Parenthood* studied
- *Women With Disabilities*: noted that they won national human rights award.
- Domestic violence: good material available at *Women Together* forum. Laurel noted Churches do not always deal with this issue well.

At 12 noon the meeting was adjourned for lunch. The meeting resumed at 12:30.

Reports continued

Winifred Kiek Scholarship (Janet Watts)

- Correspondence inward: Jean Roberts, Mina Whybourne, Trustees (info on recommended applicants). Outward: new scholar Lai Mui Ching (April), with info on ACW and assurance of prayers.
- Scholarship: 3 applicants recommended, enough funds for all. All meet criteria: age, commitment, area of service. Noted that they come from all over Australia, so personal contact should be possible. Balance of funds will be held for unforeseen expenses. Janet noted that, in accordance with Guidelines, she had liaised with a second National Executive member (Barbara Bourhill).
- Bursary Book: see above.

Australian Women's Coalition (Lee Edwards)

- Face to face meeting Ibis Hotel, Sydney Airport 3-4 August. Representatives of all nine organisations present. Pan Pacific South East Asia Women's Association likely to be accepted as tenth member. Strategic Plan finalised, also procedure for press releases. Proposal re project on paid maternity leave dropped.
- Development of Policy and Research. Agreed projects: Osteoporosis, Women from Culturally and Linguistically Diverse Backgrounds (ACW hopes to be involved), Grandparenting (COTA proposal), Domestic Violence, Bill of Rights, and Women in Prison (AFUW).

Financial Report: tensions re proposal to remove 'umbrella' position of NCWA. National Executive members shared Lee's concern re dangers in this approach. It was noted that the present arrangement is in place until next August. Other two consortia are staying with parent body.

- Administration: Elizabeth Bennett's contract as Prayer Officer signed. Pat Dart provides secretarial support. Lee suggested we submit item on WKS scholars (as soon as confirmed).
- Next Face to Face meeting 23/24 February in Canberra. Lee noted that this would provide her with an opportunity to visit State Units in Melbourne and South Australia, if invited. Travel costs would be covered by National Executive, but hospitality would be responsibility of Unit.

Special Days (Marie Majoor)

- Fellowship Day 2003: Victorian Unit is happy to prepare Order of Service, but advise it will not be ready before November. Maree to remind that early November would allow adequate time to present to National Executive meeting on 18 November.
- Maree has written to Olga Scott (ACT Unit) re World Community Day 2003. Maree noted that Guidelines require consideration of WCD projects in November of previous year, however we need to start work now. Suggestion Guidelines may need to be changed to October.
- 2002 Project: Leeola will write to both projects, requesting that they send ten copies of information to each State Unit.

- Guidelines for World Community Day project: National Executive members expressed preference for Australian, non-government projects. Need to have a specific project and rigorous accountability. Suggestion that we consider whether project should have specific Christian content or simply be compatible with Christian principles. Further discussion needed.
- Guidelines for convenors: Leeola circulated retyped copies for final check.
