MINUTES OF COUNCIL MEETING HELD ON 16TH JUNE 1997.

OPENING: President Mrs Peg Blake welcomed all present and read from 1 Corinthians 5: 18-20 "If you are in Christ ... you are a new creation ... Christ the Reconciler gave us the ministry of reconciliation ... be reconciled. Peg then prayed, especially for Norma Harrop, who is to undergo surgery tomorrow.

Secretary Jan Harrison then spoke of the serious illness of Peg's husband Arthur, and expressed the thoughts and concern of us all in a prayer for him and for Peg.

ATTENDANCE: 40 members present as per attendance records.

APOLOGIES: M Whybourne, J Tong, M Craig, and 11 others recorded.

MINUTES: The minutes of meeting on 21st April 1997 as circulated were confirmed. The minutes of Annual General Meeting on 21st April 1997 were read and initialled.

BUSINESS ARISING FROM MINUTES / BUSINESS FROM EXECUTIVE:

1. DEDICATION SERVICE. President Peg expressed her sincere thanks to all who helped. All agreed that it was a lovely warm Service. Thanks were expressed to Margaret Jessup for doing the photography - members may order photos as desired. A letter of thanks was read from Marie McCann for the "undreamed of honour" of being made a NSW Unit Life Member. Peg asked for any members to give a brief remark about the Dedication, and these were as follows:

Dss Thora Thomas: A wonderful day - "warmth" was what seemed to come through everything.

Helen Stutchbury: An extra highlight and blessing for her was re-union with some friends of many years past.

2. ECUMENICAL LUNCHEON. (Functions Convener Margaret Collier) Reminder to all to complete booking form and pay their \$10.00 today or very shortly. There will be a trading table. Shelley Reys is looking forward to coming to speak. Some difficulty is being experienced in finding an aboriginal person to sing.

3. ASIAN CHURCH WOMEN'S CONFERENCE ENDOWMENT FUND: The suggestion from Executive was ratified that \$500.00 per year be contributed to this fund by NSW Unit for ten years, to share in the establishment of a Capital Fund for ACWC. This to be done by sale of calendars, percentage donated by Lucelle King from sale of her cards and craft, and by donations or fund-raising by ACW Branches e.g. 'Bring & Buys'.

4. NSW UNIT ANNUAL REPORT. Copies available at meeting. Appreciation to Joan Tong for all her work in completing these.

5. ST ANDREW'S CATHEDRAL FLOWER FESTIVAL. September 12th-15th. Official Opening to be on Friday 14th. ACW arrangement is to be done by Mr Cec Warry. Donations were received during meeting towards costs of this.

6. AUSTRALIANS FOR RECONCILIATION CONVENTION. Marie Majoor who was present gave an excellent report and expressed her thanks to ACW & CWL for joint sponsorship which enabled her to go to Melbourne. She said she was fortunate enough to be among the 5000 people in the main auditorium, not outside with the many hundreds of 'overflow.' She spoke of the lighting of the opening Candle, the Dancing by Aboriginal groups, Spanish Flamenco, Irish Dance Group; two young people, a boy and a girl, represented "young Australia"; a video message from Bishop Desmond Tutu was presented, in which he said "All colours are needed to make a rainbow. A full report will be included in next issue of Newsette.

7. NATIONAL COUNCIL OF WOMEN SEMINAR - "A Century Of Australian Women" at the State

Library was attended by Heather Reid, who presented her report, mentioning Margaret Windeyer (founder of NCW) who was the first woman librarian in 1901, and was paid \$130 per annum - men librarians received \$200! Also Pat O'Shane, the first Aboriginal barrister. A more detailed report will be printed in next Newsette.

An Invitation and Registration Form was tabled for forthcoming NCW Seminar "Women Taking On Technology" to be held on Thursday 3rd July. President will attend. Others invited if interested. Cost \$15 which includes M Tea and Lunch.

Other National Council of Women matters:

- a. Nomination of Phyl McKinnirey to NCW Executive - letter of welcome received.
- b. NCW Woman of the Year Award - A nomination has been sent for Joan Tong for this award.
- c. NCW Foundation Day Luncheon - Tuesday 26th August. Cost \$35. President Peg will attend. Others wishing to go see Marie Major. The Woman of the Year Award is presented at this function. Guest Speaker Dr Diana Horvath AO, Chief Executive Officer, Central Sydney Area Health Service. Held in Parl House Dining Room.

8. ACW NATIONAL CONFERENCE. in Canberra, 22nd-26th September. Registration Forms now available. All encouraged to attend if possible. Special guest in residence will be Illuminada Domingo, Executive Secretary of Asian Church Women's Conference.

Motions sent by NSW Executive were read to Council; several concerning suggestion that Australia should become a member of the International Committee of the Fellowship of the Least Coin, now that it is autonomous and independent of ACWC; another again suggesting change of name of our organisation to "Church Women United - Australia" in line with other countries, e.g. USA, NZ and others. These motions were ratified by Council.

9. NATIONAL EXECUTIVE MATTERS:

- a. Senator Jocelyn Newman's consultation with women's organisations re women's concerns for the future. Copy of the Senator's reply was circulated with minutes, also list of issues submitted by ACW.
- b. ICFLC Grants. Three of the four applications for grants submitted by NSW Unit have been approved as follows: Life After Prison Ministries; Young Aboriginal Women Self-Esteem Program; Somali Refugee Sewing Group.
- c. National Executive will be based in Queensland in 1997-1999 and in South Australia in 1999-2001.

10. NSW UNIT PRESIDENT-ELECT. Rev. Elizabeth Walker has been nominated by the Uniting Church as our president-elect for 1998-2000. Elizabeth was warmly welcomed to the Council. Her address is 170 Beaumont Street, Hamilton 2303 Phone (049) 61 4040, Phone and Fax (049) 69 2540.

Mrs Edith Ridge had suggested by letter the "during the period of a Presidency, Past Presidency and Presidency Elect, the number of donominational delegates should continue to be eight. This was moved as a motion by Helen Stutchbury, seconded Beth Finlay and carried.

TREASURER: Finance Report as circulated was received - moved Marie Majoor seconded Linelle Smith.

FELLOWSHIP OF THE LEAST COIN: Convener Shirley Wells mentioned material available and read the meditation of Margaret Arnold of Scotland on 1 Corinthians 4:2 - "Those who have been given a trust must prove faithful." Box for coins was circulated.

WINIFRED KIEK SCHOLARSHIP: Convener Beth Finlay tabled the new WKS Leaflet and read letter from Nighat.

SPECIAL DAYS: Convener Edith Ridge reported a successful packing day and all bundles of Fellowship Day Services distributed.

SOCIAL ISSUES: Convener Heather Reid read letters written from ACW to Robert Harrison, MP for Kiama commending him for stand re "Push & Pull" Disabled Games being refused funding of \$25,000, whilst the "Gay Games" have been given \$75,000. Also letter to Marion Dodds, previous National Social Issues Convener, commending her for valuable work and helpfulness in that office.

She advised that the projected Network has never happened, nor the printed booklet and report. Anne Patel Gray is no longer the president. Marie has sought information from the NSW Ecumenical Council and from ATSIC. It was moved Heather Reid seconded Phyl McKinnirey that this matter be passed over to National Executive. carried.

3. Marie Majoor spoke of Chisholm Cottage run by Catholic Women's League being in need of a "caretaker" to live-in free of cost. The cottage provides cheap accommodation for relatives of patients at Westmead Hospital and Westmead Children's Hospital.
