

MINUTES OF MEETING OF NATIONAL EXECUTIVE OF AUSTRALIAN CHURCH  
HELD IN THE SALVATION ARMY MEETING ROOM, BARKER ST. SUBIA  
MONDAY - MARCH 28TH, 1988 AT 10.15 A.M.

PRESENT: Mrs. Doreen Gibson, (V. Pres.) in the chair, - Barbara B Olive Dell, Flora Hunt, Margaret Napier, Lella Wilson, Wilson.

APOLOGIES: Mary Box and Meryon Goode (acting as F.L.C. convener) and absence of Janet Watts.

OPENING: Doreen Gibson read a "Meditation on the Crucifixion."

MINUTES: Minutes of Meeting held on Monday, 22nd February were on the motion of Vera Wilson, seconded by Flora Hunt.

1. Deed of Trust: Copies of Deed of Trust have finally been duly signed by Trustees appointed by the S.A. Unit, who were advised in February. As National Conference last had moved "that the Deed should be accepted and signed at the 1987 Biennial Conference of Australian Church Women Executive officers (87/40) secretary will contact Don for clarification on this before sending on a copy of Trust to each State Unit
2. Venue for 1989 Biennial National Conference of Australian Women: After having inspected a large number of possible venues it was decided that we should go ahead and book Kingswood College, Cnr. Stirling Highway and Hampden Rd., Crawley. It was moved by Olive Dell, seconded by Barbara Bourke "That we book Kingswood College for the 1989 Biennial Conference of Australian Church Women for period 24-28 September, 1989 - prices quoted - \$60 (full board) double room with private facilities (\$30 per night). Some single rooms available at cost of \$45 per night. Also full board, we should also book the Harva at \$100 per day, and the Fellows room at \$80 per night. The motion was agreed to.

At this point the Rev. John Neal, Secretary of the W.A. Conference joined us to discuss the feasibility of some of the suggestions being shared between the A.C.W. conference and one we are helping to organise for the Joint Australian-New Zealand Conference of Theological Schools, which is to be held from 24-28 September, 1989. Because of the disparity of the dates of the two conferences it was not feasible to follow them together.
