President (Lee Edwards)

- Phone call 9 April from Jan Harrison seeking information re Australian Women's Coalition (AWC): Lee suggested contacting National Council of Women direct. Also noting Marie Majoor is coming to WA, Lee suggested contacting State Unit. Jan also expressed appreciation for information sent by National Executive.
- NCW midterm conference: Lee invited to attend (AWC involvement). Betty Farrell (ACT) to attend as Jean Thomson is away.
- AWC report: Info sent via email for last Executive Meeting did not get through. Lee reported on 11 March Teleconference, where members shared Lee's concerns about possible changes in structure. A further teleconference today (15 April) at 4 p.m. Lee has also been asked to list priority issues for organisation (ie ACW). Issues identified, apart from core objectives, were refugees and domestic violence.
- ACWC Order of Service: First draft presented and approved. Leila commended its brevity (Laurel had timed at 55 minutes).

She advised of an Open Forum: Refugees in Australia: Beyond the Rhetoric to be held on Thursday 23 May. Laurel's attendance to be paid by National Executive.

A Mother's Day Action by Amnesty International was outlined.

General Business

1. Laurel Pearce noted that, at the Mothers Union Lady Day Service on 9 April, the MU National President had stressed mutual respect of young and old. Lee Edwards raised the possibility of forming a consultative committee of younger (40 and under) women. This idea to be investigated.
2. Worship Guidelines for Conference: no action needed at present.
3. Conference News: use of notebook for ideas to be encouraged.
4. Motion 14/2001: dealt with.
5. Guidelines for ACW nominated project World Community Day: these are not needed at present as we have only received two nominations: 'The Little King's Movement' (nominated by ACW Queensland) and Nungalinya College (nominated by ACW Victoria). It was agreed that available funding should be shared equally by the two projects nominated.
6. Appointment of Auditor: Bob Burns (Council of Churches) suggested: Sheila to investigate.
7. Next meeting: Monday 20 May. Morning tea: Margaret Ker. Devotions: Janet Watts.

Updating of Guidelines: it was clarified that only guidelines needing amendment relate to mailing list for minutes (past National Executive to be deleted) and Order of Service for Nursing Homes. Leeola to follow up in Circular.
