

MINUTES of meeting of the Executive of the NSW Women's Inter-Church Council, held in the Methodist Church Offices, 139 Castlereagh St., Sydney, on Monday, 11th August, 1975, at 10.30 a.m.

PRESENT: Mrs. G. Bent, President, (in the Chair), Mesdames Chambers, Curtin, Stanhope, Perriam and Miss D. Mitchell.

OPENING: The President opened the meeting with a reading from Psalm 139, followed by a brief meditation on 'Practising the Presence of God', and prayer.

MINUTES: The Minutes of the previous meeting, held on 14th July, 1975, were read and confirmed. Thanks were expressed to Mrs. Curtin, who had kindly acted as Minute Secretary at the meeting.

BUSINESS ARISING: Proposed Ecumenical Retreat.

Following discussion of the proposal submitted by Mrs. Curtin at the previous meeting, it was agreed to recommend to Council that a Retreat be arranged for Monday, 8th December, in the Crypt of St. Mary's Cathedral. Mrs. Curtin agreed to convene a small Steering Committee to complete details of the programme. Copies of the suggested programme would be distributed at the Council Meeting on 18th inst.

Detailed consideration was given to matters of finance, Winifred Kiek Scholarship, Special Days, Travel Pool, Fellowship of the Least Coin allocations, and it was agreed to report our decisions and recommendations to the Council at the meeting on 18th inst.
