WINIFRED KIEK SCHOLAR - M.Hunt

→ It was with great shock that the Convenor received a letter from the sponsor of this year's chosen scholarship holder, to say that Bonnie had been disciplined and expelled from Metago Theological College. Mrs. Helen Burua, President of the United Church Women's Fellowship in P.N.G. and the Solomon Islands has recommended another girl who had applied at the same time, and following discussion with the Rev. D. Pitman of Alcorn College and upon his recommendation, it was decided on the motion of M. Hunt, seconded H. Trudgian to accept the application of Valerie Palang, a 24 year old clerk. The course at Alcorn College commences on January 29th and the student is required to be in residence a few days before. Costs will be \$ 55 p.w. board  
\$140 per semester (7 units at \$20)  
\$ 10 pocket money

Students at Alcorn College are allowed only \$10 p.w. and this is administered by the College. Consideration will be given to this later as it is felt not to be adequate. This amount may be able to be supplemented in some way if necessary.
