Dear ACW members,

I hope each of you feel refreshed after the Christmas break. Although I received much correspondence during that time, I have only a few items to report to you.

Firstly, **Alice Springs Branch** has a new **President**: Mrs Ruth Weber, PO Box 459 Alice Springs NT 0871. Correspondence to Ruth please until they find a new Secretary. Carol Saxby is still Treasurer.

Secondly, your very efficient(????) National Secretary, omitted the FLC Convenor from the list of National Committee members on the amended page 4 of the National Constitution. The amended amendment is enclosed! **PLEASE** keep your copies of the National Constitution up to date. **PLEASE** photocopy the amendments I have sent to you, for your members who have a National Constitution.

URGENT can you make a 'gift of love'?

In December I received a 'phone call from Barbara Lacy ACWC representative advising that Padma Ebenezer, a member of the ACWC Committee from Sri Lanka had arrived in Sydney because her daughter Niroosha, who is studying in Sydney, had been badly injured in a car accident on her way home from part-time work. Her rehabilitation will take at least six months. Padma's husband, Godfrey also came to Australia to be with his daughter, but he has now returned home.

Padma borrowed US\$2,000 from her sister in Canada and their church that Godfrey works for loaned them US\$2,000 for their airfares. The loan from the church will be repaid monthly and will take 4 years. The sister's loan need not be paid immediately, but they may take their time.

Joan Tong, NSW Unit and former ACWC Committee member has been assisting them. Workcover will pay the medical expenses but Padma and Niroosha need money for living expenses.

When Niroosha comes out of hospital, they will need accommodation on street level (Padma has been staying with her other daughter and husband). Under normal circumstances this would be fine, but with two broken legs, one of which will still be healing, she will need care and comfort. They will not have money for rent. They will have to go to the rehabilitation Hospital twice a week for physio and so will not want to be too far away as they will have to take a cab – and that needs more money.

Therefore, **can you make a 'gift of love'?**



5. The following **Motion** will be put by the National Executive at the Conference concerning **travel expenses** for the **National President** (refer Constitution p.5 7.Finance: 7.1 and Finance Guidelines P6 para 4):

'that the maximum amount of (e.g.\$2,500) per biennium be made available from National Conference Fund to provide expenses for the National President or her representative, when invited, to attend special functions interstate.'

Rationale: There is no written provision for payment of the President's interstate expenses, nor has the matter been addressed by a previous National Conference. As this is an honorary position necessitating reasonably large out-of-pocket expenses, it is the responsibility of Conference to ensure that a suitable amount is set aside to cover at least part of the costs. National Conference Fund at present has enough funds to allow this. In the case of invitations issued by State Units, it is understood that the Unit issuing the invitation will be responsible for part of the costs involved.

6. Also the matter of **National Executive's power** between Conferences will become a question for discussion at the Conference – to be placed on the Agenda.

7. The **Winifred Kiek Trustees** will **recommend** that the surplus funds from the 2001 and 2002 scholars be credited to the Winifred Kiek Fellowship Fund.

8. I have been advised of several 'omissions' from the ACW leaflet, so enclosed herewith is the corrected version!


9. **Federation Sunday 21st October, 2001.** As you know, this is the year of Federation. I have been asked, as National Secretary of ACW, to make this date widely known through our various denominations.
