In the year 2,000 Australia along with 189 countries signed onto the millenium Development Goals to eradicate poverty, hunger and curable diseases from the world and to ensure that all have access to education and clean water by the year 2015.

In order to achieve this goal, countries like Australia need to ensure that 7% of GDP goes towards this effort. At the moment we are only half way. Caritas has initiated a "Stop Global Poverty" poster campaign to develop more awareness in the community. It would be heartening if ACW members would put a poster on their noticeboards at their church to encourage awareness.

I plan to contact social issues convenors in State Units and Territories to update them regularly.

1-2 May I attended a face

AWC Report -to-face meeting of Australian Women's Coalition in Sydney. There was a focus on the future shape of AWC as there is not Federal Government funding after June. Current Projects will be completed a final report be submitted to government.

On Saturday we met Professor S. Caroline Taylor, Foundation Chair in Social Justice, Head, Social Justice Research Centre, School of Psychology and Social Sciences, Edith Cowan University. Professor Taylor spoke "Happy Healthy Women, not just survivors" national summit.

Mr. Marvin Weinman, Chairman, Outcomes Australia & Sharelife Australia spoke about best practice and change from his experience. I am awaiting a copy of his power point presentation.

On Saturday Ms. Caroline Evans, who runs a management consultancy spoke and will lead us further on our journey in June.

I advised that ACW will continue as member of AWC through 2009-11 National Executive's term.

Continuing projects – Happy Healthy Women; Advocacy training; Inter-cultural dialogue/Bridge building; trafficking; Parental leave; Role of consumers on Medical Boards; Women's Refuges; Durri Women's Health project; Lifeline suicide crisis support; Consumers Health Forum.

I shall attend the next face-to-face meeting in Sydney Friday 18<sup>th</sup> June and Saturday 19<sup>th</sup> June. This will be to finalise the works in progress.

ACWC Report      **Captain Donna Bryan**

ACWC 14<sup>th</sup> Quadrennial General Assembly.

Much is happening behind the scenes in preparation for the ACWC Assembly. With the theme of "Non Violent Worl/New Earth/Life in its Fullness" the assembly will take place at the Kinasih Conference Resort in Bogor, Indonesia from 15-20 October, 2010. Nine Australians will attend – Donna Bryan, National Representative (voting delegate) Vic; Pat Walker (voting delegate) SA; Fran Moss (voting delegate) QLD; Laurel Pearce (voting delegate) WA; Judy Burge SA; Nita West SA; Marie Majoor WA; Helen Raymond ACT; Jean Thomson ACT.

The Assembly will be a time of rich fellowship, Christian study, consideration of ACWC's programmes and contribution to ecumenism and plans for the future in continuing to give hope and support to our Asian sisters.

There will also be sadness as we say goodbye to Shu-Wen Chiang, who has served ACWC as a most excellent Executive Secretary for the past eight years. Shu-Wen has worked extremely hard to promote ACWC and to strengthen relationships with ecumenical partners. A particular focus has been to allocate more funds to scholarships for educating young women and to raise support for worthy projects that aim to reduce poverty and oppression for women and children.

During the Assembly Rev. Lee Moon Sook from Korea will be installed as the new ACWC Executive Secretary. Rev. Lee has considerable experience of ecumenism and she is well qualified in both theology and the role of Secretary to Christian organisations. Rev. Lee is also gifted in the difficult area of reconciliation and her skills have often been called upon by various organisations.

Shu-Wen will visit Korea from 17-19 May in order to meet with ACWC's ecumenical partners and discuss Rev. Lee's appointment as ACWC Executive Secretary. While in Korea Shu-Wen will also attend the Korean Church Women United (KCWU) Assembly and present a greeting from ACWC.

A Prayer Request has also been received from Nepal. They have great political unrest at present. There are strikes and food and vegetable prices have risen as the economy is at its worst. Dialogue is going on between three major parties at present but is not yet resolved.

Please pray for Nepal, the ACWC General Assembly; Shu-Wen Chiang; Rev. Lee Moon Sook; the elections in the Philippines and the conflict situation in Thailand.

The meeting closed at 4.10 pm with the Prayer for Christian Unity.
