STANDING ORDERS FOR THE ASSEMBLY

1. At meetings of the Assembly the Chair shall be taken by the President of the Union or in his absence by the President Elect, the Immediate Past President, or a Vice-President of the Union and in the absence of all or such persons then by a person elected by the Assembly and during any such election the Chair shall be taken by the Secretary of the Union.
2. The Chairman of the Assembly shall ensure that the resolutions and reports are correctly recorded and presented to the Assembly and that the business of the Assembly is dealt with at the times set out in the Agenda of the Assembly.
3. Whenever the propriety of procedure or conduct is questioned and in all cases of dispute, doubt or difficulty arising out of matters of procedure or orders, the decision of the Chairman shall be final and conclusive.
4. In case debate shall arise on any subject, no person shall, except by leave of the Chairman, be permitted to speak more than once on the same question except that the mover of the motion shall in all circumstances be allowed to speak in reply, after which the debate shall be closed.
5. No motion to close the debate of the Assembly shall be put to the Assembly unless the Chairman is of the opinion that sufficient discussion of the question before the Assembly has taken place.
6. The mover of an original motion shall not, against the evident sense of the Meeting as expressed by the Chairman, speak for more than fifteen minutes; no other speaker shall, nor shall the mover in reply as against such evident sense expressed as aforesaid, speak for more than ten minutes.
7. A person who has spoken may, by permission of the Chairman, be again heard in explanation; but he shall not, except by permission of the Chairman, introduce new matter nor interrupt a person who is speaking.
8. Whenever an amendment on an original motion has been moved and seconded, no second or subsequent amendment shall be moved until the first amendment shall have been disposed of. If an amendment be carried, the motion as amended shall take the place of the original motion and shall become the question on which any further amendment may be moved.
9. At the request of the Chairman any motion or amendment offered in a meeting shall be reduced to writing and read to the Meeting before being debated.

10. The Chairman may call the attention of the Meeting to continued irrelevance, tedious repetition, unbecoming language or any breach of order on the part of a speaker and may direct such speaker to discontinue his speech.
11. No business shall be transacted at the Assembly other than business which:
 - (a) Is included in the Agenda of the Assembly or —
 - (b) Is business arising from the same year's meetings of the Baptist Union of Australia or one of its Boards or the Australian Baptist Missionary Society and a written report of such business and the terms of any motions to be moved arising therefrom has (on the first day of the Assembly) been delivered to the Secretary of the Union and on the same day a copy of such report and Notices of Motion have been affixed on the Assembly Notice Board and sufficient copies of both the report and Notices of Motion made available on the same day for every delegate to the Assembly, or —
 - (c) In the opinion of the Chairman is of great importance and urgency and either could not have been included in the agenda or was inadvertently omitted therefrom and the Assembly has agreed to transact the same by a resolution duly passed by a three-fourths majority of delegates present and voting. Any such resolution shall determine the time of dealing with such business which shall be on a day different than that upon which the said resolution was passed.
12. In the conduct of the business of the Assembly:
 - (a) The presentation of a report shall not occupy more than one-third of the time allotted in the Agenda for the presentation and discussion of such report.
 - (b) Notices of Motion to be proposed shall be available in writing for delegates on the day after the Assembly agrees to receive them.
 - (c) Any alteration in the Agenda shall be posted on the Assembly Notice Board immediately after such alteration has been made.
 - (d) The preferential system of voting and counting shall be used for the election of the officers and appointees of the Union when there are more than two candidates for election. In all other cases the Assembly shall determine from time to time the system of voting and counting.
13. Any matter relating to the policy of the Union, its Committees, Agencies, Affiliated Organisations and District Associations and not mentioned in the Annual Report

of the Union, Committee, Agency, Affiliated Organisation or District Association shall only be dealt with by Notice of Motion duly given and shall be dealt with either (as the Chairman shall determine) when the relevant report is being dealt with or at the time on the Agenda known as "Notices of Motion."

14. Every Report to the Assembly by a Council, Committee, Affiliated Organisation, Agency or District Association shall:

- (a) First be submitted to the Council, Committee, Affiliated Organisation, Agency, District Association for adoption for presentation to the Assembly. Such Council, Committee, Affiliated Organisation, Agency or District Association shall upon presenting such report to the Assembly advise whether such Council, Committee, Affiliated Organisation, Agency or District Association has adopted the said report.
- (b) Comply with all statutory requirements and regulations and By-Laws of the Union and the Standing Orders of the Assembly.
- (c) Adequately report on the activities of such Council, Committee, Affiliated Organisation, Agency or District Association for the year under review together with a statement of future plans (if any).
- (d) Contain a record of the attendances of all elected members at meetings.
- (e) Contain in a tabulated form such resolutions arising from the report as the Council, Committee, Affiliated Organisation, Agency or District Association desires to submit to the Assembly for approval. Only resolutions thus contained in the report shall be presented to the Assembly.

Every such report shall be presented to the Assembly for reception only. ALL resolutions contained in such reports shall be presented separately to the Assembly for adoption.

15. These Standing Orders or any one of them may be suspended by a resolution duly passed by a 3/4th majority of delegates present and voting.

NOTE.

Attention is drawn to By-Law 2 (c) of the Union's By-Laws which also regulate the conduct of the proceedings of the Assembly.

- (i) The quorum of any Assembly shall be 75 members. If within 30 minutes from the time appointed a quorum is not present the meeting, if convened upon requisition of

the members, shall be dissolved, and in any other case it shall stand adjourned to the next day at the same time and place and, if at such adjourned meeting, a quorum is not present, it shall be adjourned sine die. No business shall be transacted at any adjourned meeting other than the business left unfinished at the previous meeting.

- (ii) In the absence of the President, President-elect, Vice-Presidents or Immediate Past-President, the members shall elect a Chairman.
- (iii) Every member shall have one vote, and votes shall be given personally.
- (iv) Unless a poll is demanded by at least ten (10) members, a declaration by the Chairman that a resolution has been carried shall be sufficient evidence of the fact without proof of the number or proportion of votes recorded in favour of or against such resolution. If a poll is demanded it shall be taken in such manner as the Chairman directs, and the result of such poll shall be deemed a resolution of the Assembly. In case of an equality of votes, the Chairman shall be entitled to a second or casting vote.
