

MINUTES of the Annual Meeting of the N.S.W. Women's Inter-Church Council, held at ~~1111~~ St. Congregational Church, Sydney, on Monday, 21st April, 1975, at 10.30 a.m.

PRESENT: Miss D.M. Mitchell, President, in the Chair, and 40 members.

OBITUARY: In opening the meeting, the President referred to the recent death of Miss Edna Hale, one of the Baptist representatives to Council. Deaconess Andrews led us in a time of prayer for the people of Indo-China in their tragic situation.

MINUTES of the previous Annual Meeting were read and confirmed.

PRESIDENT'S ADDRESS: In her address, Miss Mitchell referred to the heritage of the Council, and expressed her grateful thanks to members of the Executive and Council.

ANNUAL REPORT: Mrs. D. Martin, Hon. Secretary, presented the Annual Report, and Mrs. L. Perriam, Hon. Treasurer read the financial statement, subject to audit. Mrs. Lean moved the adoption of the Report and Financial Statement, and expressed thanks to the Hon. Secretary and Treasurer. This was seconded by Brig. Rugh Smith and carried.

LIFE MEMBERSHIP: Mrs. Perriam moved, seconded Deaconess Andrews, that Life Membership be conferred on Mrs. B. Montgomerie. Carried. Mrs. Stanhope moved, seconded Mrs. Martin, that Life Membership be conferred on Mrs. W. Dougherty. Carried. Tribute was paid by all speakers to the contribution made to the Council by these two valued members.

ELECTION OF OFFICE BEARERS: The retiring President, Miss D. Mitchell, welcomed Mrs. G. Bent, incoming President, and declared other offices vacant. She then vacated the Chair and invited Mrs. W. Dougherty to take the Chair for the election of the Hon. Secretary. Mrs. Martin presented the nomination of Miss D. Mitchell, and it was moved by Deaconess Andrews and seconded by Mrs. Stanhope that Miss Mitchell be elected. There being no other nominations, Mrs. Dougherty declared Miss Mitchell elected, welcomed her to the position of Hon. Secretary for the ensuing year, and vacated the Chair. Miss Mitchell resumed the Chair and the election of other office-bearers proceeded. The following were elected:-
