***Minutes of Council Meeting, Monday 15<sup>th</sup> November 2021  
10.30 am via Zoom***

**MINUTES:** *The Minutes of the Council Meeting of 21<sup>st</sup> June 2021, were confirmed on the Motion of Judy Hicks and Seconded by Martha Noel. Carried.*

**BUSINESS ARISING FROM THE MINUTES:**

- 1)** The Motion passed at Executive Meeting 9<sup>th</sup> August: to cancel registration, was Ratified by the Council Members with a unanimous vote by show of hands: ***Pat Cory, Public Officer, moved that ACW NSW State Unit Inc. apply for voluntary cancellation of our Registration as an Association in light of the decision made at the April Council Meeting that ACW NSW State Unit Inc will cease its operations at the end of 2021. Seconded by Elizabeth McEwen, passed unanimously.***
- 2)** **National Conference held 19 and 20<sup>th</sup> October via Zoom.** NSW was represented at the conference by Tricia Graham, Elizabeth McEwen (delegate), Peg McEntee, Lyn Middleton, Martha Noel, Isabel Hewitt, Pat Cory and Sue Meehan. It was well organised with excellent speakers, particularly the closing speaker, Rev. Sue Ellis. People who have died since the last conference were remembered and people recognised with Honouring Australian Church Women (for NSW Helen Richardson)

The business for the AGM was not concluded and the meeting adjourned. A further meeting will be held on 24<sup>th</sup> November. NSW can still vote until 31<sup>st</sup> December 2021.

## **REPORTS:**

**Treasurer:** Pat Cory presented her report for 1<sup>st</sup> August to 31<sup>st</sup> October 2021 and commented that there was not much happening. The total income for this period was \$443.49, and total payments were \$175.61 (Reimburse E. McEwen for Teleconference \$120.61, and reimburse J. Pfeffer for Postage \$55.00). The credit balance as per bank statement is \$18,467.12, which includes money which had been invested. There was only one account to pay and that was \$38.05 for Petty Cash.

***Pat moved that the report be accepted and the Petty Cash payment be approved. Seconded by Margaret Gregory. Carried.***

Pat advised that the decision about which of the Special Projects to donate to will be made at the meeting on 21<sup>st</sup> February. Also money is to be put aside for the Thanksgiving Celebration Service and a donation to the Auditor.

**Fellowship of the Least Coin:** Moya Potts has forwarded information from International FLC with a link to the projects approved for this year.

**Special Days:** Lyn Middleton advised that the information for World Community Day with a special notice about ACW intending closure. Two responses have been received so far for WCD, so she couldn't say how much participation there was amongst the branches. Lyn is waiting to hear what is happening with National ACW and she can then notify the branches if they wish to retain affiliation.

**Winifred Kiek Scholarship:** Judith Cayzer presented her report and gave news of 2021 Scholars Sandra Pawar and Kate Johnson who are concluding their scholarship year. The 2022 WKS Scholar is Miriam Moses from Milne Bay Province, Papua New Guinea. Miriam will begin a Masters Program through PNG United Church Theological College. Miriam's church previously supported her studies in Diploma and Bachelor of Divinity. She is an Assistant Pastor in her church of about 200 people. It is proposed that a WKS Trust will be set up for the future of the Scholarship. Judith will email past and present scholars who are still in contact, sending blessings for their future. Judith thanked the members for the years of our Units partnership in encouragement, prayer and financial support for the Winifred Kiek Scholarship.

**Social Issues:** Rae Goth didn't have any new issues for the meeting, but she is continuing to write letters on issues that are important to her. Tricia thanked Rae for her diligence over many years in bringing Social Issues to the attention of ACW members.

**Membership:** Martha advised that there were 19 members present.

**Pastoral Care:** Jennifer commented that everyone has been very encouraging and that the last message included something from one of the ladies in the branch, where she referred to her first ACW meeting as standing in a forest surrounded by old, but strong trees, women strong in faith, tried and true. Yvonne and Rae both expressed their thanks to Jennifer for keeping in touch and giving encouragement especially to those who aren't well. Jennifer will continue the Pastoral Care letters until May.

**ACWC:** Due to the virus and other disasters in many areas, not a lot of information has come from ACWC this year.
