

AUSTRALIAN CHURCH WOMEN NATIONAL EXECUTIVE

MINUTES of meeting held at 37 Rutland Ave.,
Lockleys, on Tuesday 10th December, 1985. SA

PRESENT: Dorothy Haensel, Pauline Crosby, Dorothy Wright, Margaret Knauerhase, Barbara Grealy, Jean Middleton, Alice Saunders, Margaret Pittman, Nancy Rowe.

OPENING: Devotions conducted by the President, Mrs Dorothy Haensel.

MINUTES: of meeting held on 12th November, 1985, were confirmed.

85/12/1 BUSINESS ARISING from minutes of previous meeting.

1. ACWC - reported by the President, Dorothy Haensel:

- a. Assembly will be held in Bangkok in either first or third week of November, 1986. The committee for that assembly will be set up in the coming week. Dorothy is to negotiate with Qantas to provide folders and take bags and folders over ahead of time. There will be four delegates and three observers. Janet Wood is to be keynote speaker. Closing date for registration, 31st July, 1986. The next Circle of Prayer will be available at the assembly.
- Discussion took place about the desirability of these being available in languages other than English (Italian, Greek, Fijian, etc) in Australia.

b. Consultation on Tourism and Prostitution

67 people, mostly women, from 13 of the member countries of the Asian Church Women's Conference, gathered in Taipei, Taiwan, from 18-22 November to share in a Consultation on Tourism and Prostitution.

The Opening Service was held in the Bang Kah Presbyterian Church. Following a welcome dinner given by the congregation, delegates were divided into groups of 6 - 8 and taken through the local "red light" district to see something of the situation we would be discussing over the next few days.

Each morning began with Bible Study led by Rev. Timothy Chuang. Keynote Speaker was Rev. Peter Holden and he and other speakers dealt with various facets of the relationship and problems of Tourism and Prostitution, particularly in relation to the Third World.

Situation Papers were presented by representatives from 13 countries, each giving a picture of the problem in their own country. Questions and discussion arose from these papers.

Discussion groups looked at material provided and each group presented their findings in role play form, thus providing a lighter side to the serious nature of the problems and their possible solutions.

The final plenary session agreed to the list of recommendations. Evening Devotions were led by different countries. Tuesday evening saw a sharing of culture mainly through dance and song. Olive and I shared devotions that evening and used our 'item'. We used the music for Bruce Prewer's psalm "Familiar Things", and showed slides of Australia to illustrate it.

We will need to study the recommendations together to see what we can do. The seminar on Third World Tourism in 1987 will help us to find ways to prepare and educate people, particularly church people, to be better tourists.

I am very grateful to have had the opportunity to be part of this consultation. It was a tremendous experience and I hope I am

able to encourage others to consider this problem and what we can do about it.

Recommendations:

We, the members of the Asian Church Women's Conference meeting in Taipei, Taiwan, from 18-22 November, 1985, in a Consultation on Tourism and Prostitution involving some 67 people representing 16 countries, call upon the churches we represent, other churches around the world, women's groups and all people of good will vehemently to respond to the dehumanisation of people and the violation of human rights which we have identified as the direct result of tourism and prostitution in the Third World.

Towards this end we recommend that the churches and other concerned people:

1. Seek the liberating influence and vision of Christ, who not only cared for the individual, but also paid the ultimate price in order to change the structures of exploitation.
2. Identify with exploited people and learn from them how the resources of the church may be channelled towards enabling them to live fulfilled lives.
3. Arouse and deepen the awareness of our people about the impact of tourism and prostitution.
4. Encourage solidarity with the victims of tourism and prostitution.
5. Seek the co-operation of support groups in developed and developing countries which work against the exploitation of the Third World.
6. Act in solidarity on the issue of military prostitution and work in conjunction with the Third World Movement against the Exploitation of Women (TW-MAE-W).
7. Promote tourism which affirms the equality and human dignity of all persons involved as an alternative to tourism that exploits people.
8. Work towards the kind of society where justice and self-determination are the criteria for people's development.
9. Advocate the decriminalisation of prostitution as a means of justice towards the re-integration of women in society.
10. Re-orient the media towards the elimination of sex stereotyped advertisements and pornography.
11. Conduct research on the motivation of clients involved in prostitution.
12. Prepare a Code of Ethics for use by tourists.
13. Emphasise the importance of relationships in life for a fuller development of everyone.

Following the consultation I was invited to participate in the A.C.W.C. General Committee Meeting and Executive meeting.

I appreciate very much the warmth of the welcome I received in both meetings and the invitation to contribute to the business under discussion.

I would like to express thanks and congratulations to Olive Ackland for her contribution to the consultation as the Australian representative.

The 1986 Assembly will be held in Bangkok in the first or third week of November, and other business related to this is in the minutes. The various gifts we have made will go to the Assembly and Thai committee is very grateful for our offer to help in any way.

c. General Committee Meeting

The Treasurer presented a pie chart with suggested monetary targets for different countries to cover administration and general costs. (The Australian target was US\$3,000 or approx A\$5,000). Each national representative gave a report. Responsibilities of General Committee members were discussed. Badges and pendants were presented. 50 badges @ 85c each and 10 pendants @ \$2.25 each were procured by Dorothy for sale in Australia. A badge is to be given to previous ACWC representatives.

d. Executive meeting

Dorothy to find out when it would be appropriate for ACWC team to visit NT Unit and aboriginal community. Felt that next year would not be the right time, but something will be done about it as soon as possible.

Prayer Partners: Personal prayer partners will be continued but this activity has lapsed between countries. Australia is one of the few countries who have persisted in this effort and it was agreed to continue to do so, particularly with the next WKS coming from Burma.

e. Bulletins

Agreed that the price should be raised to \$5 per copy for 1986, \$7.50 for 1987. These are still being subsidized. There will be a need to update amounts already received. Moved that each unit should receive one complimentary copy for the file instead of two. The Treasurer to write to the units.

In response to the financial needs of ACWC it was agreed that we set up within Australia "Partners of ACWC" inviting church women to contribute \$1 per year with a view to a minimum target of 5,000 partners.

Worship Book for ACWC Assembly will be printed with ACWC Service instead of quarterly Bulletin.

f. Bedsocks

Agreed that 120 pairs be kept for ACW Conference in 1987.

50 pairs be set aside for Korea.

100 extra pairs for prisoners in Korea.

approx. 10 pairs to girls in UC Synod office who helped project.
