MINUTES of MEETING of ACW NATIONAL EXECUTIVE held on
9th APRIL, 1990, at 12 noon at ACC Conference Room, Sydney.

- CHAIR: The President Mrs. Marie McCann opened the meeting with reading from 1 Corinthians 15: 51-58; this 'resurrection' chapter sets out from the pen of St. Paul, the Christian's 'sure and certain hope' and is a reminder and reassurance that any thing done for the Lord is not futile. The meeting was then committed to the Lord's guidance and over-ruling in prayer.
