TRAVEL POOL

The following is information relating to Travel Pool and comments would be welcome on or before the next Committee Meeting 30th April, 1973.

In the past A.C.W. has paid the fare for one representative to attend the National Committee Meetings and the State Units have paid for the second representative.

In 1973 the following fares were paid by A.C.W. for one representative from each State Unit to attend the N.C.M. in Sydney.

State Units paid individual amounts above for the second representative to attend the N.C.M.

It would appear from enquiries from various S.A. State Organizations and from the discussion at the Committee Meeting last that the usual practice is for all participating Organizations to pay an equal share of the fares.

Therefore had a Travel Pool been operating for the N.C.M. held in Sydney last February, the seven State Units would have shared the cost for the second representative, of \$392.07, each State Unit paying \$56.01.

The following is a basis for consideration regarding Air and Rail Fares to and from Adelaide.

Therefore with each State Unit accepting its share, the cost per State Unit would be \$63.60.

Please note that it was considered expedient that to save travelling time between Queensland and Adelaide, representatives to fly to Sydney and Tasmania representatives to fly to Melbourne. This then will enable both parties to link up with other State Representatives and thus travel together on a Group Booking. There must be six for a Group Booking, there should be over the required no. with representatives and observers. There is a total increase of \$53.16 to be paid by A.C.W. for first representative to come to Adelaide in lieu of Sydney, but this is offset by Working Committee Fares.

Travel Pool cont-

Working Committee Fares:

In 1973 A.C.W. paid fares for eight members of Working Committee \$208.26. Full fares President, Secretary and Treasurer and $\frac{1}{2}$ fares for the other members. One member used a free pass and the other was unable to attend. If all 10 fares had been paid by A.C.W. the account would have been \$246.13.

If Working Committee fares as above were to be paid by A.C.W. from Adelaide to Sydney the cost would be \$305.50.

There will be no cost to A.C.W. in 1974 for Working Committee fares.

For Further Consideration:

1. An Example:

W.A. paid \$150.50 for the second representative to attend the N.C.M. last February and had no Observers. Had a Travel Pool been operating, W.A. could have had the second representative and two observers for \$168.03.

2. National Presidents:

A.C.W. pays $\frac{1}{2}$ fares for National Presidents of affiliated Organizations to attend N.C.M. and it is envisaged that a Travel Pool may operate successfully for the remainder of fares.

3. Observers:

If a Travel Pool had been operating for two observers from each State Unit to attend N.C.M. (including the Hostess State) each person would have paid \$56.01.

We would be grateful if you would treat this as an urgent and important matter. If you have no meeting before 30th June, could you please forward them to a few groups and individuals whom you feel would respond.

The details concerning the Conference are self-explanatory, but we do request that you urge women in your State to give serious consideration to going. As the Commission of necessity includes women from New South Wales, it would be advantageous for Church women from the various States to attend to widen the scope of the enquiry. It would seem important that as wide a representation of Church women as possible should be present.

We would be interested to hear what reaction you receive.



NOTICE TO ALL STATE UNITS

Dear Secretary,

We have received the Minutes of a meeting of the Executive Committee of the Australian Council of Churches, held in February 1980. At the April meeting of the Working Committee it was decided that two items in these minutes, should be brought to the notice of State Units for information and whatever action may be considered.

item 1.

THREATS TO WORLD PEACE

It was moved and seconded

That the A.C.C. Executive adopts the following statement for transmission to member churches and to be released as a document for general information:-

"The Executive Committee of the A.C.C. meeting on 27 February, has discussed the threat to world peace posed by recent events in Afghanistan. The Committee believes that this situation and the reactions to it have created insecurity in many countries, and fear in many people. The use of force as a means to imposing 'solutions' to problems makes for more strained relations between nations and tends to lead to further violence. The Executive Committee of the A.C.C, asks member churches to consider encouraging their members to respond to the present circumstances along the following lines:-

1. Pray for the leaders and people of the countries directly involved, that they may see constructive and non-violent ways to resolve the conflict.
2. Protest to the official representatives of the USSR which has violated the human rights and territorial integrity of people of Afghanistan.
3. Try to become more fully informed about the recent events in Afghanistan.
4. Critically analyse the information and opinion presented through the media and other sources.
5. Encourage policies which offer the opportunity for a change through understanding rather than fear.
6. Support aid to those people displaced as refugees.
7. Consider the long-term implications of the pressures to increase the arms race.
8. Seek ways on maintaining communication channels among people of different countries.

ZIMBABWE

It was moved and seconded

That the A.C.C. urges the churches

- i. to support the special World Council of Churches appeal to assist the reconstruction of the new Zimbabwe, including the rehabilitation of the 200,000 (approx) refugees in neighbouring countries to meet their long-term needs;

- ii. to uphold in their intercessions the people of Zimbabwe and their newly elected Government as they try to rebuild their war torn country.

The A.C.C. also requests the General Secretary to write to the Prime Minister sharing our concerns over the information contained in the report from the W.C.C., seeking his comments and supporting his concerns and actions to seek a peaceful and just settlement in Southern Africa.

We have written to the A.C.C. expressing our support for the above two statements, and informing them that we have circulated our State Units regarding these.
