MINUTES OF WORKING COMMITTEE MEETING,

Held at Christian Welfare Centre, Perth, at 12.00 noon on Friday, 7th May, 1976.

OPENING WORSHIP: Rev. Dorothy Wacker opened the meeting with prayer and with a reading of the poem "Who Am I?" by Dietrich Bonhoeffer, thinking of the words in relation to our Aboriginal people.

APOLOGIES were received from Beryl Warr and Peg Eaton.

NEWS OF INTEREST TO A.C.W.: Dorothy Wacker reported that she and Peg Eaton attended a meeting of Dr. Margaret Sawin, who spoke about a method of Christian Education involving whole families for a given time, the family being the great educating unit.

A weekend conference was held in which members of different churches participated.

The P.W.A. of W.A. has organised a Study Day on the theme of "Enough is Enough".

"Enough is Enough" by Vincent Taylor, is to be reviewed by Vera Wilson for "Women at Work".

Marjorie Scurlock mentioned the book "My child's future depends on me", a Penguin publication.

Re Korea : a representative of the Churches of Christ is at present in Korea and could be asked to make any relevant enquiries for us.

Norma Ellis will spend several months travelling in England, Vienna, Greece, Turkey and Israel.

FELLOWSHIP OF THE LEAST COIN (Cont'd):

- 2) Recent contact with the W.A. World Day of Prayer Committee to be followed up re Fellowship of the Least Coin and Purpose of A.C.W. A letter to be written by the Secretary. It was agreed that the Western Australian State Unit be encouraged to invite members of World Day of Prayer Committee to share in one of its meetings.
- 3) A letter has been written to Fran Bailey seeking permission to duplicate and distribute "Small Beginnings".

WINIFRED KIEK SCHOLARSHIP:

Jean Vincent reported:

- 1) A letter re Sarrah Ah You has been received from Rev. John Garrett of the South Pacific Commission, advising the total cost of training is \$1,412.00 (Fijian). Jean Vincent to write to ascertain whether there is any need for further purchases of books.
- 2) A letter was received from the Queensland Unit expressing concern about the scholarship being taken up by Anne Kerepia in 1977. After much discussion it was agreed that a letter be written to Anne referring to the number of training opportunities given to her in 1975 and 1976, in addition to the proposed scholarship, and asking her to consult with the Y.W.C.A. re the possibility of their providing air fares to Fiji if she is to train there next year. The letter to be written by Jean Vincent and Vera Dean and an answer required by June 30th so that our plans for 1977 may be finalised when next year's scholarship applicants are received.
- 3) A letter has been received from Jean Skuse, enclosing a letter from Mrs. Parmar, from India, seeking help for her stay in Australia for one year. The letter had also been forwarded by Ms Skuse to others and Heather Stevens wrote from N.S.W. United Dept. of Christian Education, asking what action would be taken by A.C.W. A letter to be written to Heather Stevens stating that no decision can be made until further information is received and requesting her to pass on any news gained as a result of her enquiries. State Units may be able to help if Mrs. Parmar moves from State to State observing work done by the Churches. A copy of this letter to be sent to Jean Skuse. **** see 4) below.

ASSOCIATED BODIES:

N.C.M. - 1977:
