86/3/1 BUSINESS ARISING: from minutes of previous meeting.

1. ACWC

Phone call received from Victoria indicating opinion that this would be too expensive but maybe ACW brochure could be printed in other languages - Greek, Italian, Vietnamese, etc. Leonie Liveris, President W.A. Unit, may be able to help with Greek translation. German may also be useful.
