Deans presided over Mtg./ Following on the Opening Prayer, Mrs. Deans read from the Christian World interesting extracts from the Friends World "Conference held at Oxford; the Theme " Call to a New Dedication was presented to an Assemblage of (900) Quakers, representing 25 countries.
