MINUTES OF WORKING COMMITTEE MEETING

Held in C.M.M. Board Room, Franklin Street, Adelaide at 10 a.m. on 30th June, 1975

OPENING: Mrs. Smith welcomed members to the meeting, extending a particular welcome to Deaconess Eunice Simmons who has been co-opted to assist the Secretary.

PRESENT: Mesdames Joy Smith, Nell Kain, Joan Bache, Alder Hall, Ervyn Whitehead, Helen Morrow, Kath Howie, Gwenda Murchland and Deaconesses Norah Norris and Eunice Simmons.

APOLOGIES: Mrs. Sue Rowston.

DEVOTIONS: Mrs. Smith read thoughts and prayer by Michel Quoist entitled "We have too much to do".

MINUTES: Minutes of the meeting of 26.5.75 were confirmed in the form in which they were circulated.

BUSINESS ARISING FROM MINUTES: Leadership Training Seminar - As a result of discussions at the Bangkok Conference, A.C.W.C. had suggested that leadership seminars be held in different regions as planned at the Conference. Mrs. Fran. Bailey attended for a short time during this discussion. Mrs. Rachel Cocks had written to the other groups in our region - New Zealand, and Indonesia. It was felt that until both replies had been received it was difficult to make any decision as to what should be planned for this region. It was agreed that time should be allowed at the N.C.M. for discussion of this subject.

Travel Pool - Cheques from all States except Tasmania had been received. Tasmania had queried the effect of increased fares on the Travel Pool. The Treasurer advised that after consideration she felt it would be simplest to operate the Travel Pool on the figures already distributed and that State Units present accounts at the N.C.M. for any increases they have had to pay. She gave notice that she would then move at the N.C.M. that "these accounts for increases in fares be paid from monies held in the Travel Pool after which the remaining sum would be divided equally between State Units." Treasurer sought and was granted permission to pay to Queensland, W.A. and N.T. Units their extra share from the Travel Pool.

Winifred Kiek Scholarship

Convenor reported that Mrs. Weme had been well received by women's groups in Victoria and Tasmania. Mrs. Weme is preparing a written report on her work in Victoria. It had been intended that Mrs. Weme should attend this meeting, but as it was the first day of a course arranged by the Dept. Community Welfare it was not possible to arrange this. Convenor advised that Mrs. Weme has been enrolled to do a course with the Aboriginal Task Force. She is due to arrive in Sydney on 4th August. The possibility of her travelling to Sydney by bus via Broken Hill was discussed and it was agreed that the Convenor should try to arrange for her to speak to women's groups at at least two points on route. Mrs. Weme will stay at Deaconess House while in Sydney.

The matter of a continuing committee to look after Mrs. Weme's needs after the Working Committee moves to W.A. was discussed.

Scribal Pens and Notelets

Convenor reported that the only money outstanding is from S.A.

N.C.M.Reports for Working Documents

Secretary reported that some reports have been received. It is imperative that they reach her early in July in order that Working Documents can be sent out as soon as possible.

Members of Working Committee presented reports on their special areas of responsibility and these are now ready for inclusion in Working Documents.

Study Booklet - It is proposed that the W.C.C. study booklet "Jesus Christ Frees and Unites" be used as the basis of Bible Studies at the N.C.M. Delegates are asked to obtain their own copies from the local Council of Churches office so that they may be familiar with the subject matter before arriving at the N.C.M.

The remainder of the meeting was spent in finalising details of the programme and other arrangements for the N.C.M.
