Nathaniel Jones

Conditions under which the Revd Nathaniel Jones is nominated by the Venerable Archdeacon MacCullagh to serve as Curate at White Hills and other places in the Archdeaconry of Landhurst.

- i. A Fund is to be formed with (a) grants from Diocesan Funds towards the maintenance of the Services of the Church in the Districts of White Hills, Golden Square, Long Gully, Haanecooie, North Bridgewater etc; and (b) the contributions made by the people of those places towards such services.
- ii. Out of the said Fund the following expenditure is to be provided on the accompanying conditions:
 1. The Revd N. Jones is to receive £100 per annum for his own use as specified in this nomination.
 2. The Revd N. Jones and his family are to be provided with free board and residence.
 3. Any Readers licensed by the Bishop to serve in the above named districts are to receive free tuition from Mr Jones, and free board and residence with Mr Jones and his family.
 4. The Readers are to work under the superintendence of the Archdeacon; the time for studying, visiting etc being prescribed by him.
 5. All expenses connected with housekeeping, servants wages, food, fire, lighting and repairs, are to be paid out of the Fund.
 6. Travelling expenses of the Curate and Readers in the discharge of duty are to be paid from the Fund; and all other expenses (except the Archdeacons) incurred in carrying on work in other outlying districts are to be paid from the Fund.
 7. Any unexpended balance of the Fund at the close of every year is to be divided pro rata among the Readers employed, on such basis as may be determined by the Archdeacon.
