The Interim Committee of Australian Church Women would be very grateful if one of its members could visit your Council to explain Australian Church Women, to answer questions and to enlist your cooperation for this ecumenical adventure. Dear Mrs. Pearson,

You will remember that in May of this year the Interim Committee of Australian Church Women sent out a statement of its purpose and aims to all Federal and State denominational women's groups and the Women's Inter-Church Councils in all States where they existed. There has been considerable discussion of this project and many groups have replied expressing their interest in this movement and asking for more information regarding the basis of Australian Church Women, and concerning the next steps which they can take to become part of ACW.

At its meeting on July 3 the Interim Committee resolved to invite the existing women's ecumenical organisations which operate on a State basis to become the State Councils of Australian Church Women. There is a copy of the document "Suggestions for a more formal structure of Australian Church Women" enclosed with this letter. This document sets out the basis on which this invitation is extended.

I am writing to you now to extend the invitation to the Women's Inter-Church Council of Queensland to become the State Council of Australian Church Women for Queensland.

The Interim Committee is convinced that ACW is needed to promote ecumenical thought and action amongst the church women of Australia and that existing women's inter-church groups are the best channels for this ecumenical promotion. This opinion has also been expressed by inter-church groups and individuals in N.S.W., Victoria and South Australia.

It is the earnest hope of the Interim Committee that your Council will accept this invitation and will become an integral part of this movement to draw together the women of the Australian churches and to link them with Christian

women throughout the world.

There are still many questions to be resolved, for example:

- . the time and manner of the election of a permanent national council
- . the financial requirements of ACW
- . the location of a national headquarters of ACW
- . the nature of the relationships of ACW and the Department of Cooperation of Men and Women in Church, Family and Society of the World Council of Churches.

It is felt that these issues can be faced when once this more formal structure has been established. The calling together of representatives of Women's Inter-Church Councils who are prepared to act as State Councils of Australian Church Women would be the immediate next step.

I am very glad that Mrs. McKay will be able to visit your Council this month. I am sure that she will be able to answer the many queries that will arise as you consider our invitation to become the State Council of Australian Church Women.

Dear Mrs. Pearson,

Thank you for your letter of November 5. We are glad to know that your committee will be discussing affiliating with Australian Church Women at the meeting on November 29.

We are sorry that your committee is worried about what financial commitment will be involved. At the moment Australian Church Women is being financed by the Australian Council of Churches as an aspect of ecumenical promotion. The interim committee of Australian Church Women has not considered contributions from the states and does not regard this matter as within the province of an interim committee to determine.

The purpose of Australian Church Women is to bring together the existing women's groups in an ecumenical experience through the promoting of a Fellowship Day, a World Community Day and providing study materials and stimulating service projects. The promoting and following through of these plans would be done by the state committees (which we hope will be the existing inter-church women's groups in the states).

So far South Australia, Victoria and N.S.W. have agreed to be the council for the Australian Church Women and we now work through the women's inter-church council in those states.

At the moment we are in the midst of producing a study booklet for use in denominational and interchurch women's groups. Details concerning costs, etc will be mailed soon.

We will look forward to hearing from you following your meeting on November 29 and wish to assure you of our ~~best~~ <sup>best</sup> to cooperature fully with you and that we will be happy to answer any ~~other~~ <sup>other</sup> queries which your committee may raise in the course of your discussions.

WOMEN'S INTER-CHURCH COUNCIL OF QUEENSLAND

Secretary's Report for 1964

The year 1964 has been important for the Council, for at the Annual Meeting in November 1963, the Inter-Church Council voted to affiliate with Australian Church Women and became the State Unit of that body.

The election of Office Bearers resulted in a change in the Presidency - Mrs. Ashton being elected to that office, Mrs. Giezendanner having served so efficiently for the past two years. After thirteen years as Secretary, Mrs. Pearson resigned and Mrs. Dennis was elected to the position. Mrs. Potter was re-elected Treasurer. Retiring Office Bearers were thanked for their services.

A communication from Australian Church Women invited a delegate to a consultation of the Interim Committee to be held in Sydney on 17th and 18th March 1964. As our President had another engagement, the Secretary was appointed to represent Queensland. Rail fares and hospitality in Sydney were provided.

Such matters as the Constitution of Australian Church Women, the introduction of the Fellowship of the Least Coin, and study material for meetings, were discussed at the Consultation which was constituted in Wesley Chapel by Rev. B. R. Wyllie, Master of Wesley College. Mrs. Wyllie, Convener of the Interim Committee, presided over the meetings which were held within Wesley College, Deaconess House, and at the rooms of the Australian Council of Churches, 511 Kent Street. Delegates came from all States and included women from the Armenian Apostolic, Baptist, Church of Christ, Congregational, Church of England, Greek Orthodox, Methodist, Salvation Army, and Presbyterian. A special meeting of our Council was called on 10th April to hear the report of the Consultation. Owing to the Postal strike in Sydney, the official report did not reach us in time for this meeting but was later posted to all members.

In all, six meetings were held throughout the year and presided over by our President, Mrs. Ashton, whose opening devotions often contained thoughts from Rev. Winifred Kiek. We were glad to receive delegates from the Church of England and from the Y.W.C.A., thus strengthening our witness and influence.

A request to include a Women's Thanksgiving Service in the celebrations of the "Warana" Festival, was forwarded to the Warana Promotion Committee who accepted the suggestion and formed a Women's Committee to arrange the Service. Thus the Women's Thanksgiving Service for "Warana" was instituted. It was held in the Albert Hall, and we trust, will become an annual event in the programme.

The study book, "Saints Alive" was well received and used in our studies.

It was decided to inaugurate "World Community Day", using the Order of Service supplied by Australian Church Women. The service was held in Ann St. Presbyterian Church, Rev. T. Rees Thomas being Guest Speaker and the Presbyterian Ladies' Choir rendered an anthem and led the praise. Members of the Council conducted parts of the service and the President presented the aims of the Inter-Church Council and Australian Church Women, the Secretary introducing the Fellowship of the Least Coin. A booklet tells the history of this Prayer Fellowship, and a folder gives an abridged account of its activities. The booklet "Circle of Prayer" containing devotions for two years, compiled by Christian women of the East, costing 3/-, was available to be used in conjunction with the giving of a Least Coin.

During the year congratulations were extended to Commissioner Coutts on his elevation to a high Office, to Mrs. Trigge on her daughter's academic success, and to Mrs. Lockley on her husband's election as President-Elect of the Congregational Conference. Sympathy was extended to bereaved members.

The Inter-Church Council was glad to send representatives to the Annual Meetings or Conferences of the Women's Organisations of the Presbyterian, Salvation Army, Baptist, Church of Christ, Congregational, and Methodist Churches, noting the excellent work being done by the Church women in Queensland, the Commonwealth, and beyond our borders.

It was gratifying to have the Southport Inter-Church Fellowship affiliate with our Council and appoint as its representative, Mrs. Hage of Southport.

During the year 141 notices of meetings were posted to members, and 38 letters written as well as Reports and other literature being posted to members from time to time for their information and consideration.

Comments and suggestions regarding the draft constitution were forwarded to the Interim Committee, and it is hoped that the latest draft may be accepted as fulfilling all the aims and objects of Australian Church Women.

An invitation to send two delegates to the first Annual Conference is to hand. May God continue to bless and guide all associated with this tremendous forward thrust, that the impact of Christian workers may be felt throughout Australia, throughout the World, and the Light of the Gospel establish the Brotherhood of man and the Fatherhood of God.

Affiliated Churches - Baptist, Church of Christ, Church of England, Congregational, Methodist, Presbyterian, Salvation Army, & Society of Friends, also Y.W.C.A. & Associate members. Collection from "World Community Day" amounted to £12.6.1 which amount was forwarded to the Freedom from Hunger Campaign. £2.1.0. was received from the Fellowship of the Least Coin. 22 copies of "Circle of Prayer" were purchased.

- (c) "and on what questions?" The Working Committee feels the answer to this is - "any urgent matter of administration which requires attention between Working Committee meetings." We might add that we hardly think this is likely to be much, seeing we meet monthly.

You will be glad to know Fellowship Day material is well on the way. We hope to let you have a sample of this, with price, during next week.

Thank you for the Minutes of the meeting of the Working Committee held on 22nd. June 1965. These are interesting, and we note the information they contain.

In reply to your request for a report on the visit of Miss Connie Tan (let me state that) - Two meetings were held - one in Brisbane at which the attendance was quite good. Miss Tan's address was well received. We had organised a Panel to discuss the questions at the back of the order of service, allotting one or two questions to each of the five (including Miss Tan) These were well handled. Rev. T. Rees Thomas, who well knows Rev. Winifred Kiek and her husband, was Chairman.

Miss Tan motored to Southport - 50 miles - to attend a Fellowship Day meeting there. The attendance was good - about 50 or 60. The offering from the two meetings amounted to £17.12.9. We deducted the cost of 200 Orders of Service and remitted £16.2.9 to you in Sydney, plus £20 received from the World Day of Prayer Committee - total £36.2.9. During her stay in Brisbane, Miss Tan was the guest of Mrs. Potter and Rev. S.Y. Potter. Mrs. M.M. Reid drove her in her car to Southport. Colonel Sampson drove her in her car to visit the Spastic Centre and a Home for Girls who have been convicted in Court conducted by the Salvation Army. SECRETARY'S REPORT FOR 1965

At the Annual Meeting of the Council held on Friday, 30th October 1964, the President, Mrs. A.G.Ashton, Secretary Mrs.F.G.Dennis, and Treasurer, Mrs.S.Y.Potter, were re-elected, and members voiced thanks for the year's work.

The Secretary's report and the financial statement were roneoed and distributed to members. During the year the expenditure had been £28/4/3 leaving a credit balance of £2/11/11. *Mrs. A.G. Ashton*

Our President attended the first meetings of the National Committee of Australian Church Women held at Deaconess House within the University of Sydney, and had the honour of leading the Devotions on the second day.

A Special meeting of the Council was called for 19th February to hear the very detailed account of the business of these meetings, given by Mrs. Ashton. Copies of reports from State Units were made available to delegates, thus co-ordinating the work of all the States. The Constitution of Australian Church Women, having been discussed by State Units and agreed upon, was ratified by the Australian Council of Churches at their Annual Meetings held on 11th to 16th February. Copies were subsequently forwarded to State Units for distribution among members.

The "Winifred Kiek" Scholarship was implemented this year, (its aim being- "To offer supplementary training for a Christian woman who has already received her basic training...") The first Scholarship holder, Miss Connie Tan Kwie Hwa, (a Social Worker from Djakarta, arrived in Sydney in May, and) on our invitation, came to Brisbane. Miss Tan was met at the Inter-State Station by Mrs.Ashton and other members of the Council, in whose company she was driven to Southport by Mrs.Matthew Reid after lunching at her home.

Fellowship Day was observed in Brisbane this year, the Service being held in the Salvation Army Citadel, Ann Street, at which Miss Tan was Guest Speaker. The Theme, "Bridges to Asia," was well handled by our Guest, and to conclude the Service, questions arising were discussed by a Panel led by Rev.T.Rees Thomas, and including Miss Tan who endeared herself to all who had the privilege of meeting her. Miss Tan also addressed the Fellowship Day meeting at Southport arranged by the Inter-Church Fellowship. From the Offerings at these two meetings, an amount of £36/2/9 was forwarded to headquarters towards the Winifred Kiek Scholarship Fund.

While in Brisbane Miss Tan was the guest of our Treasurer, Mrs.S.Y.Potter, and was driven to visit Institutions by Colonel Lilliam Samson and Mrs.S.L.Richardson, to note the social work being carried on for children and for aged folk.

\* Throughout the year representatives have attended Annual meetings and Conferences of affiliated Churches, and on occasions gave greetings on our behalf. A unique gathering was the Public Welcome to Dr.Michael Ramsay, D.D., Lord Archbishop of Canterbury and Primate of all England, held in the Festival Hall on 16th March and attended by our President and Secretary. The Inter-Church Council was represented also at the Women's Thanksgiving Service connected with the Centenary Celebrations of the Sherwood Presbyterian Church.

Again our Council was invited to be associated with the "Warana" Women's Thanksgiving Service in the Albert Hall on 30th September. Mrs.Ashton led in prayer and Mrs. Glezendanner read the Scriptures. Also in connection with "Warana", Mrs. Ashton took her reserved seat in the Gardens for the Official Opening and unfurling of the flags.

Congratulations were extended to Mrs.R.S.Byrnes on her election as President of the National Council of Women, with which body our Council is affiliated; to Rt. Rev.Wm.Young B.A., on his ordination as Moderator of the General Assembly of the Presbyterian Church of Australia, and to Colonel G.Garlick of the Salvation Army, on whom Her Majesty was pleased to bestow the Order of the British Empire in the Birthday Honours.

Sympathy was expressed with members who had been bereaved, or were passing through anxious times because of ill-health.

\* Of gratification to us were the gifts by the Women's World Day of Prayer, £20, and the Methodist Women's Federation, £10, to the Winifred Kiek Scholarship Fund.

A Vice-President of Australian Church Women, Mrs.D.J.A.Verco, was invited by the Presbyterian Women's Missionary Union to be Guest Speaker at their Annual Conference held in the City Hall in May. Mrs.Verco's address was most informative and greatly appreciated.

The Secretary spoke to a Group of Deaconesses of the Presbyterian and Methodist Churches, telling of the formation of Australian Church Women, and its activities.

Now at the close of another year's work, we pause to give to our Heavenly Father the Praise and the Glory, and render thanks for His continuing guidance in our commitments. For our health and strength we are grateful and pray that our endeavours in the future may be fruitful so that His Kingdom may gain ground.

Thank you for your letter of 1st inst.,  
which was received at the Working Committee yesterday.

We are delighted to know that Fellowship Day  
passed off in such a stimulating manner. There has been a good  
deal of appreciation expressed concerning the Order of Service, and  
the fact that the writer was the Rev. Edwin Robertson made it  
of added value many of us thought.

You will probably have heard that we replied  
to Mrs. Ashton, who also wrote concerning the \$40 donation from the  
Women's World Day of Prayer to the Winifred Kiek Scholarship Fund.  
As that letter indicated that donation in its entirety was placed,  
of course, to that Fund.

At present we are not able to fully answer  
your enquiry as to how much of your cheque from Fellowship Day  
Offerings will be placed to the Winifred Kiek Scholarship Fund, apart  
from saying that the purpose in mind is that as large a percentage as  
possible of the nett income from Fellowship Day will be devoted to the  
Winifred Kiek Scholarship Fund. When offerings have been received from  
all States then a Balance Sheet for Fellowship Day will be prepared  
and the allocation to the Winifred Kiek Scholarship Fund made.

As distance, and not being associated with the  
close working of some of these matters, naturally raises enquiries,  
perhaps it may be helpful if I try to explain a little. During the  
time A.C.W. worked as an Interim Committee and in most respects during  
the first year of its establishment (1965) working expenses just came  
out of the funds of the Australian Council of Churches. It came to  
be felt by Australian Church Women that now that we were established  
we should accept some responsibility for financing our administration -  
in the way of stationery, postage, and similar incidentals. Thus at  
the National Committee Meeting this year it was resolved that States be  
asked to send us 60% of collections from Special Days (with the proviso  
that States could vary this somewhat if they so desired). The idea is  
that the larger part of this will go to the special project, such as  
Winifred Kiek Scholarship Fund from Fellowship Day collections, and a  
small amount to A.C.W. administration. However, as this is the first

2.

year we are going this way what that percentage will be has not yet been discussed or decided upon. With the finalising of Fellowship Day this year that will need to be looked at and a decision reached. Now, I hope you haven't found this burdensome, but it is obvious some of your ladies would like some fuller information, and I hope this will be of service.

This will let you know that we are sending to you 150 copies of the Order of Service for World Community Day. I hope to parcel these up when I am in the City tomorrow, so you should receive them within the next few days.

We are sorry that we find it necessary to charge a little more for these than for the Fellowship Day Programmes. You will see this in the Minutes for yesterday's Working Committee when you receive them. The explanation is that the overall order for World Community Day is some thousands less than for Fellowship Day (accounted for by the fact that in Victoria Fellowship Day is held at many more centres than World Community Day), also there is a little more material in this Order of Service than the former one. The charge will be  $\$2.50$  per 100. We have kept this low as we possibly can - even so we are not sure that we will recover all our outlay, but we have tried to do our best all round.

We are also sending you 100 copies of Information Folder concerning Miss Swarup - the Winifred Kiek Scholarship Holder. If you would like more, please let us know.


