MINUTES of Meeting of the Working Committee held at the A.C.C. Building, Sydney, on Tuesday, 1st August 1978 at 9.30 a.m.

OPENING: The President read from the calendar published by Church Women United in the U.S.A. - Who ARE Church Women United? - which sets out the ideals of that organisation so similar to our own. Mary Andrews led in prayer.

As the fund stands at \$510.31 with an additional \$500 recently received, and our two ^{representatives' fares} delegates' fares will be about \$1,400 each, it was resolved that we seek Mrs. Fran Bailey's advice as to the possibility of obtaining \$2,000 from the ACWC Travel Fund, which we hope we will be able to reimburse in due course. In the meantime, efforts will be made to encourage ^{denominational} local women's groups to each contribute \$1 to the fund.

CONVENERS' REPORTS

Winifred Kiek Scholarship. Barkat Dass attended four Fellowship Day Services and was warmly received. She also attended the annual Dedication Service of Life Line, Parramatta.

Special Days. Many comments have been received in appreciation of the Fellowship Day order of service and it was resolved that these should be passed on to the group of women who prepared it from the Chester Street Epping Uniting Church.

Fellowship of the Least Coin. Marjorie Stanhope reported extracts from the ACWC News Bulletin. She would be pleased to hear of any plans groups within Australia might have to celebrate the Silver Jubilee of the Fellowship of the Least Coin. It was resolved that quotes be obtained for the printing of FLC labels (2,000, 5,000 and 10,000). It was resolved that a roneoed sheet, giving information and news of the F.L.C. and recent allocations, be issued to State Units for insertion in the World Community Day orders of service. Marjorie Stanhope and Joan Curtin to prepare the material for this.

"Women at Work" Joan Curtin reported that the theme for the August issue would be "Simpler Lifestyle".
