The following items were listed for consideration, prayer and possible action: Treatment of asylum seekers in offshore detention, transparency needed in child sex abuse cases; rights of marginalized and oppressed in our communities; closure of Aboriginal Medical Service at Mt Druitt, NSW), Domestic violence, Recognition of indigenous Australians in Constitution, More equitable distribution of water resources.
