A summary of the file on the visit of Mrs. Shanti Solomon to Australia had been prepared for the information of committee members. This contained relevant correspondence received since the August committee meeting. The meeting decided that the prepared summary should be circulated with copies of minutes of the September meeting. (Copy attached).

Very great regret was expressed at the necessity to cancel plans or provide last-minute alternatives in Perth, Adelaide and Melbourne, because of Mrs. Solomon's delayed departure from India. Keen sympathy was felt in the disappointment of church women in these cities, that Mrs. Solomon was not able to visit as scheduled.

Attention was drawn to the fact that some States had been put to considerable expense in notifying developments during the anxious time of delay in Mrs. Solomon's arrival. Committee members were strongly of opinion that such expenses should be met from national funds and reimbursement would be made to those who had incurred expense in the sending of telegrams, cables or 'phone calls. On the receipt of advice to this effect, A.C.W. treasurer would forward a cheque to cover such amounts.

The following accounts were passed for payment - Stationery & Stencils, \$13.51; Postage for Secretary, \$20.00; Balance of Rail Ticket to W.A. for Terani \$145.50; Expenses - Visit of Shanti Solomon, \$14.00; Gift for Terani from N.S.W., \$10.00.

The Treasurer reminded that time is short and special effort would need to be made with pen sales if travel expenses, as for N.C.M. '72, are to be met. As \$800 is owing to Administration & General Account from A.C.W. Notelets Sales, no advance towards '73 Travel Expenses can be made from this Fund.

It was decided that an amount of \$10.00 received from N.S.W. as a gift to Terani be handed to her to be applied towards meeting costs incurred in connection with her Diploma (Melb. Div.) Course which she plans to continue by correspondence from Fiji.

Attention was drawn by the treasurer to the need to clarify some points relating to Finance in the A.C.W. Constitution. A motion to cover this was prepared and it was decided that this motion be included in "Notices of Motion" to be circulated with minutes of September meeting.

## REPORTS:

### UNITED CHURCHES

Mrs. Lane was still anxiously awaiting news from United Church Groups to whom she has continued to write monthly letters.

### NEWSLETTER

The next issue of "Women at Work" would be prepared by Mrs. Dingle, and it was hoped in readiness for circulation with copies of minutes.

### PENS

The new supply of pens was being despatched as orders came in. Mrs. Miller had drawn attention to a slight increase in price since the first orders were placed.

### FELLOWSHIP OF THE LEAST COIN

Supply of additional Information Leaflets and Labels was awaited from the Printer, the visit of Mrs. Solomon having stimulated interest. A letter from Rabaul reported that the Women's Fellowship there had been introduced to F.L.C. and that it was hoped to translate the "Circle of Prayer" Booklet into Pidgin English and their own language. There are currently approximately 200 copies of C. of Prayer on hand.

### WINIFRED KIEK SCHOLARSHIP

It was reported that Terani would leave Brisbane at 11.15 a.m. on 16th November for her Western Australian visit and that arrangement had been made for her to visit New Zealand on her way back to Fiji, New Zealand contributing the additional cost of fare. In connection with the matter of policy re composition of the W.K.S. Committee, this matter would be considered fully at the November meeting of the Working Committee. Mrs. Pope drew attention to an excellently prepared newsletter received from Western Australia and which was being circulated among W.A. Church women by the W.A. Unit. This made mention of A.C.W. aims, purposes and projects, particularly listing F.L.C. and the W.K.S. and the visit of Terani to Western Australia.

### SPECIAL BUSINESS: W.K.S. Committee Report and Recommendation re AWARD of 1973 SCHOLARSHIP -

Special consideration was given to the recommendation of the Scholarship Committee. Mrs. Pope pointed out that some excellent candidates had applied. She had been advised by South Australia in regard to facilities for particular training and study in Adelaide. The applicant selected to receive the award for 1973 was

MISS MALPANA JUDSON AIRAN, 26 years, of Satara, Maharashtra, India. She holds the degrees of B.A., B.Ed., and speaks English, Marathi and Hindi. She wishes to undertake study in Kindergarten Pre-primary teaching and organisation and Community Development, her ambition being to set up a centre for underprivileged children and their mothers and prepare them for education.

The secretary was directed to send Miss Airan official notification of the award.

SPECIAL BUSINESS (Contd.) AWARD OF 1973 W.K.S.

In the case of Miss Airan, advice had been received from South Australia that the training she desired could be better supplied in Sydney or Melbourne than in Adelaide. Mrs. Pope was requested to investigate the possibility of Sydney as the study centre. Forms for completion for entry into Australia would be forwarded by Mrs. Pope to Miss Airan. Advice was also to be sent to the Department of Immigration concerning the scholar selected to receive the award for 1973.

GENERAL BUSINESS:

VISIT OF SHANTI SOLOMON - Arrangement was made for members of the Working Committee to meet Mrs. Solomon on her arrival at the airport on the evening of 27th September. It was decided that a gift from A.C.W., as a souvenir of her visit to Australia be purchased and presented to her at an appropriate time during the day of the special visit to Nambour for a meeting with church women there. It was planned that the return trip from Nambour would be a scenic drive via the near north and Sunshine Coasts. It was reported that Friday morning's Brisbane meeting would be followed by luncheon at Parliament House for Mrs. Solomon, Terani Aisake (1972 W.K.S. holder), Violet Sampa (1971 scholarship holder), Mrs. Clarke (President of Queensland Unit) and possibly Dr. Jean MacFarlane. This had been arranged by Mrs. Miller whose husband is a Qld. M.P. Mr. Miller would be arranging for the visitors to be shown over Parliament House before they left to view films of Dr. MacFarlane's work among aborigine mothers and children.

N.C.M. 1973 - The theme decided upon was "Able for All Things", this being considered a comprehensive one, covering ideas presented at N.C.M. '72 as likely suggestions. Copies of the draft agenda were received by members for their further consideration, criticism and amendment at the October meeting of the Working Committee. Some thought would then also be given to the content of "Opening Worship and Address" and Closing Session and Morning and Evening Times for Prayer and Meditation.
