*Minutes of the ACW National Executive Meeting
Held on Monday 20th April 2015

Devotions: Denise led the Devotions, and began by giving each person a small cup, which represented the theme 'a moment with my cup'. The outside is what people see; inside the cup, think about your spiritual life – what does it look like? Who helped you in your spiritual growth? What fills and empties your spiritual cup? Emptying and filling, giving and receiving, accepting and letting go. What could we share with others from our cups? What might we need to add.? Denise closed in prayer.

REPORTS

President's Report:

Lyn attended the MU Festival Service at St Andrew's Cathedral. It was a lovely service and fellowship was enjoyed over lunch following the service. Interestingly, the guest speaker who was from Perth was to speak at the Perth Unit's meeting the following week so Lyn sent greetings with her.

Forward Group: The Forward Group Discussion Notes were received from Lynette Green from their last meeting. Schools have been contacted in WA and Vic and one is to be approached in Hobart concerning the Essay Competition. A young Christian woman has been approached to be the driver for the competition. Her name is Cynthia Carter and she is from Victoria. The suggestion of National Executive for a prize in each state will be discussed at conference but only the one National prize will be offered this year. Lyn surmised that it could remain with the individual Units if they want to provide a prize for their winning entrant.

The Forward Group will prepare a presentation for Conference with notices of motions arising out of their deliberations. The Forward Group will need to note that these notices of motions have to be received by National Executive before 7th July.

Vice President 1 – Denise Secomb

Denise has been working on Devotions for the Conference and has made a list of those who can participate. Collaroy Centre need to be advised of final numbers attending the Conference by 6th May 2015, and also suggested meal times, which were discussed.

There are now 53 Registrations. Included in this list is one from New Zealand. There are five requests for single occupancy and the necessary money up-front has been received. Day Visitor leaflets/Registration forms have been incorporated into the latest copy of Newsette and also forms were available for state council today.

Jennifer moved that the Treasurer's Report be accepted, Seconded by Isabel. Payment of the accounts listed was approved.

At the last meeting we decided that Cana would be the Special Project. Pamela has written to ACT and informed them that another project has been selected. Pamela has asked the units for their endorsement and is waiting for their responses.

The preparation for printing for World Community Day will go ahead on receipt of approval from the State units. Pamela has been in touch with Victoria regarding the next State to prepare World Community Day.

Pamela suggested that a couple of NE members should visit Collaroy to get an idea of the layout, and perhaps having a NE meeting there.

Social Justice Convener – Shirley Mitchell

Shirley is considering what issue of national interest can be put forward on Social Justice and has had two replies from the unit conveners. She has asked that reports be sent by 31st May and has received one from SA.

Some of the issues being considered are: rights to water and coal seam gas fracking; constitutional recognition of Aboriginal and Torres Strait Islander people; domestic violence and the effect on children; immunization.

Lyn suggested that issues with rationale, be circulated to members of NE, so that an informed decision can be made at the May meeting.
