Thank you for the report of the National Committee meeting of the A.C.W. which we were glad to have. We duplicated this and made it available to the members of our Executive.

To All State Secretaries.

The Working Committee recently had a report on the conference on "The Family To-day and Tomorrow" which was run by the Commission on Christian Education of the Australian Council of Churches. We feel that many of the issues raised at this conference are ones which Christian women throughout Australia ought to be thinking about.

Should unmarried mothers be encouraged to keep their children?  
Do we know why marriages break down?  
Could we do more to enrich marriages?  
What is our attitude to divorce?  
Is pre-marital chastity an out-dated ideal?  
Is the nuclear family a narrow, limiting thing - "the source of all our discontent"?  
Is a commune a viable alternative to the nuclear family?  
Can we accept homosexuals?  
Do we think there is something wrong with couples who choose not to have children?  
Should town-planners be encouraged to provide more cluster housing?  
How can we overcome the loneliness of old people living in flats, and isolated young mothers?

These are just a few of the questions we could be asking ourselves. Very often it is so-called "Christian" attitudes to marriage, sexuality and the family which are being attacked or questioned. It is important that we know what we think, and why we think it. This may best be done, not just by talking amongst ourselves, but by meeting people who have some experience of these things. We ought to try to talk with homosexuals, single parents, widows, town-planners, creche supervisors, mothers of young children, teenagers, people in communes, family planning advisers, marriage guidance counsellors, educationists and so on.

Do you know of ways in which your State Unit could encourage local church women's groups to do some thinking about these issues?

The report of the conference, "The Family Today and Tomorrow" is now available, and is a valuable resource book. It is available for \$1.50 (plus postage) from the Australian Council of Churches, Commission on Christian Education, 100 Flinders Street, Melbourne, Vic. 3000. Postage for one copy is 30 cents.

Also available from there is a booklet, "Marriage To-day and Tomorrow" by Ronald Fletcher, for 30 cents, which looks at many of the criticisms of the family. The key emphasis is on "the marriage of good friends".

The green leaflet prepared for National Marriage and Family Week contains some very useful discussion starters, and activities that can be used in meetings. You received a copy of this with your February Working Committee minutes.

If you visit the offices of the Departments of Christian Education in your state, and also the Marriage Guidance Council and Family Life Movement, you will find some helpful literature.





Dear Mrs. Murchland,

My apologies for taking so long to respond to your letter of 5th May. Since receiving the letter, it has been a particularly busy time for me. While the N.S.W. Presbyterian Assembly was on I was only home to sleep and since then I have been working practically full-time (part-time in the BOEMAR office and part-time for a friend who has been without a woman in the office) as well as being out most nights to meetings.

I was able to attend the meeting of the Commission on Faith and Order on 2nd May (minutes enclosed). These are the first minutes to be sent out since I was re-appointed to represent A.C.W. There was another meeting some months ago and I was relying on the minutes for my report, but none came. As you will see from these minutes, "it was agreed that the Commission meet again in about three months' time".

You will have heard about the financial position of the A.C.C. and this is the reason partly for the Commission's infrequent meetings. - Another reason is the difficulty of getting the members together. Although the meetings are very interesting, I (at least) am conscious of the small attendance when people come specially to lead a discussion. The discussions are quite often very technical and not the sort of thing that can be briefly reported upon. If I receive a copy of the paper presented by the Rev. Geoff Barnes, I will send it to you.

Thank you for the invitation and registration form for the next National Committee Meeting, but I'm afraid that I must send my apologies. I am heavily committed with local, state and national committees in connection with the Uniting Church and I just can't contemplate spending the time and money involved this year. Miss Mitchell might be willing to replace me as the representative on the Commission. I fly the flag for A.C.W. at the meetings, but I realise that it is not very satisfactory from your point of view and Miss Mitchell might be able to write a few paragraphs that would make sense to readers of "Women at Work". The nature of the subject matter makes this very difficult for me.

I accepted an invitation to a luncheon to meet Dr. Emilio Castro, the Director of the W.C.C. Commission on World Mission and Evangelism, when he was in Sydney (Monday, 3rd March). A meeting of Presbyterians in connection with Church Union was called at short notice for that morning and so I arrived at the luncheon a little late and breathless. Unfortunately they had taken the opportunity while they were waiting for the food to arrive to hear what Dr. Castro had to say, so I missed the beginning and I took a little while to get used to his accent and therefore to really catch what he was saying. I would have gone to the meeting at Epping that night when he spoke to members of Christians One and others, but I had already undertaken to attend the inauguration of the United Theological College.

Deaconess Andrews, who originally pushed for A.C.W. to be represented on the Commission, might be prepared to write a report for A.C.W. She is a member in her own right and actually represents the Commission on the Division of Faith and Witness and therefore has a much better grasp of things. I could still attend the meetings if nobody else is willing and send you a copy of the minutes.

Please convey my greetings and good wishes to the National Committee Meeting with my apology and remember me to all my pals. I have put much time and effort into A.C.W. in the past but I have been more than amply rewarded by the opportunity to make friends with people from all over Australia and some of them have been very special people indeed.

Once again, my apologies for being late with my reply. I am glad of the public holiday to-day to get to my desk to-day but a heavy head cold has not been exactly helpful.
