Jean feels that if, as Christians, we want a reasonable standard to be maintained in advertising and speech, then we must let our voices be heard when we see standards dropping. It is encouraging when companies take note of genuine concerns and if we see or hear something that offends, a personal letter will be taken seriously and can achieve good results.
