TREASURER'S REPORT

It is my pleasure to present the Financial Report of the Australian Church Women for the year ended 30th June 1986.

It will be noted that only \$10 was received towards the incoming National Executive Travel Fund.

Consideration will be given shortly to placing further funds in specific investments for the Winifred Kiek Scholarship. Interest this year for the for Winifred Kiek Scholarship was approximately \$2,800. 00 The overall cost of our last scholar, Miss Valerie Palang was nearly \$5,700. 00.

As the International Committee of Fellowship of the Least Coin have requested that our National Contributions be now sent to them each year by 31st of December, the money from 1985, sent by States to National this year will be retained and sent in December.

The falling exchange rate of the Australian dollar is of concern when sending money both to I.C.F.L.C. and A.C.W.C.

As a \$300 deposit for our 1987 venue for the National Conference was required to be paid in advance the money was loaned from Administration and General account for this purpose.

It was pleasing to see an increase in the overall interest this year of nearly \$1,000. 00.


I would like to express sincere appreciation for all the support and encouragement I have been given over the last year by the National Executive members, State Treasurers and my family.
