

**Australian Church Women Inc National Executive 2011-2013**  
**Minutes of Meeting held Monday 8 April 2013**  
**97 William Street Perth WA 6000**

1. **Welcome** The meeting was opened at 9.45 am by National President Major Laurel Pearce.
2. **Attendance** Laurel Pearce, Lee Edwards, Marie Majoor, Leeola Loughnan, Margaret Ker, Olive Dell
3. **Apologies** Donna Bryan, Meryon Goode
4. **Devotions (Leeola Loughnan)** Leeola led us in devotions centred on the Feast of the Annunciation.
5. **Minutes of Previous meeting (11 March 2013)** Confirmation as a true and accurate record moved Marie Majoor, seconded Lee Edwards.
6. **Business Arising** it was confirmed that the Travel Pool will be implemented for the National Conference. Units will be advised of either a requested contribution or the amount they will receive.

8. **Reports** *Written reports in the Secretary's File.*
  - **President (Laurel Pearce)**
    - From ACWC (Moon Sook) Thanks for update on ACWC Executive Committee Meetings in Perth.
    - From ACWC- Request for Country News for first issue of ACWC Newsletter.
    - From ACWC- Schedule of Executive Committee Meetings in Perth.
    - From Alan Jennings of Council of Churches W.A. – Rev Marie Wilson to contact Laurel re ACWC meeting with Council of Churches WA Executive.
    - Correspondence with Lee Edwards re seeing Angela McCarthy re Conference Bible Studies.
    - Advice from ACWC that some Executive Committee members because of flight times will need to arrive in Perth before 5 June and leave after 10 June. Laurel checked if Graceville units were available the nights of 4 June and 10 June and made a tentative booking of both units for those nights. Advised Moon Sook of bookings and of costs.
    - Contact with Moon Sook re Seminar on Child Slavery in Perth on 12 June (hosted by United Nations Assn and National Council of Women WA)). Moon Sook can attend.
    - Laurel received an invitation to the Lutheran Women's National Convention in Adelaide 18 /19 April. After consultation with National Executive members it was decided that if possible Laurel would combine the Convention with a visit to the South Australian ACW Unit. Laurel wrote to Unit President, Marion McCall who is happy for Laurel to visit. Arrangements have now been made.
    - From Nepal- Easter Greetings and thanks for prayers. Reply sent.
    - From Sri Lanka- Easter Greetings. Reply sent.
    - Meeting with Vice Presidents, Lee and Marie re Conference Timetable.
    - Contact with Lee and Leanne Smith re Young Women's session at Conference.
    - From Cora- ICFLC Executive Secretary- FLC Messages and Reports. Thanks sent to Cora.
    - To Moon Sook – Promise of prayer for all Koreans in the current political situation.
    - Meeting with Major Kaylene Robinson (WA. Secretary for Salvation Army Women's Ministries). The Salvation Army will print our Conference Working Papers and Minutes.
    - Correspondence with National Secretary and other National Executive members re various items of ACW business.
  - **Vice Presidents (Lee Edwards/Marie Majoor)**
    - Lee reported that she has prepared a roster at Conference for Daily Devotions.
    - She also consulted with Angela McCarthy and she answered my questions with the information: she would like an hour for the Bible Study each morning of the Tuesday, Wednesday and Thursday. She would then plan to remain for morning tea. On Tuesday morning she would accept our invitation to remain for the day. She would probably spend the time between morning tea and lunch on the beach, then be present for our Tuesday afternoon program including the High Tea. Angela also asked for information re the IT facility availability at Conference. Lee contacted the Retreat & Conference Centre and was told they were fully equipped – Lee passed their email on to Angela. After consultation

with Laurel and Marie Lee arranged with Angela for the three of them to get together with her on 29 April to discuss the Bible Studies.

- She also consulted with Elaine Ledgerwood re plans at Conference for the proposed input from the three applicants for last year's Young Women's Forum .Elaine is able to shift her work program to allow participation on the Tuesday morning. Lee will get back to her re the planned format once we had the timing arranged and the planning under way. Leanne Smith is able to come on the Tuesday [at least].
- **Secretary (Margaret Ker)**
  - Margaret apologised for slow progress with many tasks owing to family commitments.
  - **Conference Registration forms** dispatched, together with individual covering notes. The 'final' tally for Expressions of Interest is 45.
  - **Travel arrangements for our ACWC guests (and for Esther Kilagblian** The change in the visa system as from 23 March was not well timed. There may be some confusion locally over the new system. As regards Esther her letter of invitation (needed for her visa application) was lost in the post so a replacement needs to be sent by Express Courier.
  - **Finalisation of WCD order of service** After some delay while the issue of the Victorian Unit's application for the 2013 Special Project was resolved, the agreed wording for the ACT Special Project was sent to Victorian Special Days Convenor Elaine Johnson. Thanks to Donna who on her return home from overseas had worked hard to ensure the order of service reached us in time for our meeting. Guidelines time frame needs some adjustment.
  - **Constitution Revision** Very helpful responses from NSW,ACT and Queensland Units.
  - **Guidelines Revision** It is still hoped to send out a complete document (rather than a series of suggested amendments) with (or as part of) the Working Papers.
  - **From Inward Correspondence**
    - **Travel expenses for Public Officer (Item 21)** After discussion it was agreed that an ex gratia payment equivalent to half the air fares incurred by Public Officer Helen Raymond to attend the 2013 National Conference would be made.
    - **Travel Expenses Incoming NE (Item 33)** NSW Unit to be requested to arrange for National Treasurer- Elect to liaise with current National Treasurer regarding both the subsidy(Guidelines p.10) and the advance payable to NE Elect.
- **Treasurer (Leeola Loughnan)** *Circulated/attached*. Acceptance of report/ ratification of cheques moved Leeola Loughnan seconded Marie Major.
- **Winifred Kiek Scholarship Convenor (received from Meryon Goode, currently overseas)**
  - Meryon had sent as her report the letter she had sent to Unit Convenors. However information had subsequently been received to indicate some inaccuracies in the information circulated in good faith. After some discussion it was decided that to avoid any confusion the National Secretary should contact Units to request that the letter be withdrawn from circulation. After clarification updated information will be circulated as soon as possible. It was noted that communication with this year's Scholars is inevitably going to be difficult at times.
- **Fellowship of the Least Coin (Olive Dell)** It was noted that both 2012 project applications (Kidz Matta and Women Die Waiting) forwarded from Australia had been accepted. Thank you to the Victorian Unit for all the work they put in. We need to ensure that reporting requirements are met by both projects. This year no applications were received.
- **Special Days Convenor (Olive Dell)**
  - Olive thanked members for support during and after her recent operation, which went well.
  - She advised that a Special Project application from the Victorian Unit had unfortunately arrived just after she went into hospital. This was for Travellers Aid. As we had already approved a project it was too late to consider for this year, but Victoria discussed it and is happy to present it next year.

- Olive contacted NSW as the incoming National Executive regarding the Fellowship Day Service for 2014, asking if they would like to suggest the theme and advise ACT of same. They are happy to do so.
- WCD order of service received from Donna was discussed. Olive to follow up.
- **Social Justice (Laurel Pearce)**
  - Those who participated in the Slavery Free Guarantee campaign have heard that the Prime Minister recently announced a new Government Strategy “so that no firm providing goods or services to the Commonwealth is tainted by slavery or people trafficking anywhere in the supply chain”.
  - In the leadup to Easter the *Stop the Traffik* campaign focussed on the ethics of buying chocolate .We are advised to look for one of three certification labels on our chocolate bar or cocoa product. Major stores have at least one range of certified product. The labels suggested are the green label of the Rainforest Alliance, the Fair Trade label and the UTZ Certified label. These labels on a chocolate product mean that the cocoa beans in that product have not been harvested by trafficked children.   - AWC President, Sharyl Scott is back from holidays. It is proposed that the next AWC meeting should be sometime in May. AWC would like to know if members are able to attend a May meeting. Laurel forwarded the report to Jean Thomson, our alternate delegate to AWC, and asked if she could attend that meeting. She is free for most of May. No news of date yet.
  - Organization news requested to share with other members. Laurel will send a brief report.
