ATTACHMENT TO ACW NATIONAL EXECUTIVE MINUTES JUNE 21, 2004

ITEM 2.1 Letter from Lee Edwards (WA Unit) re ACW Website.

"We believe having a website is a good idea for information-sharing, and as a publicity tool for raising interest and hopefully getting new members. But it all depends on the cost.

A simple page should not cost a lot – with basic information. We thought it could well compare with the cost of brochures we already provide.

The decision needs to be considered in light of the over-all cost of publicity at National and Units level.

The information would actually not be for internal communication, unless it were a very sophisticated and updated version, which of course is expensive.

The site would be National not State-run.

We suggest the National Executive get back to Wendy Kiley and ask for the basic level she would suggest would be appropriate. We felt her contribution was very worthwhile."

**REPORT ON THE GENCO MEETING
HELD IN MYANMAR FROM 10TH TO 13TH JUNE 2004.**

The opening Service of the Genco Meeting was held in the Panda Hotel function room,

Moo Paw welcomed us and the welcome speech was given by the Rev. James Ngun Hlei (Associate General Secretary, Myanmar Council of Churches).

A candle was lit to dispel the darkness and fill us with love. The hymns "Spirit of the Living God" and "Joyful, Joyful we Adore Thee" set the tone for this happy service. Students from the Kayin Baptist Theological Seminary performed a Liturgical Drama about the women, who approached Moses for the right to inherit from their father. Moses asked God and God agreed and set the precedent.

The solo artist, was Angel Khine Zar Lwin, who sang "Hero". This little blind girl's voice filled the room with beauty and strength.

Reports were given from each National Representative. In many countries women still strive for equality both in society and in the church. Mostly Christians are a minority but they work to raise the status of women, to prevent family violence and to improve education opportunities for the underprivileged. Many also work towards peace and to support those displaced by war.

Yasuko explained our financial situation and let us know that the 2006 General Assembly has a budget of US\$150,000. This seems enormous, but some will come back in Registrations. However the bulk will be for airfares. Consider the cost of about 90 airfares to Malaysia from around Asia. Any fundraising will be welcomed. If we can afford it, we might think of some ways to raise money in our own countries for ACWC.

Yasuko Nakayama and Ester Byu took charge of a workshop concerning the joint celebration of the ACWC General Assembly and the ICFLC 50th Anniversary. We broke into groups to discuss **Fundraising, Programming and Bible Studies**. ACWC and ICFLC have a special connection as mother and daughter, so we need to celebrate together. Our worksheets will be considered and ideas taken to the planning meeting of ICFLC later this year.

We had a half day tour of the Zoe Women Development Centre, the markets and Shwee Dagon Pagoda.

In the Women's Centre, girls are given Nurse-Aid Training; Domestic Worker Training; Sewing and Embroidery; English Proficiency; School Teachers Training and given other courses. Some of their goods were on sale at very good prices.

The markets in Yangon are so full of bargains that we had trouble getting our National Representatives back to the bus but finally were able to visit the Pagoda. This is very splendid and very large, so that we could have spent much more time there if it had been available.

2/. We were made so welcome in Myanmar. Ester pointed out that no Women's Ecumenical Group had ever been able to visit Myanmar. The Christian people felt so honoured by our presence. We also felt honoured by the warmth of the Myanmar people.

REPORT ON THE GENCO MEETING HELD IN MYANMAR FROM 10TH TO 13TH JUNE 2004 (Ctd.).

Projects will be open again for 2005. They will be decided subject to money being available and countries will be able to support any project that they wish.

One Scholarship was granted to Myanmar and another for India is waiting for an educational budget to be provided.

Later this year, Shu-Wen will do a self evaluation to allow her to tell us of her vision as ACWC Executive Secretary. ACWC will allow up to US\$1,000 for Leadership Training for Shu-Wen for English Classes or Speech Therapy as required. Her contract will come up for renewal by the next General Assembly.

Another workshop was held on the issue of ACWC Day. Since the ICFLC Theme for their 50th Anniversary is "Celebrating the Legacy, Visioning the Future, Living the Jubilee" we will use parts of this theme for the themes for ACWC Days in the next three years. The Liturgy will be prepared by :-

India	in 2005	"Celebrating the Legacy"
Philippines	in 2006	"Visioning the Future"
Japan	in 2007	"Living the Jubilee".

Korea will prepare the Liturgy in 2008.

On the Sunday we were divided up into groups to worship and give greetings in ten local churches. I was able to visit the U Naw Burmese Baptist Church, named for U Naw the first Christian convert in Burma. Rev. Toe Toe Latt made me most welcome and I met Daw Mya Kyi again. The singing was beautiful and I was asked to stay for the afternoon service, which was "Parents' Day". This was very enjoyable with many young people singing and playing music for their parents. The guest speaker was the Methodist Bishop, who talked about his experiences living in Rangoon during World War 2. "Aunty" Mya Kyi interpreted some of what he was saying for me.

Let us bless Myanmar every day and bless each other. At the beginning of this visit we were praying for Bela and Atola, who had visa trouble and hadn't been able to be present. But both arrived in answer to our prayers. Every country was represented. Thanks be to God.

**REPORT ON THE ACWC EXCO MEETING HELD IN MYANMAR FROM 8TH TO
10TH JUNE, 2004.**

Moo Paw and her ladies met us at the airport and made us very welcome. We were installed in the Panda Hotel and celebrated as each member arrived. It was lovely to meet up with Ester Byu, Executive Secretary of ICFLC and also a member of our Executive Committee.

Annam told us about her meetings with the Council of Churches in Malaysia and her attendance at many conferences both in Malaysia and overseas to represent ACWC.

Yasuko brought us up to date with our finances and spoke of the US\$150,000 budget for the 2006 General Assembly, which we will hold together with the ICFLC 50th Anniversary. Some of this money will come back in registrations but a lot of it will be needed for airfares.

Shu-Wen has been in contact with women in Vietnam, Cambodia and Laos and it was decided that the 2005 Exco meeting will be held in Cambodia if we can combine it with a meeting with the women of the three countries.

Mongolia also wants to learn about ACWC and to set up an Ecumenical women's association so a visit will be made to them in early 2005 by Annam and either Usha or Yasuko.

It was decided to trust in God and plan for projects again in 2005. They will be subject to money being available and we will encourage countries to be involved with funding them.

One scholarship was approved for Naw Thwe Sah of Myanmar for US\$400 per year for 2004 and 2005 subject to an educational budget being provided. An application from India for Miss Implisongla was held until a budget can be provided.

The Executive Committee was hosted for dinner by Daw Mya Kyi, former member of ACWC, who had a banner from the 1962 Assembly in Thailand. She spent six months planning this special dinner with all of her favourite foods. The dinner was beautiful but we enjoyed the company of this very special lady much more.
