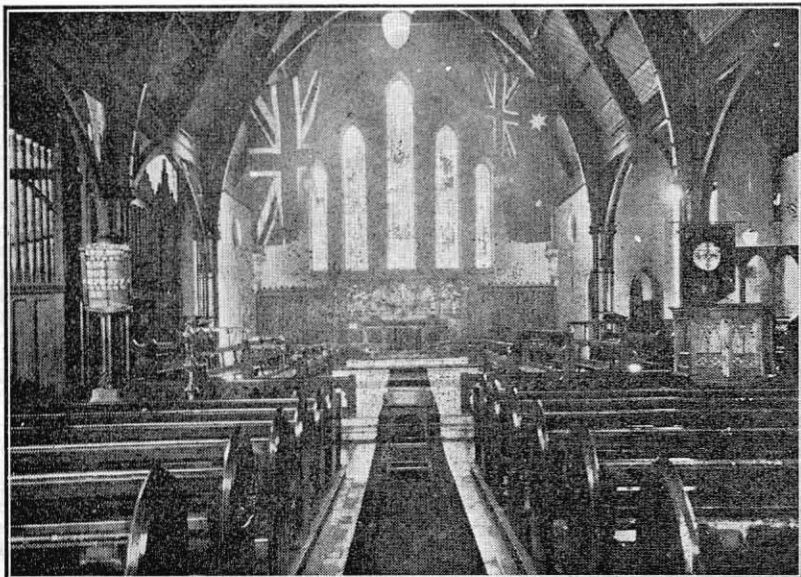

### THE RECTOR'S LETTER

---

All Saints' Rectory,

25th February, 1950.

Dear People of All Saints',

In Hubert C. Libbey's book "The Eight Deadlier Sins" (which is the Bishop of London's Lent Book for 1950) the author pictures a sixteenth century visitor coming to the British Isles today. He is proudly conducted round the several temples of art, industry and learning. "The libraries, the British Industries' Fairs and the Research Stations—to mention but three from the outstanding glories of man, might easily leave the 'benighted' visitor speechless. The proud guide, to break the oppressive silence, would ask, 'What have you to show that is even remotely comparable with all this?' Timidly and bashfully he would reply, 'We have some budding literature and some paintings and . . . oh! I nearly forgot these . . . we have some Cathedrals dotted up and down the country, but they were erected to the glory of God. They are really a poor affair, when one considers Him to whose honour and glory they were built, not half good enough.'

"The 16th century visitor returns to his contemporaries impressed by all he saw and heard, but on relating his experiences, some disquieting misgivings cloud his story. 'All very wonderful,' he thinks, 'but the glory of Man rather than the glory of God is the dominant feature of the new age I have just witnessed. The achievements are without question astounding; but man having gained the whole world, has lost his soul: at least he has lost God, and this amounts to the same thing. The gain is more than off-set by a tremendous loss. If man had but seen and glorified God in and through all his discoveries, if man had accepted them as revelations; if every temple of art and learning had been the Temple of God, wherein He was worshipped and adored; why, then, this twentieth century I have visited would verily have been the golden age. It glitters, but alas! it is tinsel!'"

At the beginning of the Season of Lent, this warning comes with renewed intensity. We are so accustomed to living in an age when discovery follows discovery and invention piles up on invention with such rapidity, that we have almost lost our capacity to wonder at anything. In the light of all this new knowledge, we ought to be able to see the glory of God as no other age has ever seen it; yet so many fail to see God in it at all. Trying to be good by our own unaided effort is quite futile, and trying to be a Christian in our own strength will never get us anywhere. If, then, we cannot manage our individual lives without some power greater than our own, how can we expect to find security and the power to satisfy the real needs of mankind, without God? Lent again calls us to examine ourselves to see whether we are really alive to the menace of everything that leaves God out of life. The splendid words of our daily Lenten prayer, "Create and make in us new and contrite hearts" are still fundamental.


We again ask your co-operation in the matter of our Lenten gifts for the extension of Christ's Kingdom through the work of the Australian Board of Missions and the Church Missionary Society. Bearing in mind the great opportunities facing our Missionary Societies, and realising how they are handicapped by rising costs, we are prompted to ask "Could YOU increase your Lenten self-denial gifts this year? At any rate, will you try to do so?" Boxes and envelopes are available.

We are again grateful for the excellent response for Harvest Festival. The gifts included a great number from the Kindergarten and Senior Sunday Schools, offered at the Children's Festival Service. We thank ALL our parishioners, who, by their kindly and willing co-operation made the Festival a day of real Thanksgiving. We appreciate the efficient work of the Choir; the very artistic decoration of the Church for which Mrs. Morris and her many helpers were responsible; and Miss E. Olofsson, for the Sanctuary; and we do not forget the practical assistance of Norman Harris and Ken Grant in transporting all our gifts to the Home of Peace where they were most thankfully received.

Bishop G. H. Cranswick was the occasional preacher at the morning service of our Harvest Festival, and was also the Celebrant at the early Celebration. He was amongst those who so kindly came to help a literally lame dog over the stile of his indisposition, including the Bishop of Tasmania (Bishop G. F. Cranswick); the Revd. F. C. Bastian (who is on his way to missionary service in the Diocese of Polynesia) and Archdeacon C. S. Robertson, Chairman of A.B.M. I am most grateful to them all, and to those upon whom additional work has fallen during my enforced absence, particularly to our former colleague, the Revd. A. E. Gardner, whose presence in Sydney was most timely. He takes with him our very good wishes as he leaves for his new work.

The April "Chronicle" will be ready on Palm Sunday, the first day of Holy Week. Notice of the services for that week and for Easter Day are therefore included in this issue.

#### MATTERS MAINLY PAROCHIAL

On Ash Wednesday, members attended the evening service and this was followed by a short business meeting.

Thursday, 9th March, there will be a Rally in the Chapel, at 3 p.m., when the speaker will be Mrs. F. O. Hulme-Moir. All women of the Parish are welcome, whether they are Guild members or not.

Monday, 13th March, will be the next Sewing Day at the Home of Peace and we hope members and friends will go either for the whole or half day.

**Sunday School.**—Both Kindergarten and School responded to the Harvest Festival appeal with enthusiasm and brought a goodly contribution to the thank-offering of the congregation to our Heavenly Father. The children now have their Lenten boxes; will you pray that even the tiniest may learn to give in self-denial? These Lenten offerings will be devoted to the work of the A.B.M.

**Lenten Music.**—Fletcher's Cantata, "The Passion of Christ," will be sung on Passion Sunday Evening, March 26, by All Saints' Choir, in association with the visiting soloists, Ronald Dowd (Tenor) and Murry Lewis (Baritone). It is hoped that our Choir may be augmented for the rendering of this work. We commend this special service of appropriate Lenten music to all parishioners and friends, in the hope that they will make it widely known throughout the parish, and bring others with them on March 26, at 7.15 p.m.

"The Passion of Christ" was written and published in England by Percy Fletcher, in 1922. It has been sung but twice in this church, namely, in 1924, and in 1942.

The Cantata is a meditation upon the cause and significance of that event which, nearly two thousand years ago, divided the stream of human history and turned it from uncertainty, suffering and hopelessness into faith, sacrifice, and triumph at the last. In the Cross of Jesus is set up the Throne of Grace, whence love, purity and righteousness flow, transforming earthly authority and society into the Kingdom of God.

The work reverently reminds us of the Divine Suffering wrought by human sin and the redemption of man wrought by the Crucifixion of Jesus. The Mortal is here confronted with the Eternal: the fulfilment of the strangest prophecy of Jewish record gives new hope to all the world. Despised and rejected of men, Jesus, bearing the iniquity of us all, in bitter pain and lonely death, sacrifices His life that the love of God might reign among men. The Cross is transformed into a throne, darkness into light, and death into life by God's Almighty Power, and all mankind brings homage, worship and adoration to Jesus who is God and King.

**Parish War Memorial.**—At the last meeting of the Parish Council, it was revealed that our General Fund was drawn upon to the extent of over £28 to defray the cost of our Parish War Memorial. Owing to initial delays, over which we had no control, steadily rising costs affected the original estimate. We thank those who gave so generously, and we are not even suggesting that they should give more; but there may be some whose relatives' names appear in the Book of Remembrance, who have not yet given, and to them we would point out that the fund is still open. The Memorial has been greatly admired; one visitor recently described it as "the most dignified Parish War Memorial he has seen, and quite unique in the Church in Australia."

**The Ritchie Memorial.**—All Saints' people generally, and senior Choir members particularly, have happy memories of Doris Ritchie, devoted chorister for some 20 years, and efficient Choir Secretary, 1937-48. Doris requested in her will that a mural tablet be erected in All Saints' in memory of her parents. This tablet, to which her own name was added, was unveiled and dedicated by the Rector in the presence of members of the Ritchie family and the members of the Choir on Sunday morning, January 8th, during a Choral Celebration of Holy Communion, being the corporate Communion for members of our Choir.

(The above was held over from February, owing to lack of space.—Ed.)

**District Visitors.**—We regret that Mrs. Robertson is still unable, through ill health, to resume the work she has done so efficiently for so many years. We pray she may soon be restored to health and strength.
