Registration Forms \$40.; \$25. to Bursary (WK Trustees)
Report and a/c's for payment moved J. Cooper, sec. J. Stott, carried.
Disaster Fund - D. Clack moved that \$500. be sent to the Kobe Fund c/- Japan Council of Churches, and that a letter of advice be sent of Mrs. Kimiko Ibaraki, sec. J. Stott and carried. Members voiced concern and difficulty in administering this fund, e.g. justice in our estimation/considerations and responsibility in making judgments.

Fellowship of the Least Coin : Both Australian applications have been approved; applications for 1995 grants need to be in the hands of the National convenor by April. Circle of Prayer booklets not yet to hand. New FLC leaflet from Shirin Samuel - we are to order 2,500 which are required by July. There is room on back to add name of State Convenor.

Winifred Kiek Scholarship : Background papers regarding changes to Constitution to be to hand shortly.

Special Days - The Convenor asked for suggestions for a theme for the 1996 Fellowship Day Service. World Community Day 1995 - Three worthy projects were considered : Laos Evangelical Church - both medical and vocational centre buildings require equipment; Christian Radio Missionary Fellowship - provides contact in remote areas of PNG; and assistance to refugees in Raiwind province of Pakistan. H. Boatman that the project assist the Laos Evangelical Church, sec. M. Dodds, and carried. It was suggested that the countries of the remaining applicants be encouraged to apply for a F.L.C. grant.

A.C.W. "News" : L. Green advised the February/March issue was ready for the printer. Editor for the April/May issue will be Mrs. Barbara Lacy, 11/12 Sydney Street, Cheltenham, 3192, and copy may be forwarded NOW.

A.C.W.C. : Australian rep., L. Green, advised that contributions to the Asian Church Women's Bulletin be in the hands of the Executive Secretary, Mrs. Iluminada Domingo, 857 Int. E. Esteban Street, Dalandanan, Valenzuela, Metro Manila, Philippines, by the 15th of every second month of each quarter. It is hoped the Bulletin will become a forum for discussion.
