9. Reports


- 1) **FLC** - Towards the end of January Jan reported receiving a parcel from ICFLC containing 733 money boxes. Due to orders from Victoria and the ACT "Circles of Prayer" stocks are now depleted until the next printing, but some flyers on FLC and prayer cards are still in stock.
- 2) **WKS** - One of the WK scholars, Inise Foiakau visited Canberra in early February and President Jean and Constance were able to share a short time with her. Christine Ferguson at Victorian Bible College has also been in contact. On 4 February the first letter for 2009 was sent to all convenors, enclosing copies of recent emails from students. Imelda's graduation is to take place on 2 April 2009, but she is unlikely to attend due to her work commitments in Dubai.
- 3) **Special Days** -
 - a) *Fellowship Day Service* – master sheets to be forwarded to ACT/States Units last week in February.
 - b) *World Community Day Special Project* – consideration to be given to possible recipient(s) (as presented by Special Days Convenor). - 4) **Social Justice** – Judith-Ann reported on a successful "Uplift Campaign" supplying undergarments to women in Fiji. She had received a reply to her letter to the PM from Jan McLucas, Parliamentary Secretary to the Minister for Health and Ageing, regarding food labelling and genetically modified foods. Two books were enclosed "Choosing the Right Stuff" and "GM Foods".
- 5) **Publications** – Eileen advised that items for the next Newsletter should be with her by 13 March 2009 please. More information will also be included on the National Conference.
- 6) **ACWC** – Donna has received an invitation to attend an ACWC Committee meeting in Korea in April.
- 7) **Website** – Brenda will be asked to update the ACW web page with information on the Conference and Angela will attend to this in the near future.
