The audit opinion expressed in this report has been formed on the above basis.


Independence

SPECIAL DAYS

Our Special Days services continue to provide opportunity for ecumenical fellowship, worship and study of the Word for Australian Church Women throughout our State and indeed throughout our Nation. The reports I receive from these days repeatedly give testimony to the blessings received through coming together as the community of Christ.

The Special Days during 2015 expanded the theme of the NSW National Executive which took office in October 2013, namely, *Building in Harmony*. The topic for Fellowship Day was *Building In Line With God's Design*. This service had been prepared by the Tasmanian Unit of ACW. Thirteen services were held throughout the state with a total attendance of 493. The topic for World Community Day was *Building For Peace and Reconciliation*. This service had been prepared by the Queensland Unit of ACW. Twenty services were held across the state and there was a total attendance of 663.

The Special Project supported at World Community Day in 2015 was submitted by the NSW Mosman/Neutral Bay Branch. This submission was for **Cana Communities** based in Sydney. This group builds relationships, and companions people who are lonely, homeless, suffering from mental ill health, addiction or other factors marginalising them from mainstream society. It has operated for 40 years with no Government funding. The project funds will be directed to their Nagle House, in Redfern Sydney, for marginalised women.

The NSW Unit was very pleased that their submission of the application to National Executive was successful. A group from Cana Communities attended an afternoon session at the National Conference held at Collaroy NSW in September 2015 and gave a presentation of their ministries. Everyone was most impressed with the work being done and justifiably pleased that this group would be the recipients of our Special Projects funding.

Sincere appreciation is expressed to the members of all branches for their diligence and faithfulness in organising each Special Day. It is my prayer that these times of ecumenical fellowship will always be a source of spiritual refreshment.

SOCIAL ISSUES ANNUAL REPORT 2016

During the last 12 months our members have been challenged to lobby on a variety of issues at both Federal and State level. Some of the areas focused on were domestic violence, the treatment of those seeking asylum and the consequent assessment of their refugee status and the radicalisation of young people in the Muslim community.

Our concerns have included the proposals being promulgated in the push for same-sex marriage in a community such as ours where the constitution is patently based on Christian ethos and on issues which involve a belief of the sanctity of human life.

More particular lobbying has been targeted at the drug-taking uncovered in the transport industry and the failure of some parents to immunise their children.

We have also written to congratulate Governments and individuals on their proposals and planning in certain areas. Thus we contacted the Victorian Government to applaud them for abolishing time limits on the reporting incidents of childhood sexual abuse and the subsequent legal proceedings against the perpetrators.

We will continue to exercise our democratic right to express our desire to see justice reign in our land.

We give thanks for our previous National WKS Convener, Nancy, and look forward to connections with new Convener, Loyola, in the Victorian National Executive.

With Nancy's emailing, we heard from Tonu (Fiji 2010) now married and in church ministry, Rachel Otto (McManus, QLD 1997), Imelda Aquino (Philippines 2008), Inise (Australia 2009) and Lou Momorou (PNG 2013). All are doing well. Leinamau (Vanuatu 2007) enjoys regular email contact. She continues further studies at Fiji Theological College. Christy Ferguson (Melbourne 2009) also gives regular email newsletters and is to do annual short term trips to her previous mission area overseas with her Mission Agent. Caryn Rogers (SA) is continuing studies and research for her PhD in Linguistics helping with the revival of an Indigenous language on the Eyre Peninsula; also balancing studies, work and ministry.

Regular reports have been given for Newsette. Some encouragement with Christmas cards and emails were sent when contact details were known. Replies were received from past scholars Doreen Tie (1990) Mary Au (1980) Nighat Gulzar (1994). Many past girls were saddened by the passing of Mina Whybourne, a past NSW WKS Convener. The NSW Unit supports the Honouring Australian Church Women Fund. We look forward to news on the 2016 scholar in Vanuatu, Mrs. Esline Toamavute. She intends to study at Taulua Ministry Training Centre to develop leadership skills to pass on to women she ministers with around her local islands. Esline has been very involved in areas of women's ministry including networking ecumenically. Past scholars often give thanks for our partnership, feeling the prayer support and encouragement.

NATIONAL COUNCIL OF WOMEN OF NEW SOUTH WALES INC.

As your representative to the National Council of Women of New South Wales (NCW), it gives me great pleasure to present the Annual Report for 2015.

NCW commenced the year with their "Celebrate Being an Australian" Luncheon in the Strangers' Dining Room at Parliament House on January 22nd. Our Guest Speaker, Nancy Serg OAM, spoke of her experiences in assimilating into post war Australia, whilst helping other migrants from Malta.

As part of the celebration, NCW awarded fourteen meritorious women, nominated by their University Faculties, with a Certificate and a cheque for \$1,000 donated by sponsors to support them in their further studies.

On Saturday, March 28th, our President Nola Barkl hosted an Afternoon Tea at her home, attended by Presidents of affiliated organisations. At this function, the new NCW logo was launched and displayed on a roll-up banner.

The Jean Arnot Memorial Luncheon was the next major function, held in May in the Strangers' Dining Room at Parliament House. The Jean Arnot Memorial Luncheon honours women in their nineties who have worked for their communities over many years. Our Patron, Mrs Linda Hurley, wife of the Governor of NSW, presented Certificates of Appreciation to 16 nonagenarians, one of whom was our member, Marie McCann OAM. The Guest Speaker was Hon. Susan Ryan AO, Age and Disability Commissioner.

In August, the National Council of Women of NSW celebrated its 119th Anniversary with the Foundation Day Luncheon at "Cellos Restaurant", at Castlereagh Boutique Hotel. The Guest Speaker was Virginia Howard, chair of Taldumande Youth Services Inc. Recognition Awards were presented to five women nominated for their untiring contribution to the community and who had not received official recognition.

Dame Professor Marie Bashir, AC CVO, the former Governor of NSW, presented the 6th Marie Bashir Peace Awards in September to five senior high school students from both metropolitan and country schools. The recipients received a Certificate and a cheque for \$250 for promoting peace

and harmony in their community. Their schools also received a Certificate. Three other students were presented with Highly Commended Certificates.

In October, five NCW members attended the NCWA Conference "Celebrate Cultural Collaboration" in Melbourne. It was a very interesting and informative time, and good to meet with members of other state councils.

NCW continues to hold a Morning Tea for members and friends on the third Wednesday of each month in The Upper Room Café at the Wesley Centre, Pitt Street, Sydney at 10.15 - 11.30am.

In 2016, the Council meetings held on the last Thursday of the month at the Sydney Mechanics Institute, 280 Pitt Street, Sydney will commence at 4.30pm, with a Business meeting, followed by a short break for refreshments, then with a Guest Speaker at 6.00pm.

Also in April, we had girls attend KYCK (youth conference) at Katoomba. The conference is where all youth organisations, Church Youth Groups come together and worship in God's name and create friendships.

On Saturday 2nd May, GB NSW had our Annual State Conference where we celebrated 75 years of Girls' Brigade NSW. The theme for the conference was 'Built on a Strong Foundation'.

On Saturday 13th June 400 girls, leaders and their families celebrated the birthday of GB NSW with the animals of Taronga Zoo. GB NSW has also adopted a Pygmy Hippo from the zoo for 12 months.

In August, Girls' Brigade NSW was invited to attend a morning tea at Government House for International Youth Day. On the day, we met

the Governor of NSW His Excellency General the Honourable David Hurley AC DSC and his wife Mrs Linda Hurley, who is GB NSW State Patron.

In October we had our National Conference, which was held in Newcastle NSW. It was a 3 ½ day conference and everyone who attended was refreshed and strengthened. At the Conference we voted on major changes to governance structure and begin the process on writing a new constitution. Also we had elections for the positions of National Commissioner and Deputy National Commissioner and Deputy National Commissioner.

In November two girls received an invitation to be part of a reception at Government House to meet Prince Charles. The girls were very excited and felt honoured to represent Girls' Brigade NSW. Throughout the year, we had Pioneer Leadership Training, where girls learn leadership skills that they can use for GB and in the community. Also we had Leader Training for ladies; this was great to see women called to serve as new leaders in GB.

GB NSW are had a fundraiser called the TWO CAN project. This is where all GB NSW Companies are collecting money (5 cents, 10 cents or \$2.00 or notes) in cans. The money raised goes towards GB NSW Company support fund (ONE CAN) and the money raised in the other can will go towards our sisters in PNG Girls' Brigade.

Four times a year we have our State Councils meeting (one of them is our State Conference). At these meetings we have time to grow our spiritual walk, fellowship with others and we have business sessions.

Also this year we had a new Company in Bel Air. They were affiliated in March. It was a great day had by all who attended. During the year the 'Brigade Affect' newsletter were sent to GB Churches. In the newsletter we have articles about how GB has impacted and transformed the lives of girls, leaders, families and churches.

It has been great being able to come and let everyone know how Girls' Brigade NSW is going.
