**REPORTS**

1. **Fellowship of the Least Coin** - Convener Margaret Greenslade

Orders have been placed for 25 copies of FLC History Book, "Many Prayers, One Prayer" and for 750 copies of "Circle of Prayer" Vol.15. Final cost for each of the publications has not been received - it would be helpful if these and the "Shanti Solomon Story" cost were received and paid for by 30th June this year (GST) but I don't know if this will be possible.

Applications for FLC Grants have been received and are presented for approval by this Executive before they are submitted to International Committee for the Fellowship of the Least Coin (ICFLC) for consideration. 4 are supported by NSW Unit & 1 supported by SA Unit.

From NSW - (1) Parent Support Group at Woolloomooloo, US\$6000

(support for children and parents where parent/s are on a Methadone programme and/or suffering substance abuse, previously or currently involved in sex industry or where other special needs exist.)

(2) Special Religious Education Teacher in High School - Tumbillimbi, NSW, US\$6000

(3) Youth Pastor - Berkeley Vale, NSW, US\$6000

(4) Provision of Jointly Owned Motor Powered Canoe, Western Province Solomon Is., US\$6000

From SA

(1) Facilitating Faith Community Nursing in WA, US\$32000

- a. Introducing Faith Nursing to Christian nurses in WA through ecumenical seminars (city & rural)
- b. Later in year conduct 5-day educational programme in theology & the practice of faith community nursing in WA,

The Applications for Grants were accepted for forwarding to ICFLC providing the group supporting No.(4), in NSW can get the relevant people in the Solomon Islands to be the supporting group (to be within the ACW Guidelines).

I support the purchase of a Fax machine so that the FLC convener has access to it when contacting Asia and the Pacific Islands.

**2. Social Justice - Convener Mavis Ellis**

I wrote to Hon. Dean Brown & Hon. Nick Zenophon regarding the recent conference in Adelaide on Gambling. Rev Christine Ostle, UCA SA Synod Social Justice Consultant, thought they were the appropriate ones. In response to my last letter to Unit Social Justice conveners, Heather Reid, NSW convener, replied enclosing copies of letters she had written to NSW politicians re gambling. Interestingly, the only reply she had received at the time of writing was from the leader of the Opposition. I intend to send her the centre-spread from the UCA SA "New Times" which features an article by Stephen Richards from Adelaide Central Mission, chair of the SA Heads of Churches Task Force on Gambling. Heather has also written to the Ink Group concerning undesirable Christmas Cards enclosed in packs of religious cards.

I also wrote to the Director of the Equal Opportunities for Women in the Workplace asking to be deleted from their mailing list.

Vera Wilson, WA Convener responded to my get well letter and the only other response was from Dorothy McMasters, ACT, who had not been able to get any World March for Women 2000 postcards in ACT so I have arranged to forward some to her.

I received a request from the SA Council of Churches to write five letters to various people in Rwanda, the Human Rights Watch in London, the Human Rights Commissioner in Geneva and our own Minister for Foreign Affairs re the plight of the son of a Rwandan Minister serving in the UCA in Adelaide. The son had been imprisoned on false charges but the good news just to hand is that he has been released and returned to his wife and two children. He now intends to try to leave Rwanda where law and order are almost unknown. I received a reply on behalf of Mr Downer.

On 24th May, 7pm, YWCA, 17 Hutt St, Adelaide, Carmel O'Loughlin & 3 women who attended 44th UN Com. on Status of Women, will speak on 'The Rights of Women - Obstacles & Achievements'.
