travel) who also have agents in India; they will negotiate for a reduced fare. Australian inter-state travel could be done separately. A rough estimate for total fares would be approx. \$3500. Dorothy Haensel has indicated that there would be approx. \$10,000 available for the 1991 scholarship.

Visa: A 3-months tourist visa gets cheaper fare. Rachel should get a 12-months tourist visa as she will not be earning money. (The State Units should be offered payment for accommodation at suggested rate of \$100 per week.)
