2. Visit of the American Church Women.

Mrs. Galebraugh commented on the success of the visit and the fellowship enjoyed with members of all churches. Greater interest had been shown by women of the Church of England and Salvation Army than formerly.

It was decided that an invitation to affiliate with the Women's Interchurch Council be sent to Deaconess Andrews, for the Church of England women, and to Lieut. Col. Mabel Bell, for the Salvation Army. (Miss Miss Diarmid)

Mrs. Pearson urged that women of all churches should get together for Bible Study & discussion more often. It was decided that a meeting for this purpose be arranged, the executive to find a suitable
