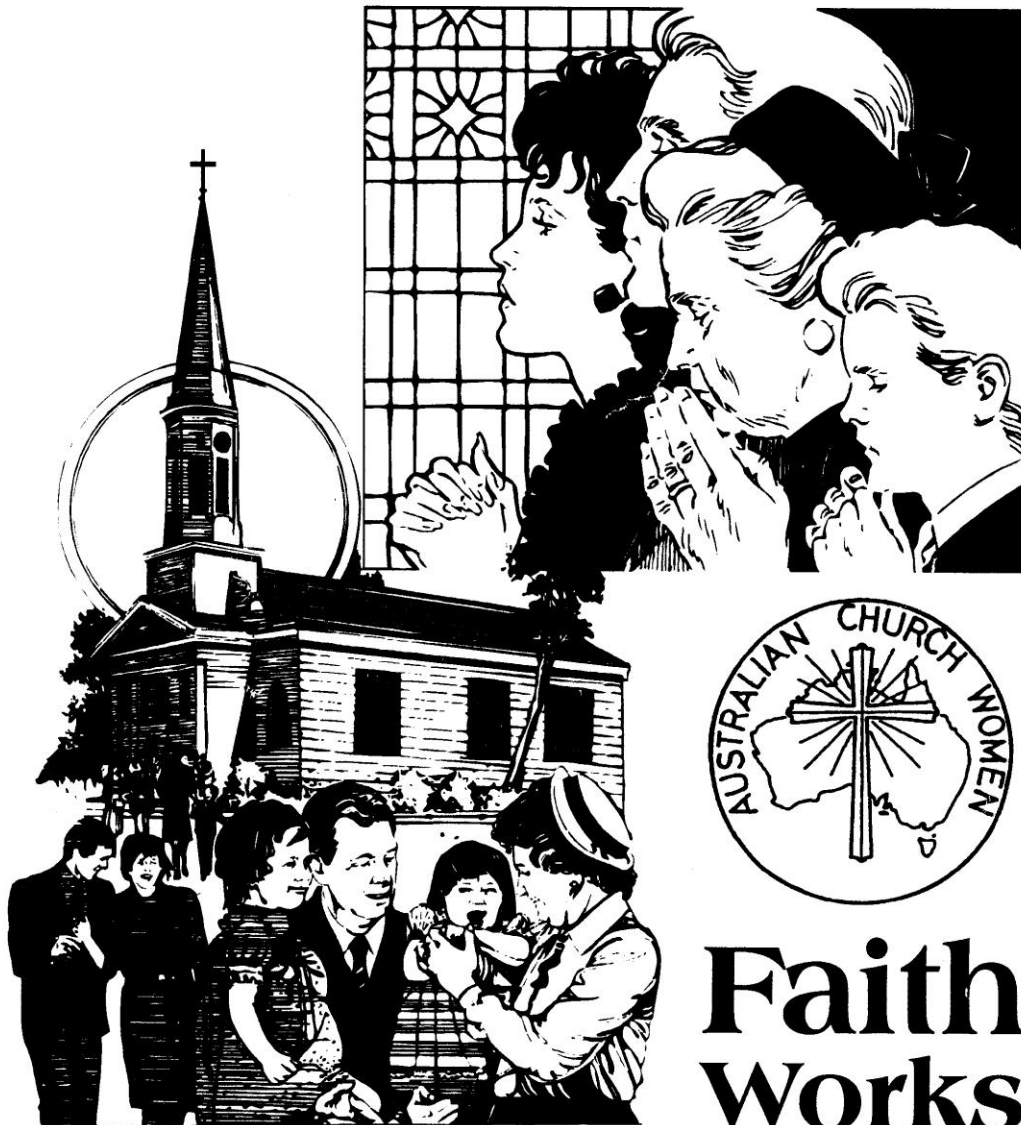

Secretary: Margaret Florence presented her report, and drew our attention to para 6 and thanked the Conference for the privilege of attending this Forum. Carried with applause.

Treasurer: Joan Trudgian - Held over to next Business session.

F.L.C. Convenor: Mollie Jean Hunt presented her report .

Janet Abrahamffy, ACT Unit asked if the Green and white FLC badges would be available again? Reply – 30 stick pin type are available, the new style are the usual brooch type and are available now. The cost of the Green/white design seemed extreme. Encourage the new Executive to look into the supply of the Green/white style. Re the Somali sewing women —They received the grant and employed a Tec teacher, which not only helped the women but the whole family to learn English.

**99/10 *Memorial Minute to Shanti Solomon (Founder of F.L.C.)***

Mollie Jean Hunt – It is my pleasure to move this Memorial Minute to Mrs Shanti Solomon, a very remarkable woman of both vision and inspiration. Her dream of the amassing of every woman's Least Coin being able to provide assistance in the betterment of conditions for her sisters, has proved a most rewarding movement. We thank God for her life and for her energies on behalf of the Fellowship of the Least Coin, a Global Movement of Prayer, Peace, Justice and Reconciliation. Seconded by Margaret Napier W.A. Unit. Carried

Special Days Convenor: Val Van de Wiel presented her report.

Conference delegates were asked if the large print Order of Services were being used. As there appears to be more support for them, than against, this service will continue.

Publications Editor: Miriam Pratt presented her report, and was applauded for the excellent production.

Treasurer: Joan Trudgian presented her report.

She shared her concern of the cost of ACWC Bulletin to National Executive.

**99/11 *Motion*** - After some discussion, Margaret Napier (WA Unit) moved that free copies of ACWC Bulletin to each unit be discontinued, and that each unit be encouraged to purchase their own. Seconded by Beth Skilbeck (Vic) Carried.

Barbara Lacy, ACWC Representative, intimated that ACWC are considering producing only two (2) Bulletins, and a newsletter per year, and she will let us know as soon as a decision is made.

Joan then drew our attention to para 8 of her report re percentages taken out of offerings and contributions to cover administration costs.

Much discussion then followed. Several speakers voicing their concern that monies given in offerings for F.L.C. have a percentage taken out for administration costs. Others reminded us that we need to pay for the cost of promotion etc. to do things well. Esther Byu, Executive Secretary International Committee, Fellowship of the Least Coin told us that other Countries also take out a percentage to cover costs of administration and promotion. It was agreed that a motion to clarify what percentage to take and for what purposes be put at the next business session.

Rev Jenny Tymms was the guest Preacher, her address was titled “Faith is the assurance of things hoped for, the conviction of things not seen”. Representatives from Local Government and Heads of Denominations and affiliated groups joined together with Conference delegates and observers and local men and women to praise and worship our living Lord. A highlight of the service was the procession of State and Territory Unit Banners into and from the Church. A copy of the Order of Service is held by each Unit. A Luncheon for 150 participants and guests was held after the service in Wesley House, which is adjacent to the Church.

**CONFERENCE SESSION 4**

Treasurer: **Motion** – Joan Trudgian moved

**99/12 a.** That the National Executive and State/Territory Units deduct an amount  
not exceeding 10% from Fellowship Day and World Community Day offerings  
for administration costs, until the next Conference.

**99/12 b.** That the National Executive and State/Territory Units deduct from  
Fellowship of Least Coin offerings, **only** the costs pertaining to promotion and  
administration of the Fellowship of Least Coin, until the next Conference.  
Seconded by Yvonne Sullivan, ACT Unit, who then spoke to the motion.

Dorothy Wright, SA Unit spoke against the motion – if we take less from the FLC  
offerings it means less for administration and the need to take more from the other  
offerings.

Ailsa Skippen, Nat. Exec. Reminded us that since Interest rates have fallen on any  
monies invested, we need to take the full 10% to cover costs.

Janet Abrahams, ACT Unit asked is it possible that the promotion and costs for  
FLC could exceed 10%? Answer, Yes, but not likely.

Heather Reid, NSW Unit, against part b, as a Unit could spend much money on  
glossy productions if there is no limit.

Helen Lloyd foreshadowed an amendment to section b.

**99/13 Motion** – That the words, “and not to exceed 10%” be added before the words  
“until the next Conference.” To section b of motion 99/12.

Dorothy was asked if PNG is part of Pacific Region – Answer, Yes.

## FAITH WORKS

We don't think of Faith seriously until we are struck by tragedy, disaster, calamity, illness, loss, separation; endangered by conflicts, wars and uncertainties, or when things get out of our hands or our control. We would rather depend on and trust our own ability and strength as long as we have something to hold on to and think we can control things ourselves.

Faith is a gift to those who realize their own weaknesses and limitations; who are willing to depend on the Divine power, the power which is beyond their comprehension.

It is a hopeful response to God's faithful promises; God's saving Grace and Act manifested through the life, the Ministry, the Death and the Resurrection of Jesus Christ.

It is a powerful healing source which is used by God in restoring wholeness to human beings and to our communities. Jesus always recognized and affirmed the faith of those who came to him for healing. We find such evidences in the Gospels. Let us look into some.

After hearing a plea from a Roman Officer; begging Jesus to heal his sick servant, Jesus said to the people who were following him, *"I tell you, I have never found anyone in Israel with faith like this."* (Mtt.8: 10). Then, Jesus said to the Officer, *"Go home, and what you believe will be done for you."* And the Officer's servant was healed that very moment. (Mtt.8:13)

A woman who had suffered from severe bleeding for twelve years came up behind Jesus and touched the edge of his cloak. She said to herself, *"If only I touch his cloak, I will get well."* Jesus turned around and saw her, and said, *"Courage my daughter! Your faith has made you well."* At that very moment the woman became well. (Mtt.9:20-22; MK.5:25-34; LK.8:43-48)

Jesus asked the two blind men who followed him and begged for his mercy, *"Do you believe that I can heal you?"* They answered, *"Yes Sir!"* Then, Jesus touched their eyes and said, *"Let it happen, then, just as you believe!"* and their sight was restored. (Mtt.9:27-30)

Jesus, in response to a Canaanite Woman, who persistently begged Jesus to drive the demon out of her daughter, said, *"You are a woman of great faith! What you want will be done for you."* And at that very moment her daughter was healed. (Mtt. 15:21-28; Mk. 7:24-30)

Jesus spoke up when a Samaritan man came back to thank Jesus after he was healed, *"There were ten men who were healed; where are the other nine? Why is this foreigner the only one who came back to give thanks to God?"* And Jesus said to the man, *"Get up and go, your faith has made you well."* (Lk. 17:17-19)

Jesus, through out his ministry taught and exhorted his disciples to have much faith or strong faith in God.

In *Mtt.6:25-34; Lk.12:22-28* Jesus told his followers not to worry about food, drink and clothes in order to stay alive; but to have faith in God who knows and provides everything they need."

The disciples came to Jesus in private and asked him, *"Why couldn't we drive the demon out?"* *"It was because you do not have enough faith,"* answered Jesus. *"I assure you that if you have faith as big as a mustard seed, you can say to this hill, 'Go from here to there!' and it will go: You could do anything!"* (*Mtt. 17:19-21; Lk.17:5-6*)

Jesus said to the disciples who were in great fear when their boat was tossed by a strong wind: *"Where is your faith?"* (*Lk.8:22-25*)

The whole chapter 11 of the letter to the Hebrews testify how faith works. The chapter begins with a description of faith. *"Now faith is the assurance of things hoped for, the conviction of things not seen."* (*Heb.11:1-2*) And the rest of the chapter talks about how, by faith, the people of ancient times won God's approval.

Let's probe further into how faith works by finding answers to some questions: What is the kind of faith that works? Through what kind of faith does God work?

1. A faith which is rooted; anchored or grounded in God: an unshakable faith. The faith which says, 'nothing in life, not even death itself, can shake us loose from our anchor in God, nothing can separate us from the Love of God. (*Rom.8:38-39*). The faith which continues to trust in God in all circumstances, in spite of ... anything and everything.

"Even though the fig trees have no fruit and no grapes grow on the vines, even though the olive crop fails and the fields produce no grain, even though the sheep all die and the cattle stalls are empty, I will still be joyful and glad, because the Lord God is my savior.

The Sovereign Lord gives me strength.

He makes me sure-footed as a deer and keeps me safe on the mountains."

(*Habakkuk 3:17-19*)

In *1 Kings 17:8-16*, we read about a poor widow who fed Elijah in her most desperate hour. There wasn't enough flour and oil to make bread for her son and herself. But she had faith in God. God rewarded her with enough food to last until the drought was over.

We need faith most in our bleakest moments, and when trusting is hard. When we cling to God despite an uncertain situation and an uncertain future, wondrous miracles can happen in our hearts and lives. In the face of our need, God can make something out of nothing.

A simple village woman who had put her trust in Christ two years before, lost her baby three days after giving birth. When she returned home from the hospital, the villagers mocked her because of her faith. But she remained faithful to the Lord and said, *"Whatever tragedy comes to us, we will continue to trust in Jesus."*

Such faith dares take a risk and pays a costly price; It dares to cross boundaries, barriers, and limitations; and do the unthinkable thing.

2. An unquestioning faith; a faith which does not doubt, but which depends absolutely on God's promise, God's power and God's unconditional Love and mercy, manifested in the lives of the faithful, the prophets and Jesus Christ. Let us listen to the word of God spoken through them.

"I am the Lord, I have called you in righteousness, I have taken you by the hand and kept you." *Isa.42:6*

"Do not fear, for I have redeemed you, I have called you by name, you are mine." *Isa.43:1*

"I know the plans I have for you, says the Lord, plans for your welfare and not for harm, to give you a future with hope." *Jer.29:11*

"I am sure that God, who began this good work in you, will carry it on until it is finished on the Day of Christ Jesus. *Phil.1:6*

"Commit your way to the Lord; trust in him, and he will act." *Ps.37:5*

"Cast all your anxiety on him, because he cares for you." *1 Pet.5:7*

"Wait on the Lord: be of good courage, and he shall strengthen thine heart." *Ps.27:14*

"By grace you have been saved through faith, and this is not your own doing; it is the gift of God." *Eph.2:8*

3. A Living faith; an active faith; a vital faith.

"Faith without work is dead." *James 2: 14-26*

"Abraham's faith and his actions were working together, and his faith was made complete by what he did." *James 2:22*

"To him who by means of his power working in us is able to do so much more than we can ever ask for, or even think of." (*Eph.3:20 TEV.*)

Miracles happen when we believe in and allow God's power to work in and through our lives.

It was by faith that 43 years ago Mrs. Shanti Solomon from India was given a vision to conceive and give birth to a Prayer Movement for justice, peace and reconciliation which is widely known as the Fellowship of the Least Coin. It happened during a Peace Mission Team visit to some countries around the Pacific rim in 1956. She prayed and pondered over a possible way of bringing together people in war-torn countries for reconciliation and peace

while she was left behind in Manila, Philippines, because she had been refused a visa to Korea.

By faith she believed that wounds and brokenness caused by hatred and war could be healed by the power of prayer offered in the spirit of Love and forgiveness.

By faith she dared dream of introducing a worldwide movement of prayer which could embrace and unite people from all walks of life no matter from where they came, what their backgrounds were, what their positions and financial status might be. She suggested that anybody who wanted reconciliation and peace should pray. She/he would set aside a least coin whenever a prayer was said in a spirit of love and forgiveness. This act of faith, expressed in an earnest prayer and a giving of the Least Coin has touched many hearts and lives around the world. God has increased the faith of those who have joined Shanti in believing and promoting this simple, yet unique Fellowship of the Least Coin, an Ecumenical Prayer Movement for justice, peace and reconciliation. And God has multiplied the least coin in order to feed the hungry, to quench the thirsty, to clothe the naked, to heal the wounded and to provide shelter and home for the abused and the homeless. Over 80 countries around the world participate in this Prayer Movement; joining the circle of prayer, learning to give and to receive love and forgiveness from one another with humility. Each year around 40-50 programmes and projects in different parts of the world are supported by these least coins.

Yes, indeed faith does work. A faith which rest in the arms of the One who is faithful, A faith which is grounded in the assurance of things which are hoped for and which cannot be seen. A faith that sees the miracles and mercies of God transforming what seems to be impossibly bad situations, in a way beyond human imagination.

May God who is able to accomplish abundantly far more than all we can ask or imagine increase our faith and make it strong

- So that we may be able to learn to trust in God's promise, God's faithfulness and God's unconditional love;
- So that we may reach out in love and forgiveness to those who are estranged to us and to those whom we have never met;
- So that we may be able to dare to dream and commit ourselves to tasks which are beyond our own comprehension, ability, strength and resources.
