Here is list (33) of Missionaries who are in receipt at the present time of an annual allowance from the Society. In this List it will be observed are not included the names of two clergymen who have been heretofore placed upon my Register. These are the Revd H.T. Stiles M.A. Chaplain of St Matthew's Windsor, and the Revd C.B. Naylor B.A. Chaplain at Norfolk Island; upon whose cases it may be right to offer a few remarks. Mr Stiles was recommended by me to the Society upon the special ground that in addition to his own proper parish he had charge of the town of Richmond, and of the distant District of Kurrajong; to and from which latter place he had every week a most

laborious journey. Upon the ground of the inadequacy of his remuneration for these additional duties I recommended his being placed upon the Socceity's List so long as he shld continue to undertake the services at Richmond and the Kurrajong in addition to his own at Windsor, which was acceded to. But now, the Revd J.K. Walpole having resumed his clerical duties, and being in charge of Richmond and the Kurrajong, I felt that it wld no longer be proper for me to certify that Mr Stiles was entitled to receive the Soc's allowance. I am however most anxious it shld be understood that such discontinuance arises wholly and exclusively from his ceasing to discharge the extra duties before spoken of: and not in the slightest degree from any decrease of the estimation in which I hold Mr Stiles. On the contrary I entertain the highest possible regard for his character and services; nor is there any clergyman to whom I could more unfeignedly wish the continuance of the Society's allowance, if circs brought him within the terms and conditions according to which such grants are regulated. With regard to the Revd C. (sic) B. Naylor, I have already apprized you that my motive in granting him permission to draw for the space on one year upon the Society's funds, was the desire of remunerating him for the expenses incurred in his removal to Norfolk Island: the Govt not making any allowance on that acct, and he being unable with a numerous family to bear the burden with his own resources. Having encouraged him to hope that the allowance of £50 wld be continued for 1843, I have taken upon myself to certify his  $\frac{1}{2}$  yr Bill to Dec; but shall not continue to do so: the Society not appearing satisfied that the nature of Mr Naylor's apptment in a penal s'ment RENDers the allowance to him from their funds a strictly proper one.

The Revd Thomas Sharpe of Bathurst stands at the present time in a situation somewhat similar to that in which the Rend H.T. Stiles was placed: i.e. in charge of a very wide district in addition to his own parish, and frequently required to undertake lengthened journeys to various parts of the same, which without that exertion on his part must remain destitute of all religious instruction. I wld beg therefore to recommend that the allowance of £50 surrendered by Mr Stiles, shld be granted to the Revd Thomas Sharpe, M.A., All Saints Church Bathurst - and continued to him as long as he shall remain liable to the extra duties which he now performs.

I hope also to receive the Soc's indulgent consideration in recommending to them that on a vacancy occurring in their list of Missionaries or the state of their funds allowing as augmentation the annual grant of £50 may be assigned to the Revd. F. Cameron, M.A. Singleton with Glendon, as I consider him very worthy of such assistance. As the Soc's resources shall (as I trust) be recruited I shall have much satisfaction if the services of the undermentioned clergymen may be taken into consideration, with a
