## PROCEDURAL ARRANGEMENTS

The following procedures will be used by the President and Vice Presidents during the National Conference 21–25 September 2009.

1. Agenda as set out in the Conference program will be adhered to unless the meeting determines otherwise.

Any business not included in the agenda must be presented in writing to the National Executive no later than 9.00pm Monday 21 September 2009 for consideration and presented for debate if and when it is considered appropriate.

The President shall determine when introduced business genuinely arises from the current debate, and is so determined, it may become part of the conference Agenda regardless of the date introduced.

2. Motions must be presented in writing and signed by the mover and seconder, together with a preamble and/or rationale.
3. Recommendations and/or suggestions from Units, intended to become Motions, must be presented in writing as indicated above.
4. Reference Committee of three (3) shall be appointed by Conference.
5. Tellers. Two (2) shall be appointed by conference.
6. Members wishing to speak shall stand and wait until recognised by the President. Members shall address the President when speaking. All members are to state their name and Unit or Organisation represented, before beginning to speak,. Observers have the right to speak but not to vote.
7. All Conference papers to be taken as read, but the Presenter of the business may highlight certain aspects within limits as prescribed in Item 15.
8. A motion may be moved, the mover speaking to the motion. Any motion that is not seconded shall lapse and not be recorded in the conference Minutes.

The seconder of the motion may speak to the motion, or may reserve the right to speak later.

9. Motions may be debated once they have been moved and seconded. The President may inquire if there is anyone wishing to speak for or against the motion, and should alternate such speakers. If there are no speakers against the motion, the President shall put the motion to the vote.

The mover of the motion has the right of reply to the debate immediately prior to the vote being taken.

10. Debating: Up to three (3) minutes will be allowed to each speaker unless permission is granted for an extension of time (for a maximum of two (2) minutes). This must be moved, seconded and agreed upon by the voting members.

No member may speak more than once on the same motion or amendment, except the mover, who shall have the right of reply. If debate exceeds twenty-five (25) minutes on one motion, it will be deferred to a later Business Session.

11. Amendments may arise from the debate, but the mover, seconder and speaker to the amendment shall not have spoken to the original motion. The proposed amendment must vary the subject matter of the motion, whilst maintaining the intent of the original motion. Any amendment not seconded must lapse and not be recorded in the Conference Minutes.

The President may choose to inquire if any amendment is likely to be seconded, before allowing the mover of the proposed amendment to speak to the amendment.

The mover of the amendment may not reserve the right to speak later.

One (1) amendment shall be dealt with at a time, with speakers limited to addressing the amendment subject. A speaker may foreshadow her intention (but not to speak to her proposal) to offer an alternate amendment following the resolution of the current amendment.

Any amendment must be taken in sequence of acceptance.

12. The debate is closed when the time limit of twenty-five (25) minutes is exceeded on the one motion, the President indicates she believes there has been sufficient debate there are no more speakers, or when someone, who has not taken part on the debate, moves the motion **“that the question be now put”**. This must be seconded and carried.

**The vote must be taken immediately without further discussion** or the mover’s right of reply being granted.

If there is a motion and an amendment before the Conference, the amendment is put to the vote first. With the resolving of an amendment, the debate on the motion, or the amended motion is closed. Any foreshadowed amendment is now proposed and the debate resumed.

The mover of the motion may use her right of reply, after which the President shall put the motion to the vote. A simple majority vote is necessary for the motion to be carried. The President shall declare the result of each vote.

13. Voting entitlements are:

- Two (2) from each State/Territory Unit
- One (1) from each Denominational Organisation
- Five (5) from Incoming National Executive
- One (1) from Winifred Kiek Scholarship Trust
- One (1) ACW representative to ACWC
- Five (5) National Executive members

14. Voting method shall be by the Delegates displaying their official Voting Card when the vote is called for, unless otherwise decided by vote at the Conference.

15. At all reporting Sessions, it shall be moved “that all reports be taken as read”. Speakers to the National Executive and Unit reports are allocated five (5) minutes, National Denominational groups, Special Interest Groups, Winifred Kiek Scholarship Trust and National Representatives are allocated three (3) minutes. Questions and comments are not included in the time allocation, but at the discretion of the President.

## **NATIONAL PRESIDENT'S REPORT**

These last two years have passed very quickly. Over that time I have been much encouraged by the ecumenical work of all Units of ACW, wherever they are, whether large or small.

I have been privileged to represent ACW at a number of functions, including the National Prayer Breakfasts, International Women's Day breakfasts and celebrations for St Patrick's Day. These have been opportunities to make our organisation more widely known in the community.

It has been a very enriching experience to be able to visit some of the Units, NSW for their anniversary celebrations, and South Australia, Western Australia and Queensland more recently. I wish to thank most gratefully the members of the Units for extending their hospitality and giving their time to look after me so well when I was with them.

My thanks also go to all those who represented National Executive on my behalf at various functions in their States.

The work of the truly extraordinary team of women who have been members of the national executive has been a wonderful support to me. We have been a team with different experiences and different skills, each giving their best to the overall work of ACW. I especially wish to commend Helen Raymond who with the support of her husband Oliver, worked tirelessly to ensure that ACW National finally became incorporated after many years of talk. This was envisaged at both the 2005 and 2007 conferences and it is most satisfying to now have ACW National as a properly incorporated non-government body.

During this time I have been the delegate to Australian Women's Coalition, and have tried to bring a Christian viewpoint, compatible with the aims of ACW, to the discussions and so to the decisions made by that body.

It has been a privilege to serve ACW and you all in this way and I thank you for enabling me to hold this position. I am very conscious of the prayers of many different people which have upheld me throughout the period.

I wish that God's richest blessings may be on the incoming President, Miss Margaret Flint OAM, and the incoming National Executive in South Australia as they go about the work in the coming years.

## **NATIONAL SECRETARY'S REPORT**

The last two years have been a time of much learning for me, and I have gained an appreciation of the wider picture of the ACW movement around Australia, and its relationship with ACWC and the world-wide organisation of the FLC movement. However, if I am really honest, I will say that I am looking forward to the handing over of ACW responsibilities to my successor! It has been a busy time for me. At the same time I will miss very much the fellowship and care that members of the National Executive have had for each other. National President Jean Thomson and National Treasurer Helen Lloyd in particular have always been very helpful in their guiding and assistance, and I thank them especially. Judith-Ann Sjostedt composed the words and tune for our Conference song. I think she has skilfully included all of ACW's activities in the words – enjoy it. I also want to pay tribute to ACT's two National Life Members, Ruth and Evonne, who have been present at most of our meetings and been a tower of knowledge and support to everyone.

I have been told that when National responsibilities were last held by ACT (in 1995–97) the matter of Incorporation was a keen topic of discussion. It seems to have been on the Agenda ever since, but no decision was able to be made by other executives. However, during our current term the matter was raised again, and members agreed that Helen Raymond carry out another investigation. With help and guidance from her husband Oliver, Helen was able to gather the information necessary, and carried it through to conclusion earlier this year. Our Life Members in particular were rejoicing. Perhaps it has been easier doing this in the ACT because "officialdom" is comparatively accessible here. The Executive realises that Incorporation affects ensuing Executives, but feels that the benefits are worthwhile.

During the year we have been saddened by devastating natural disasters across Australia – floods and bushfires. God's love and concern for his people was shown by fellow Australians and also by members of ACWC as shown by their prayers, and their donation to the bushfire victims. We were humbled by their generosity.

The ACW Website was launched at the last Conference, and I know that members of the general public have looked for information from it. Some members of Executive do not regard themselves as "computer literate", and we have had difficulty understanding everything that is required to maintain the Website as a useful tool. Brenda Dickinson, Website manager, has had frustrations too. I hope that the Incoming National Executive will be able to investigate the whole Website situation.

I want to thank all the Unit Secretaries for sending in minutes and reports regularly. It has been so interesting to read of the different emphases that our Units have. Our numbers are getting smaller, and we pray that the Lord will show us a way to broaden support for our movement.

My good wishes to go to the incoming National Executive, and the secretary in particular. I know you already have many plans in hand for the coming two years.

## NATIONAL TREASURER'S REPORT

I have pleasure in presenting the financial statements for the years ended 30.6.08 and 30.6.09. The separate statements for the periods 1.07.07 to 14.11.07, and 15.11.07 to 30.06.08 have been used in preparing the ones for the year to 30.06.08.

National Executive has used a cheque account facility at Westpac through the Anglican Development Fund in Canberra. We have also opened an "at call" account with the Anglican Development Fund which has earned a higher rate of interest. The \$22,000 deposited in this account has increased to \$23,486.86 at 30.06.09.

The Guidelines were amended at the 2007 National Conference to clarify the titles and purposes of the Conference & Travel Funds. Details of the activity in these funds since the transfer to the ACT are shown below:

Most Units have supported these funds annually, as per the Guidelines.

Interest rates have fallen during our term of office, so the amount of interest earned has been reduced. Approximately 10% was deducted each year from both the Fellowship and World Community Day Service offerings for administration prior to transfer to Winifred Kiek Scholarship Trust from Fellowship Day and 50% each to ACWC and the Special Project for the year from World Community Day. Only a small amount was deducted from the Fellowship of the Least Coin money prior to transfer to Switzerland.

It was felt that all WKS leaflets should be uniform for distribution by Units. This resulted in expenses of \$3348.09 for the printing and postage over the two years and is in excess of any money retained from the Fellowship Day Service collections.

The cost of the reprint of "Winifred" books has not been covered to date through sales. There are still 112 copies on hand.

ACWC responded to the Victorian Bushfire Emergency in February 2009 by sending a donation of \$US 500 (\$A 760.57). This remains in the National Executive account pending advice on its disposal.

All Registration and Conference Fees received for the 22<sup>nd</sup> National Conference have been shown as a separate figure at 30.6.09. The \$550 expenses incurred earlier were deducted from the National Conference Fund.

I would like to express our appreciation to the Auditors: Mr Ron Mellody of Collins Mellody for the period 1.07.07 to 14.11.07, and to Pauline Hore JP(ACT), BEc, Dipl in Admin, CPA for the period 15.11.07 to 30.6.08, the year ended 30.6.09, and also the combined accounts to 30.6.08.

I would also like to thank all Unit Treasurers for their support during my term of office and to wish my successor a happy and rewarding time as she moves from WKS Treasurer to National Treasurer.

At first I felt daunted with the prospect of having to keep in touch with past and present scholarship holders as well as being responsible for passing on news to the State and Territory Unit WKS convenors. The support and encouragement I have received from all convenors has been most welcome and I thank them most sincerely. Also I soon learnt that to follow the ACW Guidelines was the only way to go. The love of God has been flowing freely.

I attended the 70<sup>th</sup> birthday of the NSW Unit in September 2008 and it was a joy to share in the cutting of the beautifully decorated cake which was standing on a gold embroidered cloth sent as a gift from the 1994 student Nighat Gulzar. In June this year I shared with the WKS Trustees in selecting the 2010 WK Scholar/s. Our thanks go to the WKS Trustees for their dedication in making these selections. The application forms are carefully scrutinised, taking into consideration the financial assistance required as well as the planned study program. This task is not an easy one as most applicants seem worthy of support. We thank the Trustees for their excellent work over the years as they have maintained and upheld the path set before them by the Rev. Winifred Kiek. This scholarship, now in its 44<sup>th</sup> year, has enabled the WKS Trustees to assist 53 students from 26 countries of the Pacific Islands, Asia and Australia.

The 2008 and 2009 students have been given copies of "Winifred", the biography of Winifred Kiek, and they have appreciated reading about this remarkable lady.

Fellowship Day services were held in many venues around the country. Last year the Service was prepared by the ACT Unit with the theme "Growing in Faith" and this year SA Unit chose "Our God is ever faithful" for the theme to tie in with the National theme. Pamphlets about the students were sent for all convenors to distribute.

Receiving letters from former students has been interesting. I have had contact with: Mary Au (Hong Kong 1980), Doreen Tie Chin (Sarawak 1990), Nighat Gulzar (Pakistan 1994), Rachel McManus (Australia 1997), Gaye Inall and Susan Liersch (Australia 2003), Anju Borgoary (Assam, India 2005), Siok Cheng Chew (Malaysia 2005), and Tania Eichler (Australia 2005).

Pastor Leinamau Manrogoana returned to Vanuatu in December 2007 after completing her studies at Alan Walker College in Sydney. She has since attended a Scripture Union Conference in PNG, where she found the knowledge gained during her studies was of great value.

In 2008 Imelda Aquino in Manila completed her Masters Degree in Divinity, and is now fulfilling her calling ministering to Christian and Muslim women in Dubai.

2009 students Christine Ferguson and Inise Foiakau are both deeply engrossed in studies and finishing assignments on time. They are both most appreciative of our continuing prayers. Christine is studying for her Graduate Diploma in Divinity at the Bible College of Victoria as she is preparing for cross-cultural mission overseas. Inise is living in Sydney with her husband and two daughters. She is studying for a Graduate Diploma of Theology at Charles Sturt University. This will equip her to assist her husband who is a senior elder in a Fijian congregation of the Uniting Church in Parramatta.

God has blessed and guided me and now it is time for me to pass on my National Convenor's badge to the incoming Convenor. It is through faith in God that she will receive guidance in her new position.

## **WINIFRED KIEK SCHOLARSHIP TRUST REPORT FOR 2008–2009**

The Trustees have pleasure in presenting the Winifred Kiek Scholarship Trust report for the period 2008–2009.

**Scholarship:** Imelda Aquino was the 2008 scholar. She successfully completed her Master of Divinity (Missions) at Asia Pacific Theological Seminary in the Philippines. Imelda has furthered her studies in the Middle East and has a calling to work with Muslim women.

**2009 Scholarship:** Five applications were received from Multicultural Australia. Two scholarships were awarded to:

**Christine Ferguson**, a trained nurse, is studying for a Graduate Diploma in Divinity at Bible College of Victoria. She is looking towards sharing the Gospel in developing countries.

**Inise Foiakau** is currently working for AMP Capital Investors and is highly qualified in computer skills. She is studying part-time for a Graduate Diploma in Theology at Charles Sturt University in partnership with United Theological College (Vic) Parramatta so that she can assist her husband with his work as a Senior Elder in the Parramatta Fijian Parish.

**2010 Scholarship:** We received applications from Samoa, Tonga, Papua New Guinea, Kiribati, and two from Fiji. Some of the applications were incomplete or very vague, which made our decisions difficult because we needed to make further enquiries. At the time of writing this report no final decisions were made because our enquiries had not been answered.

**Fellowship:** We are delighted that Corazon Tabing-Reyes is able to be present at our National Conference as a Winifred Kiek Fellowship awardee. Cora is Executive Secretary of the International Committee for the Fellowship of the Least Coin. The Trust is happy to assist with her travel expenses.

**General:** Our Treasurer, Christine Barber, continues to pester financial institutions for the best interest rates when our investments mature. This has created a few headaches lately owing to the current economic climate so we have opted to go for the short-term fixed deposits with the best rates.

Unfortunately Christine's term expires at the 2009 National Conference and a new Treasurer will be hard to find. We thank her for her hard work and wish her well in the future.

Jean Roberts continues as Minute Secretary and operates the fax machine. Cynthia Gifford and Lois Denholm provide knowledgeable input. Yours truly sends out application forms, receives emails and answers the hard questions.

**WINIFRED KIEK SCHOLARSHIP TRUST**  
**TREASURER'S REPORT FOR PERIOD 1/7/07 TO 30/6/09**

Attached are the Financial Statements for the Trust for the years ended 30<sup>th</sup> June, 2008 and 30<sup>th</sup> June, 2009. The balances cover all funds for the Scholarship and Fellowship accounts and the Honouring Church Women account.

Investments continued to be placed in Term Deposits with guaranteed interest rates. For the year to June 2008 Interest rates rose to over 8%, and encouraged longer investment periods which gave us a working sum of \$19,411.03 for Scholarship and \$917.11 for books and materials from the HCW account. These funds being used for the 2009 Scholars. The Fellowship account stood at \$17,548.98.

As you will be aware over the past two years there has been fluctuating earnings due to the "global financial crisis." Regretfully with the continued downturn in the economic market over 08/09 earning rates fell back to 4% but are now starting to rise. Although with the term deposit investments, there is no capital growth, we have not lost any capital, and you will see from the Financial Statements that the Total Funds now accumulated stand at :

Winifred Kiek Scholarship \$345,030.71 (including the Fellowship account of \$19,228.89 and \$20,583 for the 2010 Scholarships), and Honouring Church Women \$17,206.76


Scholarships were paid in 2008 for Leianamu Manrogoana (balance of 2007) and Imelda Aquino totalling \$12,546.

In 2009 we have paid \$18,848 for Inise Foiakau and Christine Ferguson, with a balance of \$2,245 in the current year 09/10. This leaves an estimated shortfall of \$1,600 which will be paid from the excess in 2008.

I again record my thanks to my fellow Trustees for their assistance and support in considering recommendations. Also I wish to acknowledge the assistance of our Auditor Mr. Adrian Nicholls, and recommend a gift be made in appreciation of his service for the past term.

It gives me much pleasure to table this report, and move the following Motions :

1. That the balance of the 2007 Scholars account and 2008 (after transfer of the 2009 shortfall) be transferred to WKS Fellowship A/c.
2. That the balance of the 2007 and 2008 Honouring Church Women funds be transferred to WKS Scholarship A/c with the intent of accumulating additional scholarship funds.
3. Recommend that a gift of \$200 be made to the Auditor for this past term and that \$125 be reimbursed for the 2006/2007 gift.
4. That Mr. Adrian Nicholls be appointed Auditor for the ensuing 2 years.

## SOCIAL JUSTICE ISSUES REPORT

It has been both a pleasure and honour to serve Australian Church Women as the National Social Justice Convenor for the past two years. During this time we have witnessed a number of significant events having widespread implications for social justice throughout the world. The election of the first Afro-American President of the USA; the return of a Labor Government in Australia after 11 years; the collapse of many global financial institutions; on-going wars in many countries and the devastating Victorian bushfires.

All ACW Units have been concerned about human trafficking with particular emphasis on women and children. These desperate people need our prayers and support.

The Tasmanian Unit have been concerned about the plight of children living in drug-affected households and of the rising incidence of babies born suffering from drug withdrawal symptoms. Safe Surrender Laws envisaged by Senator Helen Polley and changes to the Alcopops legislation remains a concern, as do Fair Trade issues.

The South Australian Unit participated in "Uplift Fiji", a project commenced by Rotary International. Hundreds of pre-loved bras were sent to disadvantaged indigenous Fijians who purchase their clothing from second-hand Australian clothes shops. The Unit provides gift baskets for women leaving the prison system. ~~They are currently considering providing funds to enable inmates to take swimming lessons.~~

Members from the Western Australian Unit have attended rallies to protest against deaths in custody. Recently a highly respected elder literally roasted to death in the back of a non-air-conditioned van. This issue has been contested vigorously and notice brought to the attention of the relevant Government department. The work going on at Acacia Prison under the name of the Sycamore Tree project – a restorative justice program bringing perpetrators of crime face-to-face with their victims. Advocates have stressed that money being spent on bigger gaols should be directed to programs to help offenders.

Members from the ACT Unit have been concerned about food coming into Australia with little or no labelling. This can have dire consequences for people who suffer from asthma, diabetes and multiple allergies. Binge drinking and youth suicide are also issues of grave concern.

The Victorian Unit continues to be most concerned with the number of people deemed homeless. The government must provide more dwellings for low-income earners. Letters have been written to the State Minister for Education requesting that provision be made for more Breakfast Clubs in both Primary and Secondary schools. Letters were also written to the Melbourne City Council asking that new By-Laws be drafted to compel brothel operators to display signs in several languages informing workers that sexual slavery is a criminal offence in Australia and that victims can get help.

NSW Unit were concerned about the global financial crisis and its effects on the marginalised. Members have attended numerous "Days" including Sorry Day, Social Justice Day, Harmony Day, and Innocent Child Victims of Aggression. Death Penalty, Abandoned Babies and Bullying were also on their Agenda.

On your behalf I have written to many Federal politicians in relation to Alcopops, to funding for children suffering from Epidermolysis Bullosa as well as asking for an increase to the Carer's allowance; asking that pornographic material involving little children be no longer displayed in publications funded by the Australian taxpayer. I also wrote to Senator Steven Conroy congratulating him on his stance re Internet filtering.

As Christian women we must continue to speak out against all forms of injustice. A society is judged on the way it treats its most vulnerable citizens.

As our Lord said, "Whatever you do for the least of my people you do for me".

I wish the incoming National Executive every blessing for their term of office.

## **ASIAN CHURCH WOMEN'S CONFERENCE (ACWC) REPORT**

Australian Church Women is very blessed to be represented at the Asian Church Women's Conference. Our Asian sisters are incredible women and their faith is a powerful witness from women who often live daily with adversity in impoverished communities that are hostile to Christian beliefs. Their desire to live as Jesus' disciples in their neighbourhoods and beyond demonstrates the depth and strength of their faith.

Australia has been privileged to be a recipient of their reaching out to others and particularly so earlier this year after the tragic bushfires that swept across the south-eastern corner of our country. The ACWC released \$500US from their Emergency Fund and forwarded it to National Executive for distribution. This precious gift will be used to replace church property in the worst affected area.

Since our last National Conference I have travelled to Taiwan, Thailand, Hong Kong and Korea. Last year I attended the Executive and General Committee meetings of ACWC in Taiwan. Between the two meetings, a joint celebration seminar was held with Bridgebuilders International to celebrate their 5<sup>th</sup> international consultation as well as ACWC's Jubilee Anniversary. The theme of the seminar was: 'The Role of Women in Upholding the Dignity and Integrity of All God's Creation'.

On my way home from Taiwan I travelled to Chiang Mai in Northern Thailand and met up again with Oranat Katue, the national Thai representative of ACWC. I was able to see the progress of the ambitious building programme at the Baptist Church property and spend a day with several Karen women who were meeting in Chiang Mai for leadership training.

This year, on my way to the Executive Committee meeting in Korea, I stopped off in Hong Kong and shared Easter with the English speaking corps of The Salvation Army. This church has a lovely ministry that reaches out to the many Filipino people living and working in Hong Kong.

Korea was a busy time and yet we experienced spiritual renewal there as we stayed in a quiet retreat adjacent to a national park. It was also spring and the trees surrounding the hotel were full of blossom that would gently rain down whenever a breeze was blowing. There was opportunity to fellowship with our Korean prayer partners and spend time getting to know the ladies of the Korea Church Women United (KCWU).

Further details of these meetings and other ACWC activities can be found both online and in print. There are now at least five sources to find information on ACWC. For those of you who have access to the Internet, <http://www.acwc.blogspot.com/>, the ACWC website that was launched in June last year should be your first port of call. Then there is the ACWC newsletter, which I commend to you for its varied and informative reports; the ACW National newsletter; my reports (which have been trimmed back to brief notes to the National Executive whilst serving as President to the Victorian Unit); and the ACW National minutes should have reports of ACWC activities.

Presently, there is a lot of activity behind the scenes for the ACWC Executive Committee as we prepare for the next quadrennial General Assembly to be held in Indonesia from 7-12 October 2010. Your prayers would be appreciated for this Assembly and for those who will attend. Each country has been limited to a maximum of eleven (11) participants at the Assembly.

Thank you again for your support and encouragement of both myself and our Asian sisters, and we value your prayers as the Gospel of Christ is preached across the Asian region.

The Coalition consists of 19 women's groups including Aboriginal Legal Services, CWLA, Muslim women's organisation, Aust Bosnian Women's organisation, COTA, UNIFEM, PPSEAWA, Soroptomists, NCWA, NCWJA, Girl Guides, Mothers Union, Hindu Women of Australia, View clubs and Zonta. So you can see there is a wide variety of women represented as well as a variety of views expressed. It is an interesting group to be a part of.

I have attended 7 meetings of the group, usually held in Sydney, and taken part in several Teleconferences as well as receiving numerous emails and other communications. I helped to organise 2 seminars in the ACT during 2008 which related to questions of 'Women's well being' as part of a nationwide survey undertaken by the AWC. These activities are paid for by the Government grant received by AWC as one of the Women's Alliances working with the Federal Government Office for Women under Minister the Honourable Tanya Plibersek.

I have forwarded requests on to State Units where appropriate and have been pleased at the response and support I have received. I have also forwarded copies of the Annual Reports for both 2007 and 2008 to each State Unit for your interest.

I think it is important for ACW to continue to be part of this valuable network of different non-government organisations. We were one of the original members of the precursor to AWC and have continued ever since. I hope that the new National Executive will be actively part of this group for the next 2 years, and I am willing to be the alternate delegate to help with continuity of membership.

It has been two years since the launch of the Australian Church Women Website. Information has been updated as it has come to hand.

In addition to information updates, National Executive expressed the desire to add the word "Incorporated" to our title on the web pages and to add the abbreviation "Inc." to our logo. At the time of writing this report, the word "Incorporated" has been added to our title but we are still waiting to hear from our Website Administrators with regard to receiving a "mock-up" of the new logo before agreeing to the final change.

Comments from outsiders have been favourable and I've been able to help people with enquiries about Australian Church women and have even sent an Order of Service for a Special Days Service to someone interstate who contacted me via the website as they couldn't contact the person they were trying to reach. When booking churches for Special Days Services I've been able to refer the minister to our website for information.

It is to be noted that some State Units have not had any activity on their web pages. I have conveyed to them that I am happy to update information on their web pages if they would like to send me the changes. Some have still not responded but at least their "main page" is fine for people who log on to our website looking for State Unit information.

The creators and administrators of our website are a company called Marmalade Soul which is based in Queensland. It has been very difficult to communicate with them and have our requests for changes to the integral design of the website attended to. This has given rise to our thinking that perhaps we should change our administrators. If we were to do this, we would need to ensure that the new administrators would suit our needs.

At present, costs to run our website have been very low, e.g. \$220 per annum hosting costs and \$95 per annum for 4 x 15 minutes technical support sessions. If we were to engage new Administrators we might need to pay more than this.

Meeting in Scots Church Sydney, those gathered *Looked Back* with Edith Ridge and Joan Tong, still recognisable in their angelic attire, exploring the history of the Unit to date. Pru Goward MP followed with inspirational thoughts about *Moving Forward*, and the role church women can have in the community. Lyn Middleton then delivered the challenge to be visionaries, because "without a vision the people perish". The compilation of Profiles of Past Presidents was completed not long before, and a summarised version was available at the celebration. A powerpoint presentation traced the history of the unit decade by decade. As we step into the next decade we add, *The Future, Our Responsibility*.

Mrs Jennifer Pepper was responsible for the organisation of the day, having taken over from Mrs Carmel Keys as President in May. We sincerely thank Jennifer for her leadership thus far, looking forward to her continuing guidance in the year ahead. Although Carmel is now Past President, she is also our Social Issues Convener, and we acknowledge her fine contribution to the work of the Unit. Our President Elect is Mrs Nola Dickson.

At Council in August 2008 our speaker was Robyn Gaspari from Australian Women's Coalition and Eastwood Christian Community Aid. Robyn spoke on a range of matters affecting women such as the plan to combat violence against women, equal pay, sex discrimination, parental leave, and care-giving to sufferers with HIV AIDS. Social Issues that we can take up are brought to the attention of members on a continuing basis.

Following last National Conference some of our members hosted Shu-Wen Chiang before she left Australia. Since November 2007 Lyn Middleton has been our ACWC Convener, and while visiting Taiwan in April 2008 Lyn met up with Shu-Wen. The annual ACWC celebrations in the form of multicultural concerts of praise have been well received, and offer times of enjoyment and fellowship for those able to attend. The generous offerings constitute the bulk of our contribution to Asian Church Women's Conference. While in South Korea for a Salvation Army function Lyn was unsuccessful in her efforts to meet up with our prayer partners, Korea Church Women United.

Our Service of Dedication in May 2009 asked us to look back for inspiration but also to accept responsibility for the future. Colonel Jan Condon was the speaker on this occasion. Fellowship Day and World Community Day services have been held throughout the State, but some Branches have closed largely because there have not been people willing to take on the work of organising.

Our representatives to NSW Ecumenical Council, World Day of Prayer, National Council of Women, and Pan Pacific and South East Asia Women's Association continue to bring us reports from these organisations. Special Day Services were held around Brisbane and in the country centres. The Fellowship Day Service for 2008 was the last Service to be held in Brisbane City and organised by the Unit. Those who are able to come number very few so it was decided from this year on Unit members will try to attend the Services elsewhere around the suburbs. It is sad that the situation has got to this but those few who are interested find it too difficult going into the City any more.

Our only fund raiser for each year is the Musical Morning Tea. Last year it was held at St Andrews Uniting Church but again the problem of lack of numbers made us rethink for this year as to what we would do. So we decided to go out to the northern suburbs. With the wonderful support of the Geebung Catholic Women we had the most successful Musical Morning Tea ever. The nearly eighty people who attended had a wonderful morning and were entertained by 'The Brothers James Singers', a male choir who gave us a feast of songs touched with a little humour along the way. We hope to continue to have our 'fund raiser' in the suburbs from now on.

The Leadership Development Course conducted by the Girls Brigade of Queensland was the successful World Community Day Project for 2008. This course for the girls is all about personal challenge and providing opportunities to develop/improve skills and practices that enhance their ability to be effective Christian leaders in the Brigade and their community. The grant they received (\$3810) enabled girls from outback drought stricken Queensland to attend this course.

We will continue to serve our Lord and Saviour through our commitment to Australian Church Women and pray that through His guidance we will be able to keep Australian Church Women going in Queensland in the future.

## **SOUTH AUSTRALIA UNIT**

This report is written shortly after our National President, Mrs Jean Thomson, visited us in May and attended our Unit meeting, as well as a day apart to meet with Liaison officers and women from other organisations, and finally a Community Concern event. We are grateful that Jean was able to visit us and to forge bonds between us and National Executive.

Our largest local undertaking each year is the staging of Community Concern Events, with sixteen gatherings taking place in 2008 and a further sixteen this year. It is an opportunity for suburban churches to meet women and men from other denominations and to support the chosen charity for the year. While in 2008 the chosen charity was Angel Flight – for which we raised \$5,000. In 2009 we are supporting Prison Fellowship SA – our mandate for choosing a charity is that it receives no government funding and is not church based. Our thanks to all the churches who host meetings and to Mrs Judy Burge who sends out the correspondence and often visits the host churches in advance.

Through our Jubilee 150 Trust we give one-off grants to women who just need a small injection of funds to help further their careers. The grants in 2008 were given to a woman doing a certificate course in Theology and to another woman to help set up a home-based tailoring business. While the recommendation for grants come from a church group, the recipient does not necessarily have to be a church-goer herself.

We have been much involved with finding a President Elect and have been fortunate enough to have the Reverend Nita West to fill the role. She comes to us after a three month stay in Thailand where she has taught English. We welcome her warmly.

We are extremely grateful to the ladies who have offered to serve on the incoming National Executive and offer them our prayers and support. The process of choosing an executive was preceded by a specially composed prayer asking for wisdom.

We have kept up our ties with the World Day of Prayer, and the Fellowship of the Least Coin, most members often 'wearing two hats' and being involved in both of these movements as well as in ACW.

In January 2008 and again in 2009, a number of members met at the home of our Social Justice Convenor, Captain Judith Brown, and packed several parcels of toiletries for inmates of the women's prison and OARS.

In 2008 we welcomed three guest speakers to our Unit meetings. They were Mrs Wendy Sinnott, who spoke on the response to Refugees in our Communities, Mr Jonathan Gear (one of the 100 speakers specially trained by Al Gore) on Climate Change, and Sister Julie McMahon on the No Interest Loans Scheme and how effective they can be.

In 2009 we have had two Unit meetings with guest speakers. Dr Anna Muller spoke to us about aspects of breast cancer, and Major Hank Fernee from the Salvation Army spoke about his tours in the APY Lands, delivering furniture to residents of remote communities – it was inspiring to see the spirit of fraternal love shown by Hank, his wife and team as they set out on their journeys with a prayer.

We remember to pray for our prayer partners in South Korea and are kept informed of all the work of ACWC through the newsletter. Our practice of our faith seems so trouble free compared with that of women in Asian countries.

Our Day of Christian Reflection was a good opportunity for us to come together and not talk for a change. It was conducted by Mrs Barbara O'Halloran, with scripture readings to help us in our quiet time. The weather was perfect and the garden at the Church of the Good Shepherd was peaceful, with birds and butterflies to keep us company as we walked or sat.

My thanks to all on the executive who have worked with unfailing generosity throughout the year. We look forward to more loving co-operation through the remaining months.

## **CATHOLIC WOMEN'S LEAGUE AUSTRALIA INC.**

It is with pleasure that I present **Catholic Women's League Australia Inc Report** to the Australian Church Women's Conference Canberra, 21-25 September 2009.

### **World Youth Day**

*"You will receive power when the Holy Spirit has come upon you;  
and you will be my witnesses" Acts 1:8*

The success of CWLA's involvement in World Youth Day08 can be attributed to Immediate Past President Mary Schultz and her Executive, Sydney Archdiocesan President Moya Potts (who was CWLA's official representative), members of the Sydney Archdiocesan Office and Catherine McGrath NSW President for their attendance at WYD08 meetings, producing the PowerPoint presentation and being present at the Vocations Expo Booth at Darling Harbour. These women were joined by members from around Australia who travelled to Sydney to be part of this 'once in a life time' experience!! It was thrilling and exciting and a little overwhelming on that first day, as we remembered back to when it was first suggested by NSW that CWLA National should be involved in WYD08 and a motion was passed stating that we should invest time, energy and finance to be part of this momentous occasion.

### **National International Secretary**

National International Secretary Thora Regan AM attended CSW 53 in New York 2-13 March 2009. The Theme for the UN Commission for the Status of Women (CSW 53) was "The equal sharing of responsibilities between women and men, including care-giving in the context of HIV/AIDS". Following the support by CWLA in 2008 to sponsor a Billings Ovulation Method Workshop, Thora was contacted with a request for the same arrangement in 2009. Further contact from Babette Lambton of the Endeavour forum resulted in CWLA sponsoring two workshops "True Shared Fertility Management" and "The Health of Mothers" were held on 10-11 March with CWLA (Inc) nominated in the CSW schedule as the Organising NGO.

### **AusAID**

During 2008 and again on 15 February 2009, CWLA wrote to the Hon. Mr Stephen Smith, Minister for Foreign Affairs, urging that the existing AusAID guidelines which had been in place since 1996, prohibiting any overseas development funding from being used for activities which involved the termination of a pregnancy, NOT be changed. However, on 10 March 2009, a Media Release from Stephen Smith MP announced that the rules had been changed, allowing Australia's overseas development assistance programs to support the same range of family planning services for women in developing countries as are being supported for women in Australia. Being a part of WomenSpeak has enabled CWLA to become aware of and to counteract the actions of other member organisations. During 2008-2009 when emails to Mr Stephen Smith Minister for Foreign Affairs were submitted in support of the AusAID guidelines being changed, CWLA used the opportunity to respond citing that we did not support change.

### **Asia-Pacific Regional Meeting Seoul South Korea October 2008**

It was with a great deal of relief, pride and thanksgiving that we finally completed preparations for the WUCWO Asia Pacific Regional Assembly held in Seoul, South Korea from 26-31 October. The theme of the conference was "Women, Peace Makers – United in Faith and Action". Members from Australia who travelled to Seoul were Karyn Kammann, Mary Harrold, Patricia Liddiard, Eileen Hogg, Jacqueline Hipwell, Margaret Toomey, Jean Tanzer, Catherine McGrath, Susan Meehan, Joan Hughes, Peg McEntee, Marilyn Dickenson, Brenda Finlayson and Thora Regan.

CWLA had the privilege of preparing the liturgy for Mass on Tuesday 28 October which was celebrated by Father McMullen SSC, who resides in Seoul. Later in the day Thora Regan AM, our National International Secretary, represented Australia as part of a Panel talk with Dr Amelita Go,

Philippines, "Women's Initiative for Peace", Japan, "Peace and Arms" and Australia, "Peace and the Environment". As National President, I presented the CWLA National Report on actions taken relative to the Motions presented and discussed at the Arlington General Assembly in 2006.

**National Council of Jewish Women**

In September 2008 I was honoured to attend the NCJW WA section's very successful evening "NCWA Women Achievers Evening" held to honour three influential women – Faye Zwicky, Shohana Charkrabati and Dr. Sue Gordon AM. In June 2009 I accepted an invitation to attend the 80<sup>th</sup> Anniversary Dinner 1929-2009 of the WA section of NCJWA. The local Jewish community helped establish the Maurice Zeffert Home fifty years ago and these wonderful women continue to volunteer for charitable organizations, fundraise for their own community, here and in Israel, work in the areas of youth, the environment, migrants, the family and promotion of multicultural and interfaith tolerance.

On behalf of CWLA we extend our congratulations to ACW National President Jean Thomson OAM on her award for faithful "service to the community through Women's Organisations and to the Uniting Church in Australia".

We ask God's blessings on your Conference deliberations as you gather in His name – may all your decisions be pleasing to Him and keep you faithful to all that is true.

## MOTHERS' UNION AUSTRALIA REPORT

### Christian Faith in Action

The Mothers' Union aim and purpose is to demonstrate the Christian faith in action by the transformation of communities Worldwide through the nurture of family in its many forms.

The 3.6 million Mothers' Union members around the World do this by working towards five Objectives:

- To promote and support married life;
- To encourage parents in their role to develop the faith of their children;
- To maintain a Worldwide fellowship of Christians united in prayer, worship and service;
- To promote conditions in society favourable to stable family life and the protection of children;
- To help those whose family life has met with adversity.

MU Australia began 2008 by hosting an International Regional Conference in March in Toowoomba, Queensland. Participants were Provincial Presidents, Diocesan Presidents, Official Workers and Mary Sumner House Staff, and they came from Sri Lanka, South India, Myanmar, South Korea, Canada, United States of America, West Indies, New Zealand, Melanesia, Papua New Guinea, United Kingdom and Australia. This was a time for growing together, learning about each other's country, building relationships and wonderful worship. The Conference was attended by about 100 members and it closed with the World Day of Prayer Service led by women from Guyana, whose country was responsible for compiling the service in 2008. It was truly an International Service, as those taking leading roles spoke in their own language.

MU Australia Council will meet at Pallotti College, Millgrove near Melbourne, in May 2009. Our theme will be **"Challenge, Change and Relationships"**. Particular training will be building media relationships and increasing our knowledge of the Worldwide Mothers' Union which has branches in 79 countries.

Our Parent Education Program, PEP, continues to grow with facilitators trained in all States. The Family Life Program, FLP, has made small beginnings in the Torres Strait and indigenous leaders on Cape York are looking at how they may introduce this initiative of MU Worldwide. A DVD for those who are being married will be launched at Australia Council. Work has commenced on a marriage preparation program called "Loving for Life". Financial aid was given to the Dioceses of Melbourne, Gippsland and Wangaratta following the devastating fires this year. Prayer support for them came from around the World.

The Overseas and Northern Outreach Fund provides aid to developing countries and supports initiatives in North West Australia, Northern Territory, North Queensland, Papua New Guinea and Melanesia, as well as clergy families living in isolated areas.

MU Australia is a member organisation of the Australian Women's Coalition (AWC), an alliance of 20 women's organisations attached to the Office of Women in the Federal Government. In the past year this organisation has been gathering information on "Healthy Ageing" and making recommendations to the relevant Government Ministers. Work has now commenced on looking at retrieval programs for girls and young women who come before the courts.

At branch level, members continue to provide pastoral care in many forms and they are encouraged to be involved in Parish and Diocesan outreach/missional programs. A number of Dioceses are working with migrant groups, particularly the Sudanese, and in Melbourne with Karen people. Our MU members are providing love, care and basic information about social and health services that are available in Australia.

In June, 2009 I was privileged to meet with MU Provincial Presidents from 25 Provinces of the Anglican Church from around the World at Canterbury, England. The theme for this gathering was ***"Pilgrimage – journeying together"***. We examined our journeys, and the journey of MU in our own Provinces, and how we have moved forward. There was agreement that Mary Sumner, our founder's vision of **"winning the homes of the nation for Christ, and helping parents to educate their children in a loving Christian home"**, was still very relevant.

MU Worldwide will still continue to work for the advancement of Christian family life and provide Christian care for families in need.

MU Australia members continue to strive to meet our Vision of **"Sharing Christ's love by encouraging, strengthening and supporting marriage and family life."**

## **PRESBYTERIAN WOMEN'S ASSOCIATION OF AUSTRALIA**

The Federal Executive of the Presbyterian Women's Association of Australia is in office for three years and is domiciled in Queensland till the Annual Conference, which will be held in Sydney in September 2010. All States (excluding Victoria) have their own Presbyterian Women's Associations and are linked to the Federal Association.

We are kept in touch with the activities of the State Associations by receiving their Minutes and Magazines, and our President Mrs Heather Ross visits whenever possible.

Mrs Ross has just visited Western Australia for their Retreat, which was held at Bassendean Presbyterian Church WA on the evening of 1 May and day of the 2 May 2009. This was to be a time of "encouragement for the women" and the theme was "Rejoicing in Hard Times." Heather gave the devotions on the Friday evening and chose Daniel 3 v 12-28 as her topic. Mrs Judith Nicol was guest speaker and spoke of Psalms 77 and 33. She is the wife of the Anglican Archbishop of Perth. Mrs Ross was also a guest at a Moderator's Reception where she was invited to speak about the Presbyterian Women's Association.

Mrs Ross then visited South Australia Presbyterian Women's Association for their Conference which was held on 4 May 2009 at the Presbyterian Church in North Adelaide. She again addressed the gathering and spoke on their theme, "Love".

Tasmania Presbyterian Association is holding a Camp in October.

On 13 July, 2009, New South Wales held their State Conference and Mrs Ross was invited for the 3 day activities and brought a greeting to their Conference.

All States have their own Rallies, Time-out Days and Camps and Conferences, and each State works in their own particular way to help the Presbyterian Church and their own community in any way they are able. The ladies of all the States support among other things the work of the Presbyterian Inland Mission and Missionaries with financial assistance and prayer.

Since taking the position of Federal President she has visited Central, Downs, Mowbray and Wide Bay/Burnett Presbyterian Associations, in Queensland bringing words of encouragement to the ladies she meets. It is important ladies do not feel isolated in our vast country and much is gained by bringing ladies together in fellowship with their Lord and with each other.

We are finding it difficult to get ladies to take office. New South Wales Presbyterian Association has formed a Committee to look into this matter and as we, the Federal Executive start to arrange our Federal Conference in 2010 we have set aside an afternoon, before the Conference, to also discuss this matter. All States will have an opportunity to bring their ideas and thoughts to this meeting.

One of the aims of our Association is "to link the Women of the Presbyterian Church of Australia in a friendly comradeship for mutual help and inspiration and for united service to Christ and His Church at home and abroad." We pray God will continue to bless the ladies as they serve Him in any way they can in their own particular place in His vineyard. Psalm 100 v 2 and 3 says

## **THE SALVATION ARMY WOMEN'S MINISTRIES IN THE AUSTRALIA EASTERN TERRITORY**

Ministry to women is alive and well in the Eastern territory especially through our Focus groups. These are needs based groups that most of our Corps run and there is great variety in the types of groups that are operating. Some examples are:- Scrapbooking, Mainly Music, Playgroup, Quilting, Craft, Bible study groups plus some evening groups that are more social fellowship focussed.

During last year there was over 145,000 women and children who attended the variety of groups. Through these groups and other women's ministry groups, 190 new families have been linked to the Salvation Army Corps.

Mainly Music has been a great success – in fact some Corps have had to turn parents and children away as they have too many for the classes. The challenge of course is – how to link these people with the church. We hope in the near future to see more of these families being linked with other activities in the church and in worship.

Other groups which have been very effective include a sandwich club which operates in a very needy suburb in Brisbane – women from the church gather to pack lunches for children who come to school without a meal. Some corps are very active in preparing pamper packs to be distributed by our Rural chaplains in the drought affected outback areas.

Each of our 7 Divisional leaders organise spiritual retreats for our women officers and retreat weekends for members. These are special times when women draw near to God and to each other. Each Division also organises a “rally day” when all the Corps in the area come together for worship and celebration.

Of special significance is our Annual Bible Convention which this year was re-named “Captivated by the Word”. This attracted 316 women over a weekend and 175 on a Saturday. An international guest speaker leads in Bible study and the weekend also includes workshops based on the theme of the weekend. This year the theme was “Hearing from God” so all the workshops featured aspects of prayer and prayer exercises, including a prayer room and prayer walk.

The territory also has a designated missionary project each year and all our women raise funds for this. Last year an amount of \$89,000 was sent to the Karibu Centre in Kenya. Each year the project chosen is to assist women and children. This year we are raising money for Myanmar.

Over \$20,000 is raised for Child Sponsorship and a further \$64,000 for a variety of other projects. The women certainly work hard to raise this money each year.

We do have challenges – an ageing population and lack of local leadership to name but two, but overall we thank God for the women who are connecting weekly with our women's ministry and thank God for the privilege of ministry by women to women.

## **THE SALVATION ARMY, AUSTRALIA SOUTHERN DIVISION, WOMEN'S MINISTRIES**

The Australia Southern Territory includes Victoria, Tasmania, South Australia, Western Australia and the Northern Territory. Each of these states and the territory, under local leadership, conducts program for women both in the church and in the community with the fundamental purpose to bring women to Christ.

The Territorial President of Women's Ministries, Commissioner Carolyn Knaggs, is responsible for the development, recruiting and the administration of these ministries. The Team of women leaders in each state are supported and report the program results along with statistical and business results to the Territorial office.

The Salvation Army had conducted ministry to women, by women, for women for over 100 years. The original purpose of a women's organization was to help young mothers care for family needs and to give support and mentoring through the influence of others. This has not changed through the years even though our methodology has adapted to the changing society.

Women's Ministries has been an area of vibrant activity and witness for the Gospel. The most recent surveys show a membership world-wide of 500,279. In the Australia Southern Territory our recorded membership is 11,719. These statistics include our various programs that include The Home League (focused on older women), Bible study groups, craft classes, educational opportunities, nurture groups and our most successful programs of Playgroups and Mainly Music. During 2009, 307,901 attended our programs.

There has been good growth in our attendance and memberships. We attribute this growth area in relationship to our outreach programs to young families through the Playgroup programs and Mainly Music. Our primary focus is on the mothers and grandmothers who accompany their children/charges to our weekly programs. This is paying great spiritual dividends and we are making good connections with our worshipping communities through this outreach. The main focus would be on "Friendship Evangelism". We have connected with many women who have needed friendship and in turn are discovering some of the deeper needs of their hearts.

We have been delighted that through this ministry, 908 families have been linked to our corps (worship centres) and many women have found their way to a relationship with Christ. Some of these women made first-time commitments to God and have found salvation for their souls. Opportunities are given in various venues to tell the stories of Jesus including retreats and camps.

One new resourcing tool developed in 2008 was the women's ministries website which has allowed for new ways to get available material to our women leaders. The website is [www.salvationarmy.org.au/women](http://www.salvationarmy.org.au/women). This addition to our material has allowed us to communicate regularly with our field operations and help to resource their needs as they arrive.

Leader development has been a thrust during the past two years with opportunities for our women leaders to up-skill themselves. Training has been offered not only in areas of ministry, but also in areas of administration. This has been well received.

The opportunities for ministry are endless to us. The most encouraging side of our ministry to women is that it is conducted by God-loving women who are anxious to see the Kingdom of God established here in Australia.

## **UNITING CHURCH ADULT FELLOWSHIP *"For such a time as this ..."***

The Uniting Church Adult Fellowship (UCAF) has, through its members been very active in the life of the Church and many communities in the last three years.

The National Committee's role is to plan, coordinate, and facilitate activities for its members under the approved Mission statement –

*"To facilitate the network of Adult Fellowships nationally in order to promote the mission and witness of the Uniting Church in Australia."*

In the 2006–2009 triennium the National Committee has been based in Queensland. Through the leadership of Mrs Alyson Madsen (President) and the committee much has been accomplished throughout Australia and in other parts of the world.

In her report to the Twelfth Assembly of the Uniting Church, Mrs Madsen said, "There are approximately 18,000 members nationwide; who bring diverse gifts, are extremely loyal and committed to the service of the church. Arguably, they are the "glue" which holds many congregations together. Each fellowship group brings together members for spiritual, social, educational, recreational, service, and mission support activities." These activities are organised at local level and report to their State's Synod Committee.

The National Committee has a coordinating role with the Synod Committees. Nationally we are linked with, relate to, and pay affiliation fees to two world bodies: the World Federation of Methodist and Uniting Church Women (WFM&UCW) and the World Alliance of Reformed Churches (Department of Partnerships of Women and Men). Our Ecumenical Liaison member has corresponded with our thirty-three partner churches in the Pacific, Asia, India and Africa.

The theme for the triennium was "Let the Son Shine Through" and each affiliated group was challenged to use the theme in such a way that the Uniting Church could exhibit the love of God to the wider communities in which they live. This, in fact means, in excess of 18,000 women and men are witnessing to the people of Australia.

Some 2,400 rugs (approx. 48,000 squares) 'were created, as members of fellowship groups throughout Australia were encouraged to knit, crochet or sew a square from warm material' for the major project. The squares became rugs of all colours, sizes and textures to be distributed through Uniting International Mission and other agencies to people in many situations including – orphanages in Russia, Uganda, Mongolia, Zambia, Shi-Loh Church ministry; the Papua New Guinea Cyclone Appeal; Nan Province, North Thailand; fire victims in Nepal and Kinglake; in PNG Highlands; Cambodia; to Solomon Islands (for new born babies); World Vision; to Equestrian Group Members isolated in Warwick (Equine Flu); as well as many agencies/people in Australia.

Nine Australians were amongst 2000 women who attended the conference of the World Federation of Methodist & Uniting Church Women held (May 2006) in Jeju Island, Korea. At the Conference the Australian contingent agreed to embody the eight Millennium Development Goals of the United Nations and encourage all Fellowships to incorporate at least one of the Goals into their annual program.

Alyson Madsen joined a Uniting Church Assembly team of delegates to the World Methodist Conference in Seoul, a gathering of some 3,500 Christians from all over the world to experience diversity of spiritual expression, challenges confronting many countries, expressions of faith, daily worship and fellowship. In practical support for our prayer partner, the Solomon Islands, Pose Telasasa accepted an invitation to join with us at the World Assembly.

During September 2008 thirty-four Australians attended the South Pacific Area Seminar of the WFM&UCW held in Tonga with a number of our Solomon Island and Thursday Island friends accepting an invitation to join us. Ann Connan (Victoria), currently Vice-President of the South Pacific Area of WFM&UCW, provided leadership in the Bible Studies.

The National Celebration held in the early part of the triennium and the National Consultation at the close provide opportunities for people across Australia to gather. At the Consultation (May 2009) the 2009–2012 National Committee from the Synod of NSW and ACT was introduced and commissioned.

Greenhills Centre, Canberra, is the venue for the National Celebration to be held from 21 – 25 April 2010, picking up the theme *'For such a time as this...'*

## WORLD DAY OF PRAYER AUSTRALIA



On Friday 2 March 2009 there were 1,248 World Day of Prayer (WDP) services held throughout Australia. (NSW = 400, QLD = 213, VIC = 302, TAS = 52, WA = 121, SA = 160) This is almost the same number as last time we reported to ACW in 2007. This year's service was written in Papua New Guinea with the theme "In Christ there are many Members but One Body"

### **Coming author countries and themes** for the annual service are:

2010	Cameroon	Let everything that has breath praise the Lord
2011	Chile	How many loaves have you?
2012	Malaysia	Let justice prevail

This year I had the wonderful privilege of attending the main service held in Port Moresby and of being with our WDP sisters on their special day. Since then WDP Australia has funded the purchase of a printer for PNG Christian Women who organise the World Day of Prayer services. A proposal will be put to our coming National Meeting that we fund two airfares each year for PNG Christian women leaders to travel to a province to conduct WDP training days.

### **Quadrennial National Meeting**

Our next National Meeting will be held at the Holy Cross Centre at Templestowe in Melbourne from November 13<sup>th</sup> – 15<sup>th</sup>. Should you have any matters about World Day of Prayer that you would like to have considered at that meeting please submit them to me as soon as possible. For the first time we expect to have representatives from the two Commonwealth Territories present as well as the customary two representatives for each state. The National Liaison Officer from the newly constituted New Zealand National World Day of Prayer Committee has also been invited to attend as our guest. My term as National Liaison Officer will terminate at that meeting and Mrs Barbara Arnold from Adelaide will be elected to replace me.

### **WDPIC mid term – September 2009**

The mid term meeting of the World Day of Prayer International Committee (WDPIC) will be held in New York during the first week in August. Vaieli Fuiono Piita from Tuvalu, but currently resident in Fiji, and I will represent the Pacific Region. The main task of the meeting is to plan the next quadrennial International Meeting but several other agenda items are also listed.

### **Pacific Workshop**

As one of the two Pacific Representatives on the WDPIC last November I visited Fiji to assist with the running of a four day workshop for WDP leaders. The Executive Director of WDP, Eileen King, who is based in New York, led the workshop. The other Pacific representative, Vaieli Fuiono Piita from Tuvalu, but currently resident in Fiji, also assisted. This workshop was a training experience for Vaieli and myself I and it is planned that we run a similar workshop in another Pacific country next year and in coming years, as funds and other resources permit.

Vaieli represented WDP at the most recent bi-ennial Conference of the Pacific Council of Churches Conference in Samoa. It is planned that we have a presence and display at each of these conferences in the future. We may have the opportunity to run a workshop at the next one. Vaieli was also funded by WDP Australia to visit New Zealand this year and while there was able to contact many of her country women from Tuvalu and encourage them to actively participate in WDP in NZ.

Rationale for Motion 1:

***ASSOCIATIONS INCORPORATION ACT 1991 - SECT 16***

**Matters preliminary to incorporation**

An association or a group of 5 or more persons proposing to form and incorporate an association may, by resolution—

- (a) authorise a person who is at least 18 years of age and who resides in the ACT to apply for the incorporation of the association or proposed association; and
- (b) approve a statement of the objects of the association or proposed association for the purposes of the application; and
- (c) adopt rules of the association or proposed association, being—
  - (i) the model rules, as in force from time to time; or
  - (ii) rules other than the model rules, being rules that comply with section 32; and
- (d) appoint at least 3 members of the association or of the group proposing to form and incorporate an association to be the inaugural members of the committee of the incorporated association if the application is successful.

***ACW 2007 CONSTITUTION CLAUSE 8***

## MOTION 7

SA Unit moves:

(A) That Australian Church Women meeting in conference in Canberra requests the National Executive of ACW to approach the Minister for Indigenous Affairs for a detailed plan of how the Government intends to close the gap on Indigenous disadvantage within a generation.

(B) To ensure that funding is guaranteed for the stated targets, i.e.:

- to halve the literacy, numeracy and employment gaps within a decade
- to halve the gap in infant mortality within a decade
- to close the approximate 17 year gap in overall life expectancy within a ~~decade~~ *generation*

### RATIONALE:

- It is a sad fact that the life expectancy of Indigenous Australians is around 17 years lower than that of the Australian population.
- In 2006 the unemployment rate for Indigenous people was 16% compared with only 5% for the non Indigenous population.
- In 2004-2005, 27% of Indigenous people were living in overcrowded conditions.
- Indigenous people are more likely to experience homelessness than other Australians.
- Indigenous people are more likely to experience domestic violence than non Indigenous people.
- Finally Indigenous people have also suffered from limited recognition and protection of their cultures, languages and rights and ownership of land and resources.

Regarding health alone, although in November 2008 the Council of Australian Governments committed \$1.6 billion in new health funding – the largest increase ever for Indigenous health – the statistics on are compelling: around twice as many Indigenous infants died before their first birthday compared with non Indigenous infants

Cardiovascular disease is around 2.5 times higher for Indigenous Australians, respiratory disease is almost four times higher and pneumonia three times higher. (NACCHO CEO Mr Mick Adams in Oxfam media release March 09.)

The minister responsible for FaHCSIA is the Hon Jenny Macklin MP.

## MOTION 8

National Executive moves:

That Australian Church Women meeting in Conference in Canberra write to both the Federal and State Attorneys-General requesting them to consider adopting "safe surrender" legislation ensuring the protection of newborns.

**RATIONALE:** Ten infants are abandoned in Australia each year. The figures could be much higher as the numbers reflect only the babies that are discovered and reported in the media.

Safe surrender laws operate in Germany, Italy, Japan, Hungary, Austria and the US where a mother can leave her baby at a hospital or other safe place without legal penalty. Child abandonment is a deeply saddening response to what must be a very traumatic event for a mother who feels she is left with no other option but to relinquish her infant.

Presently in Australia abandoning a child is a criminal offence and therefore, a mother or a father who abandons a child can face criminal prosecution. As long as the mother is treated like a criminal we will continue to see many more babies left at rubbish tips, public toilet blocks etc to perish from exposure to the elements.

Last September, Senator Helen Polley proposed that Safe Haven laws be introduced in Australia to offer a mother/father a safe means of relinquishing a baby under tightly controlled guidelines.

## MOTION 9

Members of National Executive of ACW meeting in Conference respectfully bring to the attention of the Minister for Health and Ageing, Nicola Roxon, our concern regarding the excessive alcoholic content of drinks such as *Bacardi Cruise*, *Lemon Ruski*, *Pineapple and Coconut Rum*, and *Vodka Raspberry*. They have the appearance of a harmless soft drink but, in reality, these drinks contain between 5–7% alcohol. (A light strength beer usually consumed by males contains only 2.5% alcohol, and a can of full strength beer contains 4.7% alcohol.)

**RATIONALE:** Young girls are being particularly targeted by the liquor industry in their presentation of these drinks. The bottles appear to contain soft drink and the colouring suggests that they are soft drinks. The contents taste like soft drink. Most young women would be oblivious to the strong alcoholic content of these supposedly harmless drinks presented to them as an alternative to stronger alcoholic beverages. It has been established that females have a much lower tolerance to alcohol than males.

Alcohol is a very addictive drug. In the past few years calls to the Family Drug Support hotline by concerned parents worried about alcoholism have increased by 11%. Fifteen per cent of the 25,000 calls to the hotline last year were alcohol related with the overwhelming majority concerned about their teenagers binge drinking.

Consuming only two of these “lolly drinks” by young women could cause drunkenness, changes in consciousness, mood and emotions. These intoxicating and psychoactive effects lead to many accidents, injuries, diseases and disruptions to family life.

#### **ITEMS FOR DISCUSSION**

NSW Unit asks:

1. Whether Orders of Service for Special Days can be varied to suit the needs, age and culture of the community where they are being used
2. Whether an ideas page should be submitted with each Order of Service for Special Days prepared, giving suggestions for alternate worship styles to which the service may lend itself.
3. That consideration be given to the venues, costs and types of accommodation for future National Conferences. What are the expectations of those likely to attend?
4. Concerning Public Liability Insurance for Australian Church Women. Can there be cover on a National basis with States contributing?

## **PROFILES OF INCOMING NATIONAL EXECUTIVE**

### **Margaret Leighton Flint OAM, BA, Dip T (Prim) – President Anglican**

I was born at North Kensington, South Australia in 1945, with my early years spent at St Peters. My education was at East Adelaide Primary School, Girton Girls' School (now Pembroke), Wattle Park Teachers' College and University of Adelaide.

My Christian faith journey commenced at All Soul's Anglican Church. St Peters Consequent on the family move to Norwood in 1951, I became part of the third generation of my family to worship at St Bartholomew's Church. I attended Sunday school, as a student, then teacher and later as superintendent. I was involved in the Girls' Friendly Society branch as a member and then as leader.

Service in the Parish of Norwood until 2003 included as People's Warden, Member of Committee of Management, Parish Council, Synod Representative, Lay Assistant, Lay Reader and Parish Secretary. Later I was involved with GFS at Diocesan level as a State Executive member, leader in State and Vacation Day camps, and State Leader Training Officer. I attended the GFS World council Meeting in Japan 1984.

I was a primary school teacher with the Education Department of South Australia for over thirty years. 1972-74 I took leave to serve through Australian Volunteers' Abroad. I lectured at Balob Teachers' College, Lae, PNG, was Dean of Women 1974 and a member of the Anglican College community.

Advent 2003 I joined the worshipping community at St Aidan's, Payneham, where I have served on Parish Council 2004–, as Lay Assistant 2004– and People's Warden, October 2004–07. I attend a monthly Home Group, the parish Education for Ministry Group, Meditation Group, produce the weekly pew sheet and am Parish Contact for SACC, ABM-A and EAC.

Wider church and Diocesan involvement has included attending 1995 General Synod Meeting; a member of Diocesan Council (1989–2003), Anglican Board of Missions - Australia Provincial Committee (SA Lay Board Member 1998-2000), Anglican Board of Christian Education (1988–2000), Provincial Council (1995–), Ecumenical Affairs Commission (1995–, Chair 1998–), an Anglican representative to South Australian Council of Churches (1998–2008).

I have been active in women's affairs for many years. I was a GFS Delegate (1985-87) to National Council of Woman SA, Inc and then became an Associate Member. Since then I have been an Executive Member, Vice President, Membership Secretary, President Elect, Acting State Co-ordinator, Newsletter Editor, President and NCWA Board Member (2000–03). I have represented NCW SA on WIS Support Group, ACCC Consumer Consultative Group, IWD Luncheon Committee and numerous sub-committees e.g. Nominations, Constitution.
