Doreen Tie is a young woman, twenty three years of age who has been working with intellectually handicapped children in a special school in her home city of Kuching. She will be coming to Sydney to study specialised teaching of intellectually handicapped children, with the Developmental Disabilities Services Training School, and also do some practical work with the special schools servicing these children . . .

## Winifred Kiek Scholarship

THE purpose of this scholarship is to provide supplementary training for a Christian woman from the Asian, Indian or Pacific Areas. The Scholarship is intended for a woman who has already received her basic training in her chosen field of work. It is hoped she will return to her own country to give leadership in Church and community.

No age limit is set but it is preferred that applicants be between 25 and 35 years.

The Scholarship is available annually where possible, and tenable up to ten months (one academic year). It is also available for shorter periods. The Scholarship covers fares, tuition fees and accommodation costs.

## Home of the 1990 Scholar

SARAWAK is the largest of the thirteen States that make up Malaysia, covering an area of about 124,000 sq.kms. and stretches some 700 kms along the north-west coast of Borneo. Following World War II, Sarawak became a British Crown Colony and in September 1963 joined the Federation of Malaysia. The City of Kuching is the economic and political centre of the State. It is a country of many waterways and rivers.

Sarawak is a multi-racial society of 1.5 million people with over 23 ethnic groups. Although Islam is the official religion, the people do enjoy religious freedom — Christianity, Buddhism and Hinduism are widely practiced.

The country's economy is largely dependent upon its rich natural resources, particularly oil, liquified natural gas, timber and the famous Sarawak black and white pepper. There is also development in agriculture, commerce and industries as well as exports of coconut oil, rubber, palm oil and cocoa beans.

## National Convener of Winifred Kiek Scholarship

Each state/territory unit of Australian Church Women appoints a W.K.S. convener to encourage involvement in Fellowship Day Services, and distribute leaflets to each unit.

## Fellowship Day

FELLOWSHIP Day Services are held in various centres in July of each year and the offerings devoted to the Winifred Kiek Scholarship. Offerings are invested and the interest is used to finance the Scholars.

## Funds

APART from the Fellowship Day offerings, donations are encouraged for the Scholarship, and can be made at any time to the Winifred Kiek Scholarship Fund. All donations should be forwarded to your Unit Treasurer with specific details. (see back page).

## Winifred Kiek Fellowship

THE purpose of this Fellowship is to benefit Australian Church Women by giving them inspiration, knowledge from outstanding Christian women visiting, studying or residing in our country.

Funds will be available tri-ennially or at the discretion of the National Executive of Australian Church Women (on advice from the Winifred Kiek Scholarship Trustees) to provide fares, honoraria and accommodation costs for the recipient to tour Australia to speak to Church and community groups.

A fellowship will be awarded to a Christian Aboriginal woman as soon as funding is available. This recommendation was passed at the Australian Church Women's Conference, Adelaide, 1987.

## Australian Church Women Memorial Bursary

CONTRIBUTIONS are invited to this fund as a Memorial to Christian women, particularly those associated with the work of Australian Church Women. The contribution is to be accompanied by a brief outline and photograph of the life of the woman so honoured and this will be recorded in the Memorial Book.

The funds are invested by the Trustees of the Winifred Kiek Scholarship, and the interest so gained to be used to provide books for the current scholarship holder. When this Bursary was established it was envisaged that interest would build up towards a second scholarship.

All contributions for the Bursary can be given to your Unit Treasurer (see back page) together with the brief outline of the life of the woman being honoured.
