


**AUSTRALIAN CHURCH WOMEN**

Lyn Smith, Social Justice Convener, SA Unit attended & reported that they briefly explained the changes to the Human Rights jurisdiction and the new role of the Federal Court and gave detailed information of rules and procedures. The changes (came into force on 13 April 2000) were to effect a smoother transition of proceedings, especially for those involved in the legal profession.

- 1(8) NSW Unit's concern re gambling; m.Barbara Grealy, s.Dorothy Ferrier that a letter of support and congratulations be written to Nick Xenophon MLC in his continued stand against gambling, and a letter to congratulate Dean Brown, Minister for Human Services for his proposal to cap the number of poker machines - copies to be forwarded to Premier John Olson. **Agreed.** (The Conference enabled many people to express their concerns and experiences in this public arena.)
- 2(10) The Gale Group, producer of Encyclopaedia of Associations, International Organisations sent a form for an update of ACW Nat. Exec (free listing in previous issue) - **Agreed** to update.
- 3(12) Cards sent to Margaret Napier, Olive Dell, Pat Smeeton & Vera Wilson.
- 4(13) Australian Community Faith Nurses - Secretary to write that this group be added to the comprehensive list.
- 5(14) Quote from Vic Unit Minutes - **'Five Minute Focus'**; B Webb reported that she had visited ACW in Canberra & attended World Com. Day Service. It was reported that Lieut-Colonel I Macintyre has improved a little but needs more surgery. B Lacy read E-mails from L. Green, 7 Feb, "Enjoyed my time in London. We have arrived & are in the process of settling in." 14 Feb, "3,500 attended the welcome meeting & installation of the Territorial Commander. My little speech ended in a couple of sentences in Kiswahili & it went down really well. The service went for 2 1/2 hours."

## REPORTS

### 1 **Publicity - Barbara Grealy**

A short report has been sent to these Church papers - "New Times", UCA; "Adelaide Church Guardian", Anglican; "Southern Cross", Catholic; "Baptist Newsletter" & "Churches of Christ Newsletter".

### **Social Justice Convener - Mavis Ellis**

I have written again to all Unit Social Justice Conveners and to secretaries where no Convener has been appointed including Darwin & Alice Springs Branches. I included the report from the "Southern Cross", Dec.1999 by three Adelaide YCSM students who attended the Fairwear Candle-light Vigil, also a copy of Manifesto 2000 for a Culture of Peace and Non-Violence and information and postcards for the World March of Women 2000. I requested information about what actions they are taking and await with interest to see if I receive any more replies this time.

Our SA Unit convener, Lyn Smith (see her report under Business Arising from the Minutes No.10) is certainly doing her bit. Lyn has read a booklet entitled 'Taken In' issued by the 2000 Women's Legal Services outlining problems arising when women with dependent children are taken into custody. Currently there is no policy detailing appropriate action to be taken by police offices when arresting a person with dependent children although there are instructions on the appropriate action to take when arresting an offender with a pet! The report makes 21 recommendations. Many of the prisoners with dependent children who were interviewed were aboriginal women.

Unfortunately I was away when the Jubilee 2000 'Who is Fooling Who?' demonstration was held on 1st April. However the handout advertising this event has some alarming information about the effect of western countries' control over debt owed by developing countries. 'One thing is certain, Debt has been killing millions and will continue unless we act. Their debt is equivalent to a small fraction of a day's trading on the world's currency markets. ONLY OUR GREED IS KILLING THESE PEOPLE.' It is to be hoped that recent news of a commitment by the World Bank & the International Monetary Fund to address this problem will have some effect.

Unifem Australia's Year 2000 Project is to support survivors of violence against women in East Timor - surplus from the 8th March breakfast will given to this. Rev Professor James Haire, President-elect of the UCA has just visited Indonesia (he served 14 years as a missionary there) and reports that Christians have been driven out of several islands and extremists are planning a holy war to drive them out of other islands. We are asked to pray for the Peace Conference called by President Wahid.

The report from the Round Table Consultation arranged by the Equal Opportunity for Women in the Workplace Agency which Marj Dredge and I attended last December has been received including an invitation to join a Client Reference Group.
