On behalf of the widows, and the women who have not been able to afford a dowry which would make their marriages come into the realm of possibility, I would like to thank you for the generous gift of Taka 4,912 (Four thousand Nine hundred Twelve). This money will be used for further scholarships for training these women who have to depend upon their own handiwork for a livelihood for themselves, and in the cases of the widows, for their children.

Here at the Jagaroni Women's Cooperative Centre, these ladies are trained in the skills of weaving bamboo, creating various beautiful articles in jute, and in both machine and hand sewing. These articles are sold in the local stores for fancy work and are also exported.

Thank you again for your generous gift which will be a tremendous help so that these ladies may stand on their own feet. We ask you also for the spiritual help of your prayer. God be with you.

Dear Mrs. Connell,

Thank you very much indeed for your letter of Feb. 15th with the news of the A\$ 900 gift to the Scholarship Fund for support through their studies of Dewi and Endang Lies Heriantini. We were very thrilled indeed to hear of this and do want to express our very grateful appreciation. In our Scholarship Committee meeting this last week concern was again expressed over their very genuine need and financial difficulties so your gift comes as a very wonderful provision.

We are writing to the Bank Bumi Daya, Jakarta to let them know transmission details for forwarding the money to us. We also hope that Dewi and Endang will write to you again themselves though the thought of writing a letter in English is a bit overwhelming to them. Because of the limited amount and range of technical material in Indonesian most students can read at least some English-albeit rather slowly and painstakingly with much reference to a dictionary, but active conversation and correspondence in English tends to be a different matter!

Angela Hope is now on leave and undertaking further studies in guidance and counselling in America. So I have taken over the English language correspondence for the Committee for this year. I am also from Australia (Adelaide and Melbourne) and more latterly from New Zealand and teach in the Theological Faculty here.


About the women you mentioned for the South East Asian Conference, I don't know Winnie Callen. I know Faith Bandler personally and well but would advise against nominating her. There is no doubt about her ability to contribute to the Conference but my main reason for suggesting a "re-think" would be that she has no future leadership role with Aboriginal people. She was the National Secretary for the Federal Council of Aboriginal and Torres Strait Islanders but was in April this year voted out of her position by the F.C.A.A.T.S.I. Conference in Brisbane. This was the outcome of her declining influence for some time. I may have left this too long to write to you but I would think Rev. B. Clarke or Rev. Gordon Symonds from the United Church in Darwin should be able to nominate someone. I should add that Faith has no Church affiliation.

I wish I could help about the funds for Kalpana to go to New Zealand but it is not easy to find money for this kind of thing.

Thank you for the letter inviting me to go to Adelaide for the W.C. meetings. I am enclosing a copy of my acceptance which I sent to Deaconess Norris. Your letter to Frank Engel arrived when he was overseas, hence the reply from David Parker. I believe the A.C.C. representatives will be decided at the General Meeting in Melbourne in August.

Dear Friends,

It is some time since we have been in touch with you, but I believe you have in the past had an interest in Malmaluan Training Centre, Rabual. The Centre is one of the training institutions of the United Church in Papua New Guinea and the Solomon Islands.

Malmaluan changes as the situation in Melanesia changes, but our aim remains the same: to train men, women and young people to be effective Christian leaders in Papua, New Guinea, the Solomon Islands and the Pacific.

The two year Christian Education course continues, training young people to work in village and urban situations. We are currently conducting the last residential three month lay training course for village men and women. In future most lay training will be conducted within Regions with the assistance of Dept. of Christian Education staff. In this way we expect to involve a large number of people and to relate training more effectively to specific local situations.

Next July we are looking forward to welcoming new staff who will lead a series of specialist Christian Education courses initiated by the Pacific Council of Churches. Candidates for these courses will be mature and experienced Christian educationists from the whole of the Pacific. The courses will use the facilities at present serving the residential lay training groups.

At present there are far more suitably qualified young people applying to train at Malmaluan than the United Church is able to finance, although we have enough room for them. We find it very hard to have to refuse them simply on financial grounds; the Church thereby loses some potentially valuable leaders.

We are making every effort to find funds for our training schemes from within Papua New Guinea and the Solomon Islands, particularly from the local circuit level where Malmaluan graduates serve. At the same time we still value and need the support of overseas friends.

I am enclosing copies of the Malmaluan brochure for your interest, and we hope that some friends will be in a position to express their interest through a financial gift. We will send photos of the student supported to overseas friends and encourage the student to keep up personal correspondence with them. Please let me know if you can make use of more leaflets.

I have not had an opportunity to consult the historical document, which as I heard at the A. C. C. Headquarters, I have not yet really begun work as an archivist because I am only just now retiring from a full time job. So I am working from memory, but in the next few weeks I hope to collect the documents and bring them home.

1. Yes, World Community Day originated in U.S.A. It was organized by the "United Church Women" which has now become "Church Women United."

2. I think that it was in 1962 that World Community Day was first observed in Australia. It was during the period when the Federal Committee was operating from Sydney.

3. ~~No, with~~ No! A. C. W. has not followed the theme of Church Women United. Themes applicable to Australia have been chosen. The programmes have been planned by different groups in different states.

4. I do not know whether similar themes or orders are used in different countries. I doubt if this is so.

5. Yes. World Community Day is as closely related.

6. It was thought advisable to have on special day to receive fellowships of the Test Coin gifts.

Because Fellowship of the Test Coin originated in Great Britain and now embracing people all round, World Community Day seemed an appropriate time.

After Deaconess Simmons had presented the Winifred Kiek Scholarship report, it was evident that further funds would be needed to enable Kalpana to complete her course and future visits within Australia and the proposed visit to New Zealand. It is envisaged that an extra \$600 will be required if Kalpana is to visit New Zealand. The Van Leer Project under which Kalpana is studying, has progressed further amongst Maori people and it would be more beneficial for a visit to New Zealand, rather than Darwin, especially before leaving for home.

No other scholar has visited another country whilst studying in Australia, but Mr. Gray (Sydney University) who is supervising Kalpana's course, has strongly recommended the proposed visit. He feels that Kalpana and in future her people, will be the richer for this experience.

I fully realise that this is not giving a great deal of time for publicity, but it would be appreciated if this matter could be treated as urgent.

We are anxious to receive any comments you may wish to make, as your support with this venture will determine any future planning for Kalpana - thank you.

When it is convenient, I would appreciate the names and addresses of all the members of your Federal Executive, for future reference - thank you.

It is estimated that 400,000 women were left widows by the fighting and the atrocities which accompanied it. By custom, these women would in most cases never marry again.

Centres have been opened where girls and women could be trained in local handicrafts. Those trained then go out to train others. Other girls are trained in clerical work. The complete rebuilding of the business structure of the country has created a great demand for trained office workers.

The Director of the programme estimates that from 20 to 30% of the women war victims have been rehabilitated.

Our National Director has received from Mr. Parker of the Australian Council of Churches staff your queries re the CHRISTMAS BOWL APPEAL. Mr. Arblaster has asked me to reply to them.

I am happy to do this, and will. But I may be able to be even more helpful to you if you were able to tell me what queries lie behind the questions which were asked. Were the ladies wanting to help promote the appeal or use our materials for another purpose, or what?

For now, to answer the questions you asked...

- * THE CHRISTMAS BOWL APPEAL is the way in which the World Christian Action Division of the Australian Council of Churches launches its annual appeal for funds. The appeal has been conducted in Australia since about 1948. World Christian Action was formerly known in Australia as Inter-Church Aid. We operate as part of the programme of churches round the world which is co-ordinated through the Commission on Inter-Church Aid, Refugee and World Service of the World Council of Churches.
- * World Christian Action in Australia raises most of its money through the CHRISTMAS BOWL APPEAL. The other regular source of funds is our FORCE TEN regular-giving scheme, which we operate now in partnership with Australian Catholic Relief.
- * THE CHRISTMAS BOWL APPEAL is a national programme. Promotion materials are prepared by the national office for use in all states. Promotion materials are prepared for use by adults and children. These are in the hands of State Secretaries by August. Each State Secretary has his own schedule and method of distribution of the materials.
- * No order of service is prepared normally. A Ministers kit of

promotion ideas, sermon illustrations, children's stories, pulpit announcements, articles for church papers is prepared.

* These days, we decide after the money has been raised just what will be done with it. This is to work in with our W.C.C. programme, to make sure that the money can be sent as soon as Geneva approval for the project has been gained. There are, of course, several projects which we know we will be supporting/

Within Australia, probably \$50,000 will be spent in refugee resettlement and migrant welfare.

About \$20,000 will go to the Australian Volunteers Abroad programme to help young Australians serve overseas.

At least \$50,000 will go to the programme of Asian Christian Service, working amongst refugees in Laos, Vietnam and Cambodia.

These are just three I can think of.

* We know now the theme for our 1974 appeal, and by April next year the final form of all the promotion materials associated with it will be agreed upon.

Rev. Chris Mackaay of your State Council of Churches office at 33 Pirie Street would be happy to give you a sample copy of all the promotion materials we have provided this year.

I will be happy to answer any further questions you might have, either this year or when I am attending the A.C.W. meetings in Adelaide next February.

Being responsible this year for both our National promotion and Victorian office operations, life is hectic for me. It also means that I will be out of Victoria for about half of the time between now and Christmas, visiting Queensland, N.S.W. and Tasmania. This means that I might not be able to answer your letter immediately it arrives at this office. I work on a plan of one week at home and one away.

Re World Community Day Project

Our National Director has been waiting for the new 1974 project list from Geneva, so he could provide the most up-to-date information to go with our suggestions for Community Day offering project in 1974.

The list has not as yet arrived, but working from other information available, he has asked me to make some suggestions.

I would suggest one of two projects with which I have had a personal link. These are both on the W.C.C. listing, and churches from all round the world are helping with them. They both need additional money.

EITHER THAILAND LEPROSY PATIENTS

A resettlement programme for negative leprosy patients who have been treated through the McKean Rehabilitation Institute at Chiangmai in Northern Thailand.

The request is for funds to buy land and provide basic living and work facilities for 300 cured leprosy patients, as part of a new rehabilitation plan.

The project is described in more detail in the enclosed FORCE TEN Action Sheet.

Several Australians work at McKean.

I have visited there. No shortage of information.

OR HONG KONG Kwun Tong Community Health Project.

The request is for funds for a health education unit and three health centres.

The churches together in Hong Kong have erected a new hospital for this industrial and housing area, built on reclaimed land in the last ten years. The hospital is interested in prevention as well as cure.

The project intends to improve general health standards for its 500,000 residents by developing better health attitudes within the community.

When I was in Hong Kong in 1970, I interviewed the planning officer, and brought back a tape in which he explains there hopes. A transcript of that interview is enclosed.

Since then, the hospital has been completed, and work can start on the prevention side of the project.

No shortage of information.

The need for money is great in both instances, and we know that the small amount of money ~~XXXXXX~~ which might come in from the offering can be used. The Hong Kong project still needs over \$7,000. The Thai project needs over \$150,000.

I can talk about both projects and illustrate them.
