REPORTS:

Fellowship of the Least Coin:

Mrs Strack reported that she had received a copy of the book 'In Quest of the Least Coin'. She was negotiating with the Presbyterian Bookroom as to the possibility of importing copies in time for the National Committee Meeting. The new leaflet was under way. One bundle of Circle of Prayer Vol. III still on hand.

Publicity:

Mrs Coates read through material prepared for the next news sheet. This would be completed and duplicated to be sent out.

United Churches: Mrs Faichney reported that she had visited the W.A. Unit of A.C.W. which was very active in its work. Community work in homes etc. was done on a monthly basis. New churches would be established at Francis Creek and Gove in the new year. Discussion took place as to the position of the United Churches in relation to A.C.W. It was decided to continue discussions at the National Committee Meeting. United Churches already contacted to be invited to send observers to the National Committee Meeting.

Ball Point Pens:

Mrs Col. Saunders reported that \$72 dollars was in hand from sale of pens.

WINIFRED KIEK SCHOLARSHIP:

Mrs Durton reported that a meeting of the Committee had been held, Thursday, 20th November when FOURTEEN applications had been considered. All applicants had been worthy of assistance and the Committee had short list of four names to be submitted to the Working Committee. Cost of fares had been considered and the opportunity applicants had had to engage in further study in their own country. It was resolved to offer the Winifred Kiek Scholarship to Miss Veronica Kafa, of the British Solomon Islands to continue study in education in Australia. Miss Kafa is 25? and will seek further training in the teaching of English. She is Anglican. It was decided to include brief details of all applicants in the Working documents so that members might see the number of women seeking help in further training. The question of the application from Captain de Fretes of Bandung, Indonesia would be pursued with Inter-Church aid. Investigations would be made into the possibility of accepting more than one person if help could be given with fares etc. Mrs Durton was asked to continue work on the course of study, place of residence etc, of Miss Kafa.

WORLD COMMUNITY DAY 1970:

Mrs Col. Saunders presented questions to be added to the Order of Service. These were accepted. It was resolved to support Life Line Centres in Seoul as the project for 1970 World Community Day.

NATIONAL COMMITTEE
