


AUSTRALIAN CHURCH WOMEN

3 Social Justice - Mavis Ellis

I have written to all Unit Social Justice Conveners and Secretaries of NT branches with 1) a copy of a letter from Homeworkers Code of Practice re 'No Sweat Shop Information Campaign'. This seems to be an issue for State Units/Branches rather than the National Executive and I have reminded them all that it was a decision of the National Conference to support the Fairwear Campaign.

2) a recommendation that they contact the Council for Aboriginal Reconciliation for a copy of 'Corroboree 2000, Towards Reconciliation' and 'Roadmap for Reconciliation' and make a commitment to the questionnaire in it. (I found it difficult to make commitments on behalf of the National Executive as we are in office for only another year but replied that I would encourage the Units/Branches to do so. I hope that we would all make a personal commitment).

3) a copy of Jean Thomson's report on the ACT workshop she attended (reported last mtg)

4) a report on the Coalition for Justice for Refugees workshop (reported before to N Exec).

The insight program on SBS last Thursday night was on the situation at Womera and amongst those interviewed were Farhad Noori employed by the SA Council of Churches to assist refugees brought to Adelaide and Scott Litchfield of UCA World & Cross Cultural Ministries. Unfortunately I didn't have the presence of mind to tape it. I intend to write personally to the Prime Minister about some of the issues raised.

Please be aware of - A scam targeting females in particular purports to be from the Post Office asking for confirmation of their firm's postcode. When given, the person is told she is eligible for gift vouchers and her home address & postcode is needed to receive the vouchers. 90% of women who have given this information are burgled (it is assumed no one will be home during the day).

Also - you may receive a phone call from someone claiming to be an AT&T Service Technician testing the line and that you should press 90# and hang up. **Do not do so** - it gives full access to your phone line to place long distance, international or chat-line calls billed to your account. (Police have information that suggests many of these calls are emanating from local jails)
