Re: "Wybalena" Fund.

Your letter of the 31st December last addressed to the writer, Mrs. M. Millar, and Mr. J.F. Dey, Trustees of the "Wybalena" Fund, is hereby acknowledged. I also acknowledge receipt of the Opinion of Mr. R.G. Henderson, Q.C., of the 21st November last enclosed therewith.

I am perfectly aware that Mr. Dey, one of the Trustees, is in favour of the decision of the members of your Council, but you are doubtless also aware that Mrs. May Millar, who has been the active Trustee in this matter over the years, is in favour of the Dunmore Lang College and that with her view, the writer concurs.

The reason for this view has already been advanced and this view is also supported by the opinion of Mr. John Kearney of Counsel which was forwarded to you on the 26th September last. In my letter to your Council enclosing this Opinion, I quoted the final words of his advice - "Therefore I would advise that on all counts, the final decision as between the suggested donees should be in favour of the Dunmore Lang College."

In view of the difference in the Opinions now presented, it seems clear that the appropriate course would be to place the matter before the Court for a decision which would protect the Trustees and in regard to which all parties would, of necessity, be bound.

I have conferred with Mrs. Millar and we will jointly instruct Messrs Hunt & Hunt to engage Counsel to make the necessary application. In respect of this matter, you will therefore be further advised.

Under these circumstances, your instructions to hand over funds will be dealt with when the Court makes the decision and in the meantime, you can be well assured that the major portion of the funds is usefully employed in gaining interest on a Trustee security which will be readily available for the ultimate benefit of the final recipient and which in the meantime is earning good interest. The actual details can be made readily available.



Having carefully considered all the information available we have concluded that the purpose of Wybalena would be best fulfilled by giving the money to the Y.W.C.A. for its proposed new hostel. The following are the reasons for this decision:-

1. Wybalena was established as an ^{inter-church} ecumenical venture and conducted without emphasis on any one denomination. The Y.W.C.A. is an ecumenical movement with its purpose "To unite women and girls through faith in Jesus Christ in a world wide fellowship; to develop responsible Christian citizens with a concern for all people." Any hostel under its control would appear to satisfy the ecumenical requirement.

We recognise that students of all denominations would be accepted at Dunmore Lang, and the board would doubtless be broadened to include other than Presbyterians, but with the name Dunmore Lang Presbyterian Women's College it will inevitably be associated, at least in the popular mind, with the Presbyterian Church. The secretary has told us that no special plans have been made to encourage the ecumenical ideal.

2. University students always comprised a small proportion of the girls at Wybalena, most of whom were studying at Teacher's College, Technical College, Conservatorium, etc. Many came from homes which would have been unable to afford the expense of a university course. While Commonwealth Scholarships have eased the way of many university students there has been little help for the many students who have had to come from the country to study at technical colleges or to gain training by working as apprentices. "Young girls studying radiography, art, music, dressmaking, hairdressing, etc. (without the aid of a scholarship in many cases) are most in need of assistance at the present time. There is little government assistance for these girls and apprenticeship students receive so little remuneration" Such students would probably be nearer to those originally at Wybalena, in both educational and economic status, than girls doing a full university course at a college.

The Y.W.C.A. has suggested that if we decide to assist their project a wing of their hostel could be called the Wybalena wing and could be reserved for students.

3. While the Dunmore Lang plans are all complete the plans of the Y.W.C.A. are still nebulous as the site has not yet been finalised. We do not see this as a great drawback. The money has been invested till May 1970, and could, if necessary, be reinvested. Delay would, we think, be better than making a wrong decision. The knowledge that this money would be available would doubtless enable the Y.W.C.A. to proceed more quickly with its plans.

The suggestion by the Y.W.C.A. that the Council should send representatives to the board planning the hostel should be accepted. We should like to commend the idea of "cluster Flats" apart from the obvious economies of this system it seems more in harmony with the ideas of young people today than the formal college. It is similar to the idea so successfully adopted at Walter Selle Hall at the University of Sydney.

4. Considerable emphasis has been placed on the fact that any money given to Dunmore Lang will be quadrupled by Commonwealth and State subsidies. It is gratifying that such generous assistance is available for university colleges, but sad that hostels catering for students of technical colleges, or for apprentices, receive absolutely no government assistance. Some ten or fifteen years ago the Inter-Church Council, struggling to pay off its mortgage on Wybalena, looked with envy at institutions lucky enough to have government subsidy; we did try, unsuccessfully, to obtain such help. Should we now jump on the band wagon of government subsidy, or should we, remembering our own struggles, give any help we can to the Y.W.C.A. which has no government assistance?

We recognise that Dunmore Lang, with its library and tutors, would be a more "important" and more dignified institution than the hostel- or than Wybalena ever was. We believe that many big concerns will be proud to associate themselves with an academic establishment of its calibre, and we wish the Committee success. But we feel that our help must go to girls who have fewer advantages either educational or economic; and that in every way a hostel would more faithfully reproduce the old Wybalena.

We are therefore in favour of giving all the money, with accrued interest, to the Y.W.C.A. to be devoted to building a hostel, on the conditions that a wing of the hostel be called the Wybalena wing, and be reserved for students, and that the Council be invited to send two members to the committee which will advise the directors of the Y.W.C.A. on the conduct of the project.

VIEWS EXPRESSED BY SOME MEMBERS OF THE N.S.W. W.I.C.C.
COLLATED BY MARGARET RALPH - AUGUST 1970

1. Wybalena was established as an inter-church venture and conducted without emphasis on any one denomination. The Y.W.C.A. is an inter-denominational movement with its purpose "To unite women and girls through faith in Jesus Christ in a world-wide fellowship; to develop responsible Christian citizens with a concern for all people." Any hostel under its control would appear to satisfy the ecumenical requirement.

We recognise that students of all denominations would be accepted at Dunmore Lang, and the board would doubtless be broadened to include other than Presbyterians, but with the name Dunmore Lang Presbyterian Women's College, it will inevitably be associated, at least in the popular mind, with the Presbyterian Church.

It has been stated that the College Council will not be responsible to the Presbyterian Church for the conduct of the College. With the need for "Christian oversight" in mind, many ~~W.I.C.C.~~ W.I.C.C. members would prefer to rely on the proved ability of the Y.W.C.A. in their management of their hostels, in contrast to the reputation of Colleges within other universities.

2. University students always comprised a small proportion of the girls at Wybalena, most of whom were studying at Teachers College, Technical College, Conservatorium, etc. Many came from homes which would have been unable to afford the expense of a university course. While Commonwealth Scholarships have eased the way of many university students there has been little help for the many students who have had to come from the country to study at technical colleges or to gain training by working as apprentices. Dunmore Lang, with its library and tutors is a College - not a hostel as Wybalena was. It will be the type of institution that many big concerns would be proud to associate themselves with - they would probably get tax concessions on donations given.

4. It would seem that Tremayne does all that Wybalena set out to do, only better. It is in a more central position, it was built for the purpose with mainly single rooms (in some cases there were three in a room at Wybalena), it is large enough to be viable, with sufficient staff to provide supervision at all times, a large waiting list ensures that there are no costly vacancies, rooms are readily let during holiday periods.

Report on "Wybalena" for Meeting, 26th March 1971

The current position with regard to "Wybalena" monies is as follows:

The major portion of \$28,000 is invested and will fall due on 20th May 1971. An amount of \$6,429.49 is with a permanent building society, \$2113.27 on a fixed deposit with the Bank of N.S.W. and this falls due on 24th January 1972 and \$191.96 is in the current account - a grand total of \$36,734.72.

The Equity Court is to decide whether or not the Council has power to dispose of the money according to its wishes. The case will be heard before Mr. Justice Helsham on Wednesday, 26th May 1971 at 10 a.m.



" It follows, in my view, there was no exercise of the power of sale by the Trustees under Clause 18 of the Trust Deed, and that the trustees never had and do not now have power to dispose of the proceeds of sale according to any decision which might be made.

The next problem arises because there is no power now remaining to dispose of the proceeds of sale. The power to do so could have been exercised by the Council under Clause 12(b) of the constitution of the Committee, but it failed to exercise that power. It was necessary to exercise it at the meeting when the resolution was passed to dissolve the Committee, and this was not done. There is no longer anyone who has the power to do so. Should then the Court apply the proceeds of sale cy pres?

All parties, including the Attorney General, agree that the Court should do so if the situation is reached to which I have just alluded. It is agreed that the purpose for which the funds now represented by the proceeds of sale were applied was a charitable purpose, and those proceeds are impressed with a charitable trust. I agree that they should be applied cy pres.

All parties, including the attorney General, are also agreed that in such event I should make a decision as to how the proceeds should so be applied by making a choice between the Dunmore Lang College on the one hand and Tremayne on the other. This is a sensible course, designed to save expense and delay. I think it is a proper one.

The choice leaves me in no doubt that the funds should be applied to Tremayne. There are a number of reasons for this. The original concept from which the trust arose was to provide a home for girls coming to the city from the country, to provide badly needed accommodation. Secondly it was to provide a hostel for students or business girls needing such accommodation or, as it was put in the Trust Deed, students and/or business girls. Thirdly it was to be a "hostel" and known as a hostel.

Now it seems to me that Tremayne reflects almost exactly each of these three concepts, whereas a university women's college does not. I have never heard a university intra-mural college described as a hostel, and yet the word "hostel" is a well known word used to describe in our community places where people, usually young people, find community residential accommodation, precisely the sort of thing which aptly describes Tremayne. A university residential college has no residents associated with the business community, whether as students or otherwise. The trust envisaged that girls having such association should be catered for, and they were catered for. Tremayne does precisely this. It is true that the emphasis, as far as the administration of Wybalena Hostel was concerned, was upon student girls not associated with business, and no doubt I am permitted to take this into consideration in deciding how the funds should be applied. The reason seems to have been an empirical one, stemming from difficulties of mixing pure students, if I may call them such, with girls doing business courses. But the trust was intended to extend to assist girls associated with business, and Tremayne apparently experiences no such difficulty. Upon the figures before me it too seems to place the emphasis upon student girls; and finally the evidence is that Tremayne retains some of the attributes of a home, which I believe was near to the core of the intention of the founders of Wybalena. I think this differs from the educational environment and atmosphere of a women's college.

If, by applying the funds cy pres I am to apply them as nearly as I can for purposes in conformity with the trust with which they are impressed, I have no doubt they should be applied to Tremayne. There is nothing to suggest that this is in any way less beneficial to the community because that institution is not in the fortunate position of being able to secure Govt. grants for its assistance.

It is agreed that the purpose of running a hostel such as Tremayne is a purpose beneficial to the community, and hence a valid charity. The proceeds of sale of Wybalena now held by the trustees of the trust set up under the Deed of 28th August 1951 should be applied for the purposes of Tremayne.

In my view in this case it is proper that costs of all parties of all parts of the argument and proceedings should be allowed on taxation, and no objection is raised by any party to this course. I also... certify for senior counsel

The Ce Pre Clause, it was commonly agreed should apply, that is to say, the project which most nearly came within the terms of the original resolution which formed Wybalena Hostel.

There were two projects to be considered. The Presbyterian Women's College named Dunmore Lang, within the University of Macquarie, catering for university students with its schools of residence and tutorial advantages; and the Y.W.C.A. 'Tremayne' Hostel for students and business girls at Kirribilli. His Honour gave the present figures of girls in residence there, of whom some 56 were students at teachers colleges, conseratorium, business college, etc., plus at least 12 university students and about 11 girls between the ages of 18 and 22 who were country girls living and working in the city on limited incomes. He therefore ruled that there could be no other decision than to direct the monies, less court costs, be paid over to the Y.W.C.A. 'Tremayne' project. Both Mr. Kearney (for Mrs Millar and Mr. Hunt) and the barrister for the Attorney General agreed with Mr. Henderson, Q.C. and Mr. Gyles (for Mrs. Palmer, Mr. Day and myself representing this Council) that the Judge's summing up was one of the most masterly pieces of Equity findings they had experienced.

When the Equity Court adjusts the costs, the monies will be paid to the Y.W.C.A. which is expected to be within the next two or three weeks.



The Presbyterian Women's College named Dunmore Lang, within the University of Macquarie, catering for university students with its schools of residence and tutorial advantages; and the Y.W.C.A. "Trenayne" Hostel for students and business girls at Kirribilli. His Honour gave the present figures of girls in residence there, of whom some fifty six were students at teachers colleges, conservatorium, business college, etc., plus at least twelve university students and about eleven girls between the ages of 16 and 22 years, who were country girls living and working in the city on limited incomes. He therefore ruled that there could be no other decision than to direct the monies, less court costs, be paid over to the Y.W.C.A. "Trenayne" project. Both Mr. Kearney (for Mrs. Millar and Mr. Hunt); and the barrister for the Attorney General agreed with Mr. Henderson, Q.C. and Mr. Gyles (for Mrs. Palmer, Mr. Day and myself) - representing this Council - that the Judge's summing up was one of the most masterly pieces of Equity findings they had experienced.

When the Equity Court adjusts the costs, the monies will be paid to the Y.W.C.A. which is expected to be within the next two or three weeks.


